SUBSTITUTE FOR HOUSE BILL NO. 5955

A bill to amend 1917 PA 273, entitled

"An act to regulate and license pawnbrokers in certain governmental units of this state; and to prescribe certain powers and duties of certain local governmental units and state agencies,"

by amending sections 1 and 3 (MCL 446.201 and 446.203), section 1 as amended by 2004 PA 585 and section 3 as amended by 2002 PA 469.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. (1) A person, corporation, or firm shall not conduct
- 2 business as a pawnbroker in any of the governmental units of this
- 3 state without having first obtained from the chief executive
- 4 officer of that governmental unit a license under this act that
- 5 authorizes that person, corporation, or firm to conduct that
- 6 business. THIS SUBSECTION DOES NOT REQUIRE AN INTERNET DROP-OFF
- 7 STORE COMPLYING WITH SUBSECTION (3), OR A PERSON ENGAGED IN THE
- 8 SALE, PURCHASE, CONSIGNMENT, OR TRADE OF PERSONAL PROPERTY OR OTHER

- 1 VALUABLE THING FOR HIMSELF OR HERSELF, TO OBTAIN A LICENSE UNDER
- 2 THIS ACT.
- 3 (2) Licensure under either or both of the following acts does
- 4 not exempt a person from obtaining a license under this act:
- 5 (a) The precious metal and gem dealer act, 1981 PA 95, MCL
- 6 445.481 to 445.492.
- 7 (b) 1917 PA 350, MCL 445.401 to 445.408.
- 8 (3) AN INTERNET DROP-OFF STORE IN COMPLIANCE WITH THE
- 9 FOLLOWING CONDITIONS IS EXEMPT FROM LICENSURE AS A PAWNBROKER UNDER
- 10 THIS ACT:
- 11 (A) HAS A FIXED PLACE OF BUSINESS WITHIN THIS STATE EXCEPT
- 12 THAT HE OR SHE EXCLUSIVELY TRANSACTS ALL PURCHASES OR SALES BY
- 13 MEANS OF THE INTERNET AND THE PURCHASES AND SALES ARE NOT
- 14 PHYSICALLY TRANSACTED ON THE PREMISES OF THAT FIXED PLACE OF
- 15 BUSINESS.
- 16 (B) HAS THE PERSONAL PROPERTY OR OTHER VALUABLE THING
- 17 AVAILABLE ON A WEBSITE FOR VIEWING BY PHOTOGRAPH, IF AVAILABLE, BY
- 18 THE GENERAL PUBLIC AT NO CHARGE, WHICH WEBSITE SHALL BE SEARCHABLE
- 19 BY ZIP CODE OR STATE, OR BOTH. THE WEBSITE VIEWING SHALL INCLUDE,
- 20 AS APPLICABLE, SERIAL NUMBER, MAKE, MODEL, AND OTHER UNIQUE
- 21 IDENTIFYING MARKS, NUMBERS, NAMES, OR LETTERS APPEARING ON THE
- 22 PERSONAL PROPERTY OR OTHER VALUABLE THING.
- 23 (C) MAINTAINS RECORDS OF THE SALE, PURCHASE, CONSIGNMENT, OR
- 24 TRADE OF THE PERSONAL PROPERTY OR OTHER VALUABLE THING FOR AT LEAST
- 25 2 YEARS, WHICH RECORDS SHALL CONTAIN A DESCRIPTION, INCLUDING A
- 26 PHOTOGRAPH, IF AVAILABLE, AND, IF APPLICABLE, SERIAL NUMBER, MAKE,
- 27 MODEL, AND OTHER UNIQUE IDENTIFYING MARKS, NUMBERS, NAMES, OR

- 1 LETTERS APPEARING ON THE PERSONAL PROPERTY OR OTHER VALUABLE THING.
- 2 (D) PROVIDE THE LOCAL POLICE AGENCY WITH ANY NAME UNDER WHICH
- 3 IT CONDUCTS BUSINESS ON THE WEBSITE, ACCESS TO THE BUSINESS
- 4 PREMISES AT ANY TIME DURING NORMAL BUSINESS HOURS FOR PURPOSES OF
- 5 INSPECTION, AND, WITHIN 24 HOURS AFTER ENTERING INTO THE CONTRACT
- 6 FOR THE SALE, PURCHASE, CONSIGNMENT, OR TRADE OF THE PERSONAL
- 7 PROPERTY OR OTHER VALUABLE THING, AN ELECTRONIC COPY OF THE
- 8 SELLER'S OR CONSIGNOR'S NAME, ADDRESS, TELEPHONE NUMBER, DRIVER
- 9 LICENSE NUMBER AND ISSUING STATE, AND DESCRIPTION OF THE PERSONAL
- 10 PROPERTY OR OTHER VALUABLE THING AS DESCRIBED IN SUBDIVISION (C).
- 11 THE PROVISION OF INFORMATION SHALL BE IN A FORMAT ACCEPTABLE TO THE
- 12 LOCAL POLICE AGENCY BUT SHALL AT LEAST BE IN A LEGIBLE FORMAT AND
- 13 IN THE ENGLISH LANGUAGE.
- 14 (E) PROVIDE THAT PAYMENT FOR THE PERSONAL PROPERTY OR OTHER
- 15 VALUABLE THING IS EXECUTED BY MEANS OF CHECK OR OTHER ELECTRONIC
- 16 PAYMENT SYSTEM, SO LONG AS THE PAYMENT IS NOT MADE IN CASH.
- 17 (F) IMMEDIATELY REMOVE THE PERSONAL PROPERTY OR OTHER VALUABLE
- 18 THING FROM THE WEBSITE AND NOTIFY THE LOCAL POLICE AGENCY UPON
- 19 LEARNING IF THE VERIFICATION REVEALS THAT THE PERSONAL PROPERTY OR
- 20 OTHER VALUABLE THING IS STOLEN.
- Sec. 3. As used in this act:
- 22 (a) "Chief executive officer" means any of the following:
- (i) For a city, the mayor.
- (ii) For a village, the village president.
- 25 (iii) For a township or charter township, the township
- 26 supervisor.
- 27 (iv) For a county, the county executive or, if there is no

- 1 county executive, the person designated by a resolution of the
- 2 county board of commissioners.
- 3 (b) "Governmental unit" means a city, township, charter
- 4 township, county, or incorporated village.
- 5 (C) "INTERNET DROP-OFF STORE" MEANS A PERSON, CORPORATION, OR
- 6 FIRM THAT CONTRACTS WITH OTHER PERSONS, CORPORATIONS, OR FIRMS TO
- 7 OFFER ITS PERSONAL PROPERTY OR OTHER VALUABLE THING FOR SALE,
- 8 PURCHASE, CONSIGNMENT, OR TRADE THROUGH MEANS OF AN INTERNET
- 9 WEBSITE AND MEETS THE CONDITIONS DESCRIBED IN SECTION 1(3).
- 10 (D) "LOCAL POLICE AGENCY" MEANS THE POLICE AGENCY OF THE CITY,
- 11 VILLAGE, OR TOWNSHIP, OR IF NONE, THE COUNTY SHERIFF OF THE COUNTY
- 12 IN WHICH THE INTERNET DROP-OFF STORE CONDUCTS BUSINESS.
- (E) (c) "Pawnbroker" means a person, corporation, or member,
- 14 or members of a copartnership or firm, who loans money on deposit,
- 15 or pledge of personal property, or other valuable thing, other than
- 16 securities or printed evidence of indebtedness, or who deals in the
- 17 purchasing of personal property or other valuable thing on
- 18 condition of selling the same back again at a stipulated price.
