## SUBSTITUTE FOR HOUSE BILL NO. 5960

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 78101 (MCL 324.78101), as amended by 2004 PA 587, and by adding section 78117.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 78101. As used in this part:
- 2 (a) "Commission" means the Michigan state waterways
- 3 commission.
- 4 (b) "Department" means the department of natural resources.
- 5 (c) "Director" means the administrative director of the
- 6 commission.
- 7 (d) "Diesel motor fuel" means any liquid fuel used in the
- 8 operation of engines of the diesel type in motor vehicles or

- 1 watercraft.
- 2 (e) "Gasoline" means gasoline, casing head or natural
- 3 gasoline, benzole, benzine, and naphtha; also, any liquid prepared,
- 4 advertised, offered for sale, sold for use as, or used for, the
- 5 generation of power for the propulsion of motor vehicles or
- 6 watercraft, including any product obtained by blending together any
- 7 1 or more products of petroleum, with or without other products,
- 8 and regardless of the original character of the petroleum products
- 9 blended, if the resultant product obtained is capable of use for
- 10 the generation of power for the propulsion of motor vehicles or
- 11 watercraft, it being the intention that the blending of the
- 12 products, regardless of name or characteristics, shall conclusively
- 13 be presumed to produce motor fuel, unless the resultant product is
- 14 entirely incapable for use as motor fuel. Gasoline does not include
- 15 diesel fuel, liquefied petroleum gas, or commercial or industrial
- 16 naphthas or solvents manufactured, imported, received, stored,
- 17 distributed, sold, or used exclusively for purposes other than as a
- 18 fuel for motor vehicles or watercraft.
- 19 (f) "Harbor" means a portion of a lake or other body of water
- 20 either naturally or artificially protected so as to be a place of
- 21 safety for watercraft, including contrivances used or designed for
- 22 navigation on water and used or owned by the United States.
- 23 (g) "Harbor facilities" means the structures at a harbor
- 24 constructed to protect the lake or body of water and the facilities
- 25 provided within the harbor and ashore for the mooring and servicing
- 26 of watercraft and the servicing of crews and passengers.
- 27 (H) "INLAND LAKE OR STREAM" MEANS THAT TERM AS DEFINED IN

- 2 (I) —(h)— "Liquefied petroleum gas" means gases derived from
- 3 petroleum or natural gases -which THAT are in the gaseous state at
- 4 normal atmospheric temperature and pressure, but -which- THAT may
- 5 be maintained in the liquid state at normal atmospheric temperature
- 6 by suitable pressure.
- 7 (J) —(i) "Marina" means a site —which THAT contains harbor
- 8 facilities.
- 9 (K) -(j) "Navigable water" means any waterway navigable by
- 10 vessels, or capable of being made navigable by vessels through
- 11 artificial improvements, and includes the structures and facilities
- 12 created to facilitate navigation.
- 13 (l)  $\frac{(k)}{(k)}$  "Person" includes any individual, partnership,
- 14 corporation, association, or body politic, except the United States
- 15 and this state, and includes any trustee, receiver, assignee, or
- 16 other similar representative of those entities.
- 17 (M) -(l)— "Public boating access site" means a publicly owned
- 18 site for the launching of recreational watercraft.
- 19 (N) (m) "Retail fuel dealer" includes any person or persons,
- 20 both private and municipal, who engage in the business of selling
- 21 or distributing fuel within the THIS state.
- 22 (O)  $\frac{(n)}{(n)}$  "Secretary of state" means the secretary of state of
- 23 this state, acting directly or through a duly authorized deputy,
- 24 investigators, agents, and employees.
- 25 (P) (o) "Vessel" means all watercraft except the following:
- 26 (i) Watercraft used for commercial fishing.
- (ii) Watercraft used by the sea scout department of the boy

- 1 scouts of America chiefly for training scouts in seamanship.
- 2 (iii) Watercraft owned by this state, any political subdivision
- 3 of this state, or the federal government.
- 4 (iv) Watercraft when used in interstate or foreign commerce and
- 5 watercraft used or owned by any railroad company or railroad car
- 6 ferry company.
- 7 (v) Watercraft when used in trade, including watercraft when
- 8 used in connection with an activity that constitutes a person's
- 9 chief business or means of livelihood.
- 10 (Q) -(p) "Watercraft" means any contrivance used or designed
- 11 for navigation on water, including, but not limited to, any vessel,
- 12 ship, boat, motor vessel, steam vessel, vessel operated by
- 13 machinery, motorboat, sailboat, barge, scow, tugboat, and rowboat,
- 14 but does not include contrivances used or owned by the United
- 15 States.
- 16 (R) -(q) "Waterway" means any body of water.
- 17 (S)  $\frac{(r)}{(r)}$  "Waterways account" means the waterways account of
- 18 the Michigan conservation and recreation legacy fund provided for
- 19 in section 2035. THIS SUBDIVISION DOES NOT APPLY UNLESS 2004 PA 587
- 20 TAKES EFFECT, AS A RESULT OF JOINT RESOLUTION Z OF THE 92ND
- 21 LEGISLATURE BECOMING A PART OF THE STATE CONSTITUTION OF 1963 AS
- 22 PROVIDED IN SECTION 1 OF ARTICLE XII OF THE STATE CONSTITUTION OF
- 23 1963.
- 24 SEC. 78117. A TOWNSHIP MAY BY ORDINANCE REGULATE ACTIVITIES AT
- 25 A PUBLIC BOATING ACCESS SITE OWNED BY THE DEPARTMENT AND LOCATED ON
