THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 5. (1) "Domestic dependent sovereign" means an Indian
- 2 tribe that has been acknowledged, recognized, restored, or
- 3 reaffirmed as an Indian tribe by the secretary of the interior
- 4 pursuant to chapter 576, 48 Stat. 984, 25 U.S.C. UNDER THE INDIAN
- 5 REORGANIZATION ACT, 25 USC 461 to 463, 464 to 465, 466 to 470, 471

- 1 to 472, 473, 474 to 475, 476 to 478, and 479, commonly referred to
- 2 as the Indian reorganization act, or has otherwise been
- 3 acknowledged by the United States government as an Indian tribe.
- 4 (2) "Election" means a primary, general, special, or millage
- 5 election held in this state or a convention or caucus of a
- 6 political party held in this state to nominate a candidate.
- 7 Election includes a recall vote.
- 8 (3) "Election cycle" means 1 of the following:
- **9** (a) For a general election, the period beginning the day
- 10 following the last general election in which the office appeared on
- 11 the ballot and ending on the day of the general election in which
- 12 the office next appears on the ballot.
- (b) For a special election, the period beginning the day a
- 14 special general election is called or the date the office becomes
- 15 vacant, whichever is earlier, and ending on the day of the special
- 16 general election.
- 17 (4) "ELECTIONEERING COMMUNICATION" MEANS, SUBJECT TO
- 18 SUBSECTION (5), A BROADCAST, CABLE, OR SATELLITE COMMUNICATION TO
- 19 WHICH ALL OF THE FOLLOWING APPLY:
- 20 (A) THE COMMUNICATION REFERS TO A CLEARLY IDENTIFIED
- 21 CANDIDATE.
- 22 (B) THE COMMUNICATION IS MADE WITHIN 30 DAYS BEFORE A PRIMARY
- 23 ELECTION OR A CONVENTION OR CAUCUS OF A POLITICAL PARTY THAT HAS
- 24 AUTHORITY TO NOMINATE A CANDIDATE OR WITHIN 60 DAYS BEFORE A
- 25 GENERAL ELECTION.
- 26 (5) ELECTIONEERING COMMUNICATION DOES NOT INCLUDE THE
- 27 FOLLOWING:

- 1 (A) A COMMUNICATION IN A NEWS STORY, COMMENTARY, OR EDITORIAL
- 2 DISTRIBUTED THROUGH THE FACILITIES OF A BROADCASTING STATION,
- 3 UNLESS THE FACILITIES ARE OWNED OR CONTROLLED BY A CANDIDATE OR A
- 4 COMMITTEE, OTHER THAN AN INDEPENDENT COMMITTEE OR A BALLOT QUESTION
- 5 COMMITTEE.
- 6 (B) A COMMUNICATION THAT IS AN EXPENDITURE OR AN INDEPENDENT
- 7 EXPENDITURE.
- 8 (C) A COMMUNICATION IN A CANDIDATE DEBATE OR FORUM CONDUCTED
- 9 PURSUANT TO RULES ADOPTED BY THE SECRETARY OF STATE OR THAT SOLELY
- 10 PROMOTES SUCH A DEBATE OR FORUM AND IS MADE BY OR ON BEHALF OF THE
- 11 PERSON SPONSORING THE DEBATE OR FORUM.
- 12 (6) "ELECTIONEERING COMMUNICATION ORGANIZATION" MEANS A PERSON
- 13 THAT PAYS OR BECOMES OBLIGATED TO PAY FOR 1 OR MORE ELECTIONEERING
- 14 COMMUNICATIONS, IF THE PAYMENTS MADE OR TO BE MADE AGGREGATE MORE
- 15 THAN \$1,000.00 IN AN ELECTION CYCLE.
- 16 (7) -(4) "Elective office" means a public office filled by an
- 17 election. A person who is appointed to fill a vacancy in a public
- 18 office that is ordinarily elective holds an elective office.
- 19 Elective office does not include the office of precinct delegate.
- 20 Except for the purposes of sections 47, 54, and 55, elective office
- 21 does not include a school board member in a school district that
- 22 has a pupil membership of 2,400 or less enrolled on the most recent
- 23 pupil membership count day. However, elective office includes a
- 24 school board member in a school district that has a pupil
- 25 membership of 2,400 or less if a candidate committee of a
- 26 candidate for the office of school board member in that school
- 27 district receives an amount in excess of \$1,000.00 or expends an

- 1 amount in excess of \$1,000.00. Elective office does not include a
- 2 federal office except for the purposes of section 57.
- 3 Sec. 6. (1) "Expenditure" means a payment, donation, loan, or
- 4 promise of payment of money or anything of ascertainable monetary
- 5 value for goods, materials, services, or facilities in assistance
- 6 of, or in opposition to, the nomination or election of a candidate,
- 7 or the qualification, passage, or defeat of a ballot question.
- 8 Expenditure includes, but is not limited to, any of the following:
- **9** (a) A contribution or a transfer of anything of ascertainable
- 10 monetary value for purposes of influencing the nomination or
- 11 election of a candidate or the qualification, passage, or defeat of
- 12 a ballot question.
- (b) Except as provided in subsection $\frac{(2)(f) \text{ or } (g)}{(g)}$ (2)(E) OR
- 14 (F), an expenditure for voter registration or get-out-the-vote
- 15 activities made by a person who sponsors or finances the activity
- 16 or who is identified by name with the activity.
- 17 (c) Except as provided in subsection -(2)(f) or (g) (2)(E) OR
- 18 (F), an expenditure made for poll watchers, challengers,
- 19 distribution of election day literature, canvassing of voters to
- 20 get out the vote, or transporting voters to the polls.
- 21 (2) Expenditure does not include any of the following:
- 22 (a) An expenditure for communication by a person with the
- 23 person's paid members or shareholders and those individuals who can
- 24 be solicited for contributions to a separate segregated fund under
- **25** section 55.
- (b) An expenditure for communication on a subject or issue if
- 27 the communication does not support or oppose a ballot question or

- 1 candidate by name or clear inference.
- 2 (B) —(e)— An expenditure for the establishment,
- 3 administration, or solicitation of contributions to a separate
- 4 segregated fund or independent committee.
- 5 (C) $\frac{-(d)}{}$ An expenditure by a broadcasting station, newspaper,

- 6 magazine, or other periodical or publication for a news story,
- 7 commentary, or editorial in support of or opposition to a candidate
- 8 for elective office or a ballot question in the regular course of
- 9 publication or broadcasting.
- 10 (D) $\frac{(e)}{(e)}$ An offer or tender of an expenditure if expressly
- 11 and unconditionally rejected or returned.
- 12 (E) -(f) An expenditure for nonpartisan voter registration or
- 13 nonpartisan get-out-the-vote activities made by an organization
- 14 that is exempt from federal income tax pursuant to section
- 15 501(c)(3) of the internal revenue code of 1986, 26 U.S.C. USC
- 16 501, or any successor statute.
- 17 (F) $\frac{g}{g}$ An expenditure for nonpartisan voter registration or
- 18 nonpartisan get-out-the-vote activities performed pursuant to
- 19 chapter XXIII of the Michigan election law, 1954 PA 116, MCL
- 20 168.491 to 168.524, by the secretary of state and other
- 21 registration officials who are identified by name with the
- 22 activity.
- 23 (G) -(h) An expenditure by a state central committee of a
- 24 political party or a person controlled by a state central committee
- 25 of a political party for the construction, purchase, or renovation
- 26 of 1 or more office facilities in Ingham county if the facility is
- 27 not constructed, purchased, or renovated for the purpose of

- 1 influencing the election of a candidate in a particular election.
- 2 Items excluded from the definition of expenditure under this
- 3 subdivision include expenditures approved in federal election
- 4 commission advisory opinions 1993-9, 2001-1, and 2001-12 as
- 5 allowable expenditures under the federal election campaign act of
- 6 1971, Public Law 92-225, 2 U.S.C. 431 to 434, 437, 437c to 439a,
- 7 439c, 441a to 441h, and 442 to 455, and regulations promulgated
- 8 under that act, regardless of whether those advisory opinions have
- 9 been superseded.
- 10 Sec. 11. (1) "Person" means a business, individual,
- 11 proprietorship, firm, partnership, joint venture, syndicate,
- 12 business trust, labor organization, company, corporation,
- 13 association, committee, ORGANIZATION THAT CLAIMS TAX-EXEMPT STATUS
- 14 UNDER SECTION 527 OF THE INTERNAL REVENUE CODE, 26 USC 527, or any
- 15 other organization or group of persons acting jointly.
- 16 (2) "Political committee" means a committee that is not a
- 17 candidate committee, political party committee, independent
- 18 committee, or ballot question committee.
- 19 (3) "Political merchandise" means goods such as bumper
- 20 stickers, pins, hats, beverages, literature, or other items sold by
- 21 a person at a fund raiser or to the general public for publicity or
- 22 for the purpose of raising funds to be used in supporting or
- 23 opposing a candidate for nomination for or election to an elective
- 24 office or in supporting or opposing the qualification, passage, or
- 25 defeat of a ballot question.
- 26 (4) "Political party" means a political party which— THAT has
- 27 a right under law to have the names of its candidates listed on the

- 1 ballot in a general election.
- 2 (5) "Political party committee" means a state central,
- 3 district, or county committee of a political party -which THAT is

- 4 a committee. Each state central committee shall designate the
- 5 official party county and district committees. There shall not be
- 6 more than 1 officially designated political party committee per
- 7 county and per congressional district.
- **8** (6) "Public body" means 1 or more of the following:
- 9 (a) A state agency, department, division, bureau, board,
- 10 commission, council, authority, or other body in the executive
- 11 branch of state government.
- 12 (b) The legislature or an agency, board, commission, or
- 13 council in the legislative branch of state government.
- 14 (c) A county, city, township, village, intercounty, intercity,
- 15 or regional governing body; a council, school district, special
- 16 district, or municipal corporation; or a board, department,
- 17 commission, or council or an agency of a board, department,
- 18 commission, or council.
- 19 (d) Any other body that is created by state or local authority
- 20 or is primarily funded by or through state or local authority,
- 21 which body exercises governmental or proprietary authority or
- 22 performs a governmental or proprietary function.
- 23 Sec. 24. (1) A committee shall file a statement of
- 24 organization with the filing officials designated in section 36 to
- 25 receive the committee's campaign statements. A statement of
- 26 organization shall be filed within 10 days after a committee is
- 27 formed. A filing official shall maintain a statement of

- 1 organization filed by a committee until 5 years after the official
- 2 date of the committee's dissolution. A person who fails to file a
- 3 statement of organization required by this subsection shall pay a
- 4 late filing fee of \$10.00 for each business day the statement
- 5 remains not filed in violation of this subsection. The late filing
- 6 fee shall not exceed \$300.00. A person who violates this subsection
- 7 by failing to file for more than 30 days after a statement of
- 8 organization is required to be filed is guilty of a misdemeanor

- 22 NUMBER OF THE SUCCESSOR TREASURER WHO WILL SERVE AS THE TREASURER
- 23 OR OTHER INDIVIDUAL DESIGNATED AS RESPONSIBLE FOR THE COMMITTEE'S
- 24 RECORD-KEEPING, REPORT PREPARATION, OR REPORT FILING IF THE
- 25 INDIVIDUAL NAMED UNDER SUBDIVISION (B) RESIGNS, DIES, OR IS
- 26 INCAPACITATED.
- 27 (D) -(c) The name and address of the financial institution in

- 1 which the official committee depository is or is intended to be
- 2 located, and the name and address of each financial institution in
- 3 which a secondary depository is or is intended to be located.
- 4 (E) —(d) The full name of the office being sought by,
- 5 including district number or jurisdiction, and the county residence
- 6 of each candidate supported or opposed by the committee.
- 7 **(F)** (e) A brief statement identifying the substance of each
- 8 ballot question supported or opposed by the committee. If the
- 9 ballot question supported or opposed by the committee is not
- 10 statewide, the committee shall identify the county in which the
- 11 greatest number of registered voters eligible to vote on the ballot
- 12 question reside.
- 13 (G) -(f) Identification of the committee as a candidate
- 14 committee, political party committee, independent committee,
- 15 political committee, or ballot question committee if it is
- 16 identifiable as such a committee.
- 17 (3) An independent committee or political committee shall
- 18 include in the name of the committee the name of the person or
- 19 persons that sponsor the committee, if any, or with whom the
- 20 committee is affiliated. A person, other than an individual or a
- 21 committee, sponsors or is affiliated with an independent committee
- 22 or political committee if that person establishes, directs,
- 23 controls, or financially supports the administration of the
- 24 committee. For the purposes of this subsection, a person does not
- 25 financially support the administration of a committee by merely
- 26 making a contribution to the committee.
- 27 (4) If any of the information required in a statement of

- 1 organization is changed, the committee shall file an amendment when
- 2 the next campaign statement is required to be filed. An independent
- 3 committee or political committee whose name does not include the
- 4 name of the person or persons that sponsor the committee or with
- 5 whom the committee is affiliated as required by subsection (3)
- 6 shall file an amendment to the committee's statement of
- 7 organization not later than the date the next campaign statement is
- 8 required to be filed. -after the effective date of the amendatory
- 9 act that added this sentence.
- 10 (5) When filing a statement of organization, a committee,
- 11 other than an independent committee, a political committee, or a
- 12 political party committee, may indicate in a written statement
- 13 signed by the treasurer of the committee that the committee does
- 14 not expect for each election to receive an amount in excess of
- 15 \$1,000.00 or expend an amount in excess of \$1,000.00.
- 16 (6) When filing a statement of organization, an independent
- 17 committee, a political committee, or a political party committee
- 18 may indicate in a written statement signed by the treasurer of the
- 19 committee that the committee does not expect in a calendar year to
- 20 receive or expend an amount in excess of \$1,000.00.
- 21 (7) Upon the dissolution of a committee, the committee shall
- 22 file a statement indicating dissolution with the filing officials
- 23 with whom the committee's statement of organization was filed.
- 24 Dissolution of a committee shall be accomplished pursuant to rules
- 25 promulgated by the secretary of state under the administrative
- 26 procedures act of 1969, 1969 PA 306, MCL 24.201 to 24.328.
- 27 (8) A candidate committee that files a written statement

- 1 pursuant to UNDER subsection (5) shall not be required to file a
- 2 dissolution statement -pursuant to UNDER subsection (7) if the
- 3 committee failed to receive or expend an amount in excess of
- 4 \$1,000.00 and 1 of the following applies:
- 5 (a) The candidate was defeated in an election and has no
- 6 outstanding campaign debts or assets.
- 7 (b) The candidate vacates an elective office and has no
- 8 outstanding campaign debts or assets.
- 9 Sec. 26. (1) A campaign statement of a committee, other than a
- 10 political party committee, required by this act shall contain all
- 11 of the following information:
- 12 (a) The filing committee's name, address, and telephone
- 13 number, and the full name, residential and business addresses, and
- 14 telephone numbers of the committee treasurer or other individual
- 15 designated as responsible for the committee's record keeping,
- 16 report preparation, or report filing.
- 17 (b) Under the heading "receipts", the total amount of
- 18 contributions received during the period covered by the campaign
- 19 statement; under the heading "expenditures", the total amount of
- 20 expenditures made during the period covered by the campaign
- 21 statement; and the cumulative amount of those totals. Forgiveness
- 22 of a loan shall not be included in the totals. Payment of a loan by
- 23 a third party shall be recorded and reported as an in-kind
- 24 contribution by the third party. In-kind contributions or
- 25 expenditures shall be listed at fair market value and shall be
- 26 reported as both contributions and expenditures. A contribution or
- 27 expenditure that is by other than completed and accepted payment,

1 gift, or other transfer, that is clearly not legally enforceable,

- 2 and that is expressly withdrawn or rejected and returned before a
- 3 campaign statement closing date need not be included in the
- 4 campaign statement and if included may, in a later or amended
- 5 statement, be shown as a deduction, but the committee shall keep
- 6 adequate records of each instance.
- 7 (c) The balance of cash on hand at the beginning and the end
- 8 of the period covered by the campaign statement.
- 9 (d) The following information regarding each fund-raising
- 10 event shall be included in the report:
- 11 (i) The type of event, date held, address and name, if any, of
- 12 the place where the activity was held, and approximate number of
- 13 individuals participating or in attendance.
- 14 (ii) The total amount of all contributions.
- 15 (iii) The gross receipts of the fund-raising event.
- 16 (iv) The expenditures incident to the event.
- 17 (D) -(e) The full name of each individual from whom
- 18 contributions are received during the period covered by the
- 19 campaign statement, together with the individual's street address,
- 20 the amount contributed, the date on which each contribution was
- 21 received, and the cumulative amount contributed by that individual.
- 22 The occupation, employer, and principal place of business shall be
- 23 stated if the individual's cumulative contributions are more than
- **24** \$100.00.
- **25** (E) $\frac{(f)}{(f)}$ The cumulative amount contributed and the name and
- 26 address of each individual, except those individuals reported under
- 27 subdivision -(e) (D), who contributed to the committee. The

- 1 occupation, employer, and principal place of business shall be
- 2 stated for each individual who contributed more than \$100.00.
- (F) $\frac{(g)}{(g)}$ The name and street address of each person, other
- 4 than an individual, from whom contributions are received during the
- 5 period covered by the campaign statement, together with an
- 6 itemization of the amounts contributed, the date on which each
- 7 contribution was received, and the cumulative amount contributed by
- 8 that person.
- 9 (G) -(h) The name, address, and amount given by an individual
- 10 who contributed to the total amount contributed by a person who is
- 11 other than a committee or an individual. The occupation, employer,
- 12 and principal place of business shall be stated if the individual
- 13 contributed more than \$100.00 of the total amount contributed by a
- 14 person who is other than a committee or an individual.
- 15 (H) $\frac{(i)}{(i)}$ The cumulative total of expenditures of \$50.00 or
- 16 less made during the period covered by the campaign statement
- 17 except for expenditures made to or on behalf of another committee,
- 18 candidate, or ballot question.
- 19 (I) $\frac{(j)}{(j)}$ The full name and street address of each person to
- 20 whom expenditures totaling more than \$50.00 were made, together
- 21 with the amount of each separate expenditure to each person during
- 22 the period covered by the campaign statement; the purpose of the
- 23 expenditure; the full name and street address of the person
- 24 providing the consideration for which any expenditure was made if
- 25 different from the payee; the itemization regardless of amount of
- 26 each expenditure made to or on behalf of another committee,
- 27 candidate, or ballot question; and the cumulative amount of

- 1 expenditures for or against that candidate or ballot question for
- 2 an election cycle. An expenditure made in support of more than 1
- 3 candidate or ballot question, or both, shall be apportioned
- 4 reasonably among the candidates or ballot questions, or both.
- 5 (2) A candidate committee or ballot question committee shall
- 6 report all cumulative amounts required by this section on a per
- 7 election cycle basis. Except for subsection $\frac{(1)(j)}{(1)}$ (1)(I), an
- 8 independent committee or political committee shall report all
- 9 cumulative amounts required by this section on a calendar year
- 10 basis.
- 11 (3) A campaign statement of a committee, in addition to the
- 12 other information required by this section, shall include an
- 13 itemized list of all expenditures during the reporting period for
- 14 election day busing of electors to the polls, get-out-the-vote
- 15 activities, slate cards, challengers, poll watchers, and poll
- workers.
- 17 (4) For a reporting period in which a contribution is received
- 18 that is to be part of a bundled contribution or a reporting period
- 19 in which a bundled contribution is delivered to the candidate
- 20 committee of a candidate for statewide elective office, a bundling
- 21 committee shall report to the secretary of state, on a form
- 22 provided by the secretary of state, all of the following
- 23 information, as applicable, about each contribution received or
- 24 delivered as part of a bundled contribution, and about each bundled
- 25 contribution delivered, in the reporting period:
- 26 (a) The amount of each contribution, the date it was received
- 27 by the bundling committee, and the candidate for statewide elective

- 1 office whom the contributor designated as the intended recipient.
- 2 (b) Each contributor's name and address and, for each
- 3 contribution exceeding \$100.00, the contributor's occupation,
- 4 employer, and principal place of business.
- 5 (c) The date each contribution is delivered to the candidate's
- 6 statewide elective office candidate committee.
- 7 (d) The total amount of bundled contributions delivered to
- 8 that candidate committee during the reporting period and during the
- 9 election cycle.
- 10 (5) With its delivery of a bundled contribution to the
- 11 candidate committee of a candidate for statewide elective office, a
- 12 bundling committee shall deliver a report to that candidate
- 13 committee, on a form provided by the secretary of state, that
- 14 includes all of the following information, as applicable, about
- 15 each contribution delivered as part of the bundled contribution,
- 16 and about all bundled contributions delivered to that candidate
- 17 committee in the election cycle:
- 18 (a) The amount of each contribution, the date it was received
- 19 by the bundling committee, and the statewide elective office
- 20 candidate the contributor designated as the intended recipient.
- 21 (b) Each contributor's name and address and, for each
- 22 contribution exceeding \$100.00, the contributor's occupation,
- 23 employer, and principal place of business.
- 24 (c) The total amount of bundled contributions delivered to
- 25 that candidate committee during the reporting period and during the
- 26 election cycle.
- 27 (6) For a reporting period in which a bundled contribution is

- 1 received, a candidate committee of a candidate for statewide
- 2 elective office shall report to the secretary of state, on a form
- 3 provided by the secretary of state, all of the following
- 4 information, as applicable, about each contribution delivered as
- 5 part of a bundled contribution received in the reporting period and
- 6 about all bundled contributions received by that candidate
- 7 committee:
- 8 (a) The amount of each contribution, the date it was received
- 9 by the candidate committee, and the name of the bundling committee
- 10 that delivered the contribution.
- 11 (b) Each contributor's name and address and, for each
- 12 contribution exceeding \$100.00, the contributor's occupation,
- 13 employer, and principal place of business.
- 14 (c) The total amount of bundled contributions received by that
- 15 candidate committee during the reporting period and during the
- 16 election cycle.
- 17 Sec. 29. (1) A campaign statement filed by a political party
- 18 committee shall contain all of the following information:
- 19 (a) The full name and street address of each person from whom
- 20 contributions are received in a calendar year, the amount, and the
- 21 date or dates contributed; and, if the person is a committee, the
- 22 name and address of the committee and the full name of the
- 23 committee treasurer, together with the amount of the contribution
- 24 and the date received. The occupation, employer, and principal
- 25 place of business, if any, shall be listed for each person from
- 26 whom contributions totaling more than \$100.00 are received in a
- 27 calendar year.

- 1 (b) Accompanying a campaign statement reporting the receipt of
- 2 a contribution from a committee or person whose treasurer does not
- 3 reside in, whose principal office is not located in, or whose funds
- 4 are not kept in this state, and whose committee has not filed a
- 5 statement of organization as required in section 24, shall be a
- 6 statement setting forth the full name and address of the treasurer
- 7 of the committee.
- 8 (c) An itemized list of all expenditures, including in-kind
- 9 contributions and expenditures and loans, made during the period
- 10 covered by the campaign statement that were contributions to a
- 11 candidate committee of a candidate for elective office or a ballot
- 12 question committee; or independent expenditures in support of the
- 13 qualification, passage, or defeat of a ballot question or in
- 14 support of the nomination or election of a candidate for elective
- 15 office or the defeat of any of the candidate's opponents.
- 16 (d) The total expenditure by the committee for each candidate
- 17 for elective office or ballot question in whose behalf an
- 18 independent expenditure was made or a contribution was given for
