SUBSTITUTE FOR HOUSE BILL NO. 6162

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding section 30306b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 30306B. (1) IF REQUESTED BY THE LANDOWNER OR ANOTHER
- 2 PERSON IN WRITING, THE DEPARTMENT SHALL MEET WITH THE PERSON OR HIS
- 3 OR HER REPRESENTATIVES TO REVIEW A PROPOSED PROJECT OR A PERMIT
- 4 APPLICATION IN ITS ENTIRETY. THE MEETING SHALL TAKE PLACE AT THE
- 5 DEPARTMENT'S DISTRICT OFFICE FOR THE DISTRICT THAT INCLUDES THE
- 6 PROJECT SITE OR, IF AUTHORIZED BY THE LANDOWNER, AT THE PROJECT
- 7 SITE ITSELF, AS SPECIFIED IN THE REQUEST.
- 8 (2) EXCEPT AS PROVIDED IN THIS SUBSECTION, THE REQUEST SHALL
- 9 BE ACCOMPANIED BY A FEE. THE FEE FOR A MEETING AT THE DISTRICT

- 1 OFFICE IS \$150.00. THE FEE FOR A MEETING AT THE PROJECT SITE IS
- 2 \$250.00 FOR THE FIRST ACRE OR PORTION OF AN ACRE OF PROJECT AREA,
- 3 PLUS \$50.00 FOR EACH ACRE OR PORTION OF AN ACRE IN EXCESS OF THE
- 4 FIRST ACRE, BUT NOT TO EXCEED A FEE OF \$1,000.00. HOWEVER, IF THE
- 5 LOCATION OF THE PROJECT IS A SINGLE FAMILY RESIDENTIAL LOT THAT IS
- 6 LESS THAN 1 ACRE IN SIZE, THERE IS NO FEE FOR A MEETING AT THE
- 7 DISTRICT OFFICE, AND THE FEE FOR A MEETING AT THE PROJECT SITE IS
- \$100.00. 8
- 9 (3) IF THE PERSON WITHDRAWS THE REQUEST AT LEAST 24 HOURS
- 10 BEFORE THE MEETING, THE DEPARTMENT MAY AGREE WITH THE PERSON TO
- 11 RESCHEDULE THE MEETING OR SHALL PROMPTLY REFUND THE FEE AND NEED
- 12 NOT MEET AS PROVIDED IN THIS SECTION. OTHERWISE, IF, AFTER AGREEING
- 13 TO THE TIME AND PLACE FOR A MEETING, THE PERSON IS NOT REPRESENTED
- 14 AT THE MEETING, THE PERSON SHALL FORFEIT THE FEE FOR THE MEETING.
- 15 IF, AFTER AGREEING TO THE TIME AND PLACE FOR A MEETING, THE
- 16 DEPARTMENT IS NOT REPRESENTED AT THE MEETING, THE DEPARTMENT SHALL
- 17 REFUND THE FEE AND SEND A REPRESENTATIVE TO A RESCHEDULED MEETING
- 18 TO BE HELD WITHIN 10 DAYS OF THE FIRST SCHEDULED MEETING DATE.
- 19 (4) ANY WRITTEN AGREEMENT REACHED AT THE MEETING IS BINDING ON
- 20 THE DEPARTMENT.
