- 6 NOT EMPLOY THE INDIVIDUAL IN ANY CAPACITY AND SHALL NOT ALLOW THE
- 7 INDIVIDUAL TO REGULARLY AND CONTINUOUSLY WORK UNDER CONTRACT IN ANY
- 8 OF ITS SCHOOLS.
- 9 (5) A school district, intermediate school district, public
- 10 school academy, or nonpublic school shall make a request to the
- 11 department of state police for the criminal history check and
- 12 criminal records check under this section on a form and in a manner
- 13 prescribed by the department of state police.
- 14 (6) The results of a criminal history check and criminal
- 15 records check under this section shall be used by a school
- 16 district, intermediate school district, public school academy, or
- 17 nonpublic school only for the purpose of evaluating an individual's
- 18 qualifications for employment or assignment in his or her position
- 19 and for the purposes of subsections (2) and (3). A member of the
- 20 board of a school district or intermediate school district, of the
- 21 board of directors of a public school academy, or of the governing
- 22 body of a nonpublic school or an employee of a district, public
- 23 school academy, or nonpublic school shall not disclose those
- 24 results, except a misdemeanor conviction involving sexual or
- 25 physical abuse or any felony conviction, to any person who is not

- 9 EMPLOYER. A REPRESENTATIVE OF A DISTRICT, PUBLIC SCHOOL ACADEMY,
- 10 NONPUBLIC SCHOOL, OR OF ANY OTHER EMPLOYER WHO RECEIVES A COPY OF A
- 11 REPORT OR RECEIVES RESULTS OF A REPORT FROM ANOTHER SOURCE AS
- 12 AUTHORIZED UNDER THIS SUBSECTION SHALL NOT DISCLOSE THE REPORT OR
- 13 ITS CONTENTS OR THE RESULTS OF A THE REPORT TO ANY PERSON WHO IS
- 14 NOT DIRECTLY INVOLVED IN EVALUATING THE INDIVIDUAL'S OR APPLICANT'S
- 15 QUALIFICATIONS FOR EMPLOYMENT OR ASSIGNMENT. A person who violates
- 16 this subsection is guilty of a misdemeanor punishable by a fine of
- 17 not more than \$10,000.00, but is not subject to the penalties under
- **18** section 1804.
- 19 (7) Within 30 days after receiving a proper request by a
- 20 school district, intermediate school district, public school
- 21 academy, or nonpublic school for a criminal history check and
- 22 criminal records check on an individual under this section, the
- 23 criminal records division of the department of state police shall
- 24 do both of the following:
- 25 (a) Conduct the criminal history check and, after conducting
- 26 the criminal history check and within that time period, provide a
- 27 report of the results of the criminal history check to the

- 1 district, public school academy, or nonpublic school. The report
- 2 shall contain any criminal history record information on the
- 3 individual that is maintained by the criminal records division of
- 4 the department of state police.

- 1 shall not allow the individual to regularly and continuously work
- 2 under contract in any of its schools. If the results received by a
- 3 school district, intermediate school district, public school
- 4 academy, or nonpublic school under subsection (7), OR A REPORT
- 5 RECEIVED UNDER SECTION 1230A, 1230D(7), 1535A(15), OR 1539B(15),
- 6 disclose that an individual has been convicted of a felony other

- 19 DESCRIBED IN THIS SUBSECTION, WITHIN 30 DAYS AFTER RECEIVING THOSE

- 21 SCHOOL ACADEMY, OR NONPUBLIC SCHOOL SHALL SUBMIT TO THE DEPARTMENT
- 22 IN THE FORM AND MANNER PRESCRIBED BY THE DEPARTMENT A REPORT
- 23 DETAILING THE INFORMATION RECEIVED AND ANY ACTION TAKEN AS A RESULT
- 24 BY THE SCHOOL DISTRICT, INTERMEDIATE SCHOOL DISTRICT, PUBLIC SCHOOL
- 25 ACADEMY, OR NONPUBLIC SCHOOL.
- 26 (9) IF THE CRIMINAL HISTORY CHECK AND CRIMINAL RECORDS CHECK
- 27 REQUIRED UNDER THIS SECTION HAVE BEEN COMPLETED FOR A PARTICULAR

- 1 INDIVIDUAL AND THE RESULTS REPORTED TO A SCHOOL DISTRICT,
- 2 INTERMEDIATE SCHOOL DISTRICT, PUBLIC SCHOOL ACADEMY, OR NONPUBLIC
- 3 SCHOOL AS PROVIDED UNDER THIS SECTION, THEN ANOTHER CRIMINAL
- 4 HISTORY CHECK OR CRIMINAL RECORDS CHECK IS NOT REQUIRED UNDER THIS
- 5 SECTION FOR THAT INDIVIDUAL AS LONG AS THE INDIVIDUAL REMAINS, WITH
- 6 NO BREAK IN SERVICE OTHER THAN NORMALLY SCHEDULED ACADEMIC CALENDAR
