

**SUBSTITUTE FOR  
HOUSE BILL NO. 6315**

A bill to amend 1915 PA 63, entitled

"An act to provide for the furnishing of suitable flag holders and United States flags for the graves of veterans who served in the armed forces of the United States for the marking and designation of the graves for memorial purposes; and to provide a penalty for the removal or destruction of the flag holders and United States flags when placed,"

by amending sections 1 and 1a (MCL 35.831 and 35.831a), section 1 as amended by 2005 PA 26 and section 1a as added by 2005 PA 27.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1        Sec. 1. (1) The legislative body of a city, village,  
2        **MUNICIPALITY**, or township in this state, upon the petition of **A**  
3        **RECOGNIZED VETERANS' ORGANIZATION OR OF** 5 eligible voters of the  
4        city, village, **MUNICIPALITY**, or township, shall procure for and  
5        furnish to the petitioners, at the expense of the city, village,  
6        **MUNICIPALITY**, or township, a suitable flag holder and United States  
7        flag for the grave of each veteran who served in the armed forces

2 **PUBLIC OR PRIVATE** cemetery ~~belonging to~~ LOCATED WITHIN the city,  
3 village, **MUNICIPALITY**, or township.

4 ~~(2) The legislative body of a city, village, or township in~~

16 Sec. 1a. (1) The legislative body of a county in this state,  
17 upon petition of **A RECOGNIZED VETERANS' ORGANIZATION OR OF 5**  
18 eligible voters of the county, may procure for and furnish to the  
19 petitioners, at the expense of the county, a suitable flag holder  
20 and United States flag for the grave of each veteran who served in  
21 the armed forces of the United States and who is buried in any  
22 **PUBLIC OR PRIVATE** cemetery located within the limits of the county.  
23 ~~that does not belong to that county.~~

24 (2) A flag holder and United States flag shall be placed on  
25 the grave of a veteran for the purpose of marking and designating  
26 the grave for memorial purposes.
