SENATE SUBSTITUTE FOR HOUSE BILL NO. 5606

A bill to amend 1976 PA 451, entitled "The revised school code,"

by amending section 1280 (MCL 380.1280), as amended by 2003 PA 275, and by adding section 1278a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 THE MIACCESS ASSESSMENTS.
- 2 (B) HAS SUCCESSFULLY COMPLETED THE CREDIT REQUIREMENTS OF THE
- 3 MICHIGAN MERIT CURRICULUM BEFORE GRADUATING FROM HIGH SCHOOL. THE
- 4 CREDIT REQUIREMENTS OF THE MICHIGAN MERIT CURRICULUM ARE AS
- 5 FOLLOWS:
- 6 (i) AT LEAST 4 CREDITS IN ENGLISH LANGUAGE ARTS THAT ARE
- 7 ALIGNED WITH SUBJECT AREA CONTENT EXPECTATIONS DEVELOPED BY THE

- 16 TRIGONOMETRY, STATISTICS, PRECALCULUS, CALCULUS, APPLIED MATH,
- 17 ACCOUNTING, BUSINESS MATH, OR A RETAKE OF ALGEBRA II. IF A PUPIL

- 25 IF A PUPIL SUCCESSFULLY COMPLETES 1 OR MORE OF THESE SCIENCE
- 26 CREDITS BEFORE ENTERING HIGH SCHOOL, THE PUPIL SHALL BE GIVEN HIGH
- 27 SCHOOL CREDIT FOR THAT CREDIT. THE LEGISLATURE STRONGLY ENCOURAGES

- 13 (vi) AT LEAST 1 CREDIT IN VISUAL ARTS, PERFORMING ARTS, OR
- 14 APPLIED ARTS, AS DEFINED BY THE DEPARTMENT, THAT IS ALIGNED WITH
- 15 GUIDELINES DEVELOPED BY THE DEPARTMENT.
- 16 (C) HAS SUCCESSFULLY MET THE ELECTIVE COURSE CREDIT
- 17 REQUIREMENTS ESTABLISHED BY THE SCHOOL DISTRICT OR PUBLIC SCHOOL
- 18 ACADEMY UNDER SUBSECTION (6).
- 19 (D) MEETS EITHER OF THE FOLLOWING, AS DETERMINED BY THE SCHOOL
- 20 DISTRICT OR PUBLIC SCHOOL ACADEMY:
- 21 (i) HAS SUCCESSFULLY COMPLETED AT LEAST 1 COURSE OR LEARNING
- 22 EXPERIENCE THAT IS PRESENTED ONLINE, AS DEFINED BY THE DEPARTMENT.
- 23 (ii) THE PUPIL'S SCHOOL DISTRICT OR PUBLIC SCHOOL ACADEMY HAS
- 24 INTEGRATED AN ONLINE EXPERIENCE THROUGHOUT THE HIGH SCHOOL
- 25 CURRICULUM BY ENSURING THAT EACH TEACHER OF EACH COURSE THAT
- 26 PROVIDES THE REQUIRED CREDITS OF THE MICHIGAN MERIT CURRICULUM HAS

- 5 EQUIVALENT TO 2 CREDITS IN A LANGUAGE OTHER THAN ENGLISH.

- 16 THE MICHIGAN MERIT CURRICULUM, THE PUPIL'S PARENT OR LEGAL GUARDIAN
- 17 MAY REQUEST A MODIFICATION OF THE ALGEBRA II CREDIT REQUIREMENT AT

- 11 PUPILS ENTERING GRADE 9 IN 2007 OR IS UNABLE TO IMPLEMENT ANOTHER
- 12 REQUIREMENT OF THIS SECTION, THE SCHOOL DISTRICT OR PUBLIC SCHOOL
- 13 ACADEMY MAY APPLY TO THE DEPARTMENT FOR PERMISSION TO PHASE IN 1 OR

- 3 SUBJECT AREA CONTENT EXPECTATIONS OR GUIDELINES DEVELOPED BY THE
- 4 DEPARTMENT THAT APPLY TO A CREDIT AT LEAST IN PART ON THE PUPIL'S
- 5 PERFORMANCE ON THE ASSESSMENTS DEVELOPED OR SELECTED BY THE
- 6 DEPARTMENT UNDER SUBSECTION (3)(B) OR ON 1 OR MORE ASSESSMENTS
- 7 DEVELOPED OR SELECTED BY THE SCHOOL DISTRICT OR PUBLIC SCHOOL
- 8 ACADEMY THAT MEASURE A PUPIL'S UNDERSTANDING OF THE SUBJECT AREA
- 9 CONTENT EXPECTATIONS OR GUIDELINES THAT APPLY TO THE CREDIT.
- 10 (C) A SCHOOL DISTRICT OR PUBLIC SCHOOL ACADEMY SHALL ALSO
- 11 GRANT A PUPIL A CREDIT IF THE PUPIL EARNS A QUALIFYING SCORE, AS
- 12 DETERMINED BY THE DEPARTMENT, ON THE ASSESSMENTS DEVELOPED OR
- 13 SELECTED FOR THE SUBJECT AREA BY THE DEPARTMENT UNDER SUBSECTION
- 14 (3) (B) OR THE PUPIL EARNS A QUALIFYING SCORE, AS DETERMINED BY THE

- 19 (11) THIS SECTION DOES NOT PROHIBIT A PUPIL FROM SATISFYING OR
- 20 EXCEEDING THE CREDIT REQUIREMENTS OF THE MICHIGAN MERIT CURRICULUM
- 21 UNDER THIS SECTION THROUGH ADVANCED STUDIES SUCH AS ADVANCED
- 22 PLACEMENT, DUAL ENROLLMENT IN A POSTSECONDARY INSTITUTION, OR THE
- 23 INTERNATIONAL BACCALAUREATE PROGRAM.
- 24 (12) NOT LATER THAN OCTOBER 1 OF EACH YEAR, A SCHOOL DISTRICT
- 25 OR PUBLIC SCHOOL ACADEMY THAT OPERATES A HIGH SCHOOL SHALL SUBMIT
- 26 TO THE INTERMEDIATE SCHOOL DISTRICT IN WHICH IT IS LOCATED AN
- 27 ANNUAL REPORT DETAILING THE NUMBER OF PUPILS WHO HAVE REQUESTED AND

- 1 RECEIVED A MODIFICATION OF THE ALGEBRA II CREDIT REQUIREMENT UNDER
- 2 SUBSECTION (4)(B).
- 3 Sec. 1280. (1) The board of a school district that does not
- 4 want to be subject to the measures described in this section shall
- 5 ensure that each public school within the school district is
- 6 accredited.
- 7 (2) As used in subsection (1), and subject to subsection (6),
- 8 "accredited" means certified by the superintendent of public
- 9 instruction as having met or exceeded standards established under
- 10 this section for 6 areas of school operation: administration and
- 11 school organization, curricula, staff, school plant and facilities,
- 12 school and community relations, and school improvement plans and
- 13 student performance. The building-level evaluation used in the
- 14 accreditation process shall include, but is not limited to, school
- 15 data collection, self-study, visitation and validation,
- 16 determination of performance data to be used, and the development
- 17 of a school improvement plan.
- 18 (3) The department shall develop and distribute to all public
- 19 schools proposed accreditation standards. Upon distribution of the
- 20 proposed standards, the department shall hold statewide public
- 21 hearings for the purpose of receiving testimony concerning the
- 22 standards. After a review of the testimony, the department shall
- 23 revise and submit the proposed standards to the superintendent of

- 1 Upon approval by these committees, the department shall distribute

- 6 (4) The superintendent of public instruction shall develop and
- 7 distribute to all public schools standards for determining that a
- 8 school is eligible for summary accreditation under subsection (6).
- 9 The standards shall be developed, reviewed, approved, and
- 10 distributed using the same process as prescribed in subsection (3)
- 11 for accreditation standards, and shall be finally distributed and
- implemented not later than December 31, 1994.
- 13 (5) The standards for accreditation or summary accreditation
- 14 under this section shall include AS CRITERIA pupil performance on
- 15 Michigan education assessment program (MEAP) tests and ON THE
- 16 MICHIGAN MERIT EXAMINATION UNDER SECTION 1279G AND, UNTIL THE
- 17 MICHIGAN MERIT EXAMINATION HAS BEEN FULLY IMPLEMENTED, the
- 18 percentage of pupils achieving state endorsement under section
- 19 1279, -as criteria, but shall not be based solely on pupil
- 20 performance on MEAP tests OR THE MICHIGAN MERIT EXAMINATION or on
- 21 the percentage of pupils achieving state endorsement under section
- 22 1279. The standards shall also include AS CRITERIA multiple year
- 23 change in pupil performance on MEAP tests AND THE MICHIGAN MERIT
- 24 EXAMINATION and, UNTIL AFTER THE MICHIGAN MERIT EXAMINATION IS
- 25 FULLY IMPLEMENTED, multiple year change in the percentage of pupils
- 26 achieving state endorsement under section 1279. as criteria. If
- 27 it is necessary for the superintendent of public instruction to

- 1 revise accreditation or summary accreditation standards established
- 2 under subsection (3) or (4) to comply with this subsection, the
- 3 revised standards shall be developed, reviewed, approved, and
- 4 distributed using the same process as prescribed in subsection (3).
- 5 (6) If the superintendent of public instruction determines
- 6 that a public school has met the standards established under
- 7 subsection (4) or (5) for summary accreditation, the school is
- 8 considered to be accredited without the necessity for a full
- 9 building-level evaluation under subsection (2).
- 10 (7) If the superintendent of public instruction determines
- 11 that a school has not met the standards established under
- 12 subsection (4) or (5) for summary accreditation but that the school
- 13 is making progress toward meeting those standards, or if, based on
- 14 a full building-level evaluation under subsection (2), the
- 15 superintendent of public instruction determines that a school has
- 16 not met the standards for accreditation but is making progress
- 17 toward meeting those standards, the school is in interim status and
- 18 is subject to a full building-level evaluation as provided in this
- 19 section.
- 20 (8) If a school has not met the standards established under
- 21 subsection (4) or (5) for summary accreditation and is not eligible
- 22 for interim status under subsection (7), the school is unaccredited
- 23 and subject to the measures provided in this section.
- 24 (9) Beginning with the 2002-2003 school year, if at least 5%
- of a public school's answer sheets from the administration of the
- 26 Michigan educational assessment program (MEAP) tests are lost by
- 27 the department or by a state contractor and if the public school

- 1 can verify that the answer sheets were collected from pupils and
- 2 forwarded to the department or the contractor, the department shall
- 3 not assign an accreditation score or school report card grade to
- 4 the public school for that subject area for the corresponding year
- 5 for the purposes of determining state accreditation under this
- 6 section. The department shall not assign an accreditation score or
- 7 school report card grade to the public school for that subject area
- 8 until the results of all tests for the next year are available.
- 9 (10) Subsection (9) does not preclude the department from
- 10 determining whether a public school or a school district has
- 11 achieved adequate yearly progress for the school year in which the
- 12 answer sheets were lost for the purposes of the no child left
- 13 behind act of 2001, Public Law 107-110, 115 Stat. 1425. However,
- 14 the department shall ensure that a public school or the school
- 15 district is not penalized when determining adequate yearly progress
- 16 status due to the fact that the public school's MEAP answer sheets
- 17 were lost by the department or by a state contractor, but shall not
- 18 require a public school or school district to retest pupils or
- 19 produce scores from another test for this purpose.
- 20 (11) The superintendent of public instruction shall annually
- 21 review and evaluate for accreditation purposes the performance of
- 22 each school that is unaccredited and as many of the schools that
- 23 are in interim status as permitted by the department's resources.
- 24 (12) The superintendent of public instruction shall, and the
- 25 intermediate school district to which a school district is
- 26 constituent, a consortium of intermediate school districts, or any
- 27 combination thereof may, provide technical assistance, as

- 1 appropriate, to a school that is unaccredited or that is in interim
- 2 status upon request of the board of the school district in which
- 3 the school is located. If requests to the superintendent of public
- 4 instruction for technical assistance exceed the capacity, priority
- 5 shall be given to unaccredited schools.
- 6 (13) A school that has been unaccredited for 3 consecutive
- 7 years is subject to 1 or more of the following measures, as
- 8 determined by the superintendent of public instruction:
- 9 (a) The superintendent of public instruction or his or her
- 10 designee shall appoint at the expense of the affected school
- 11 district an administrator of the school until the school becomes
- 12 accredited.
- 13 (b) A parent, legal guardian, or person in loco parentis of a
- 14 child who attends the school may send his or her child to any
- 15 accredited public school with an appropriate grade level within the
- 16 school district.
- 17 (c) The school, with the approval of the superintendent of
- 18 public instruction, shall align itself with an existing research-
- 19 based school improvement model or establish an affiliation for
- 20 providing assistance to the school with a college or university
- 21 located in this state.
- 22 (d) The school shall be closed.
- 23 (14) The superintendent of public instruction shall evaluate
- 24 the school accreditation program and the status of schools under
- 25 this section and shall submit an annual report based upon the
- 26 evaluation to the senate and house committees that have the
- 27 responsibility for education legislation. The report shall address

- the reasons each unaccredited school is not accredited and shall 1
- 2 recommend legislative action that will result in the accreditation
- 3 of all public schools in this state.
- 4 (15) BEGINNING WITH THE 2007-2008 SCHOOL YEAR, A HIGH SCHOOL
- SHALL NOT BE ACCREDITED BY THE DEPARTMENT UNLESS THE DEPARTMENT 5
- DETERMINES THAT THE HIGH SCHOOL IS PROVIDING OR HAS OTHERWISE
- ENSURED THAT ALL PUPILS HAVE ACCESS TO ALL OF THE ELEMENTS OF THE 7
- CURRICULUM REQUIRED UNDER SECTION 1278A THAT HAVE BEEN FINALLY 8
- APPROVED BY THE STATE BOARD. IF IT IS NECESSARY FOR THE 9
- SUPERINTENDENT OF PUBLIC INSTRUCTION TO REVISE ACCREDITATION OR 10
- 11 SUMMARY ACCREDITATION STANDARDS ESTABLISHED UNDER SUBSECTION (3) OR
- 12 (4) TO COMPLY WITH THE CHANGES MADE TO THIS SECTION BY THE
- AMENDATORY ACT THAT ADDED THIS SUBSECTION, THE REVISED STANDARDS 13
- SHALL BE DEVELOPED, REVIEWED, APPROVED, AND DISTRIBUTED USING THE 14
