## SENATE SUBSTITUTE FOR HOUSE BILL NO. 5661

A bill to amend 1956 PA 218, entitled
"The insurance code of 1956,"

(MCL 500.100 to 500.8302) by adding section 2111a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 2111A. (1) NOTWITHSTANDING SECTION 2111, AN AUTOMOBILE
- 2 INSURER MAY OFFER A PREMIUM DISCOUNT TO INSUREDS 50 YEARS OF AGE
- 3 AND OLDER WHO SUCCESSFULLY COMPLETE A TRAFFIC ACCIDENT PREVENTION
- 4 COURSE THAT AN AUTOMOBILE INSURER DETERMINES MEETS ALL OF THE
- 5 CRITERIA LISTED IN SUBSECTION (3).
- 6 (2) AN AUTOMOBILE INSURER MAY PROVIDE THE DISCOUNT UNDER
- 7 SUBSECTION (1) FOR 3 YEARS AFTER SUCCESSFUL COMPLETION OF AN
- 8 INITIAL OR REFRESHER TRAFFIC ACCIDENT PREVENTION COURSE.
- 9 (3) A TRAFFIC ACCIDENT PREVENTION COURSE SHALL PROVIDE FOR ALL

- 1 OF THE FOLLOWING:
- (A) FOR AN INITIAL TRAFFIC ACCIDENT PREVENTION COURSE, 2
- 3 INCLUDES NOT LESS THAN 8 HOURS OF CLASSROOM INSTRUCTION TAUGHT BY
- 4 AN INSTRUCTOR CERTIFIED BY THE ENTITY OFFERING THE COURSE. FOR A
- 5 REFRESHER TRAFFIC ACCIDENT PREVENTION COURSE, INCLUDES NOT LESS
- THAN 4 HOURS OF CLASSROOM INSTRUCTION TAUGHT BY AN INSTRUCTOR
- 7 CERTIFIED BY THE ENTITY OFFERING THE COURSE.
- (B) INCLUDES, BUT IS NOT LIMITED TO, INSTRUCTION IN ALL OF THE 8
- 9 FOLLOWING AREAS:
- (i) THE EFFECTS OF AGING ON DRIVING BEHAVIOR. 10
- 11 (ii) THE SHAPES, COLORS, AND TYPES OF ROAD SIGNS.
- 12 (iii) THE EFFECTS OF ALCOHOL AND OTHER DRUGS, INCLUDING
- 13 MEDICATIONS, ON OLDER DRIVERS.
- (iv) LAWS RELATING TO THE PROPER USE OF A MOTOR VEHICLE AND 14
- 15 SAFE DRIVING BEHAVIOR.
- 16 (v) TRAFFIC CRASH AVOIDANCE AND PREVENTION MEASURES.
- 17 (vi) THE BENEFITS AND PROPER USE OF MOTOR VEHICLE OCCUPANT
- 18 PROTECTION SYSTEMS.
- 19 (vii) MAJOR DRIVING HAZARDS AND RISK FACTORS ASSOCIATED WITH
- 20 TRAFFIC CRASH PREVENTION.
- 21 (viii) INTERACTION WITH OTHER HIGHWAY USERS SUCH AS EMERGENCY
- 22 VEHICLES, TRUCKS, MOTORCYCLISTS, BICYCLISTS, AND PEDESTRIANS.
- 23 (C) PROVIDES, UPON SUCCESSFUL COMPLETION OF THE COURSE, A
- 24 CERTIFICATE OF COMPLETION THAT MAY BE USED IN APPLYING FOR AN
- 25 AUTOMOBILE INSURANCE PREMIUM DISCOUNT UNDER SUBSECTION (1).
