

SENATE SUBSTITUTE FOR
HOUSE BILL NO. 5864

A bill to amend 1956 PA 217, entitled
"Electrical administrative act,"
by amending section 2 (MCL 338.882), as amended by 1992 PA 130.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 2. (1) The board shall consist of ~~a representative of~~
2 ~~the department of state police, fire marshal division, appointed by~~
3 ~~the director of state police~~ **THE STATE FIRE MARSHAL OR HIS OR HER**
4 **REPRESENTATIVE** and 9 other members who are residents of this state,
5 appointed by the governor with the advice and consent of the
6 senate. Of the 9 members appointed by the governor, 1 shall be a
7 representative of an insurance inspection bureau operating in this
8 state, 1 shall be a representative of an electrical energy supply
9 agency operating in this state, 1 shall be an electrical contractor

1 operating in this state, 1 shall be a master electrician serving as
 2 a supervisor, 1 shall be an electrical journeyman, 1 shall be a
 3 chief electrical inspector of a municipality, 1 shall be a
 4 representative of distributors of electrical apparatus and
 5 supplies, 1 shall be a representative of manufacturers primarily
 6 and actively engaged in producing material fittings, devices,
 7 appliances, fixtures, apparatus, and similar products, used as a
 8 part of, or in connection with, an electrical installation, and 1
 9 shall be representative of the general public. The director of
 10 ~~labor~~ **THE DEPARTMENT OF LABOR AND ECONOMIC GROWTH**, or the
 11 authorized representative of the director, shall be an ex officio
 12 member of the board without vote. Each appointment **MADE BEFORE**
 13 **JANUARY 1, 2007** shall be for a term of 3 years. **EACH APPOINTMENT**
 14 **MADE AFTER DECEMBER 31, 2006 SHALL BE FOR 4 YEARS.** The members of
 15 the board ~~annually shall elect a chairperson, and~~ shall hold
 16 regular meetings 4 times a year. **BEFORE JANUARY 1, 2007, THE**
 17 **MEMBERS OF THE BOARD ANNUALLY SHALL ELECT A CHAIRPERSON. AFTER**
 18 **DECEMBER 31, 2006, THE GOVERNOR SHALL DESIGNATE A MEMBER OF THE**
 19 **BOARD TO SERVE AS ITS CHAIRPERSON AT THE PLEASURE OF THE GOVERNOR**
 20 **AND THE MEMBERS OF THE BOARD MAY ANNUALLY ELECT A VICE-CHAIRPERSON.**
 21 A special meeting may be called by the chairperson or upon written
 22 request of 4 members.

23 (2) ~~There is created a fire alarm industry advisory committee~~

9 (3) ~~—(4)—~~ The business ~~which~~ **THAT** the board may perform
 10 shall be conducted at a public meeting of the board held in
 11 compliance with the open meetings act, ~~Act No. 267 of the Public~~

 13 ~~Compiled Laws 1976 PA 267, MCL 15.261 TO 15.275.~~ Public notice of
 14 the time, date, and place of the meeting shall be given in the
 15 manner required by ~~Act No. 267 of the Public Acts of 1976~~ **THE**
 16 **OPEN MEETINGS ACT, 1976 PA 267, MCL 15.261 TO 15.275.**

17 ~~—— (5) The per diem compensation of the 9 members of the board~~
 18 ~~appointed by the governor, and the schedule for reimbursement of~~
 19 ~~expenses shall be established annually by the legislature.~~

20 (4) **EACH OF THE 9 MEMBERS OF THE BOARD APPOINTED BY THE**
 21 **GOVERNOR SHALL BE ENTITLED TO ACTUAL AND NECESSARY EXPENSES**
 22 **INCURRED IN THE PERFORMANCE OF HIS OR HER DUTIES AS A MEMBER OF THE**
 23 **BOARD, SUBJECT TO AVAILABLE APPROPRIATIONS.**

24 (5) ~~—(6)—~~ In a political subdivision where this act applies,
 25 the board may inspect electrical wiring and its installation, and
 26 shall fix the fees for the inspection at rates not higher than the
 27 average rates for similar inspections charged by the 3 highest

1 populated cities in this state. The director of ~~labor~~ **THE**
2 **DEPARTMENT OF LABOR AND ECONOMIC GROWTH** shall appoint electrical
3 inspectors from the state civil service commission's eligible
4 register.

5 Enacting section 1. This amendatory act does not take effect
6 unless all of the following bills of the 93rd Legislature are
