SENATE SUBSTITUTE FOR HOUSE BILL NO. 5977

A bill to amend 1976 PA 451, entitled

"The revised school code,"

by amending section 1384b (MCL 380 1384b), as amended by 20

by amending section 1284b (MCL 380.1284b), as amended by 2005 PA 144.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1284b. (1) Until subsection (2) applies to the school
- 2 district, public school academy, or intermediate school district,
- 3 the board of a school district or intermediate school district or
- 4 board of directors of a public school academy shall ensure that the
- 5 district's or public school academy's schools are not in session on
- 6 the Friday before Labor day.
- 7 (2) Except as otherwise provided in subsections (3) and (4)
- 8 THIS SECTION, the board of a school district or intermediate school

- 1 district or board of directors of a public school academy shall
- 2 ensure that the district's or public school academy's pupils are
- 3 not required to begin a school year DOES NOT BEGIN before Labor
- 4 day.
- 5 (3) If a collective bargaining agreement that provides a
- 6 complete school calendar is in effect for employees of a school
- 7 district, public school academy, or intermediate school district as
- 8 of the effective date of the amendatory act that added subsection
- 9 (2), and if that school calendar is not in compliance with
- 10 subsection (2), then subsection (2) does not apply to that school
- 11 district, public school academy, or intermediate school district
- 12 until after the expiration of that collective bargaining agreement.

- 14 public school academy is operating a year-round school or program

- 15 SUBSECTION (3) OR (4), THEN THE INTERMEDIATE SCHOOL DISTRICT MAY
- 16 PROVIDE PROGRAMS OR SERVICES ACCORDING TO THE SCHOOL DISTRICT'S OR
- 17 PUBLIC SCHOOL ACADEMY'S CALENDAR.
- 18 (6) THIS SECTION DOES NOT APPLY TO A PUBLIC SCHOOL THAT
- 19 OPERATES ALL OF GRADES 6 TO 12 AT A SINGLE SITE, THAT ALIGNS ITS
- 20 HIGH SCHOOL CURRICULUM WITH ADVANCED PLACEMENT COURSES AS THE
- 21 CAPSTONE OF THE CURRICULUM, AND THAT ENDS ITS SECOND ACADEMIC
- 22 SEMESTER CONCURRENTLY WITH THE END OF THE ADVANCED PLACEMENT
- 23 EXAMINATION PERIOD.
- 24 (7) THIS SECTION DOES NOT PROHIBIT A SCHOOL DISTRICT,
- 25 INTERMEDIATE SCHOOL DISTRICT, OR PUBLIC SCHOOL ACADEMY FROM
- 26 OFFERING OR REQUIRING PROFESSIONAL DEVELOPMENT FOR ITS PERSONNEL
- 27 THAT IS CONDUCTED BEFORE LABOR DAY.
