A bill to amend 1978 PA 368, entitled "Public health code,"

by amending sections 7301a, 16111, 16122, 16139, and 16264 (MCL 333.7301a, 333.16111, 333.16122, 333.16139, and 333.16264), section 7301a as added and section 16111 as amended by 1988 PA 462 and sections 16122 and 16139 as amended by 1993 PA 80; and to repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 7301a. Licensing activities conducted under this part are
- 2 subject to sections 16201, 16203, 16263, 16299, 16303, 16305,
- **3** 16307, 16309, and 16313.
- 4 Sec. 16111. (1) This part applies to health professions, but,
- **5** except for sections 16201, 16261, 16263, 16299, 16301, 16303,
 - 16305, 16307, 16309, and 16313, does not apply to a pharmacy,

- 1 dispensing prescriber, or drug manufacturer or wholesaler who is

- 3 (2) Except as otherwise provided by this article, this part

- 15 individual as having completed or attained specific training or as
