SENATE SUBSTITUTE FOR HOUSE BILL NO. 6162

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding section 30306b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 30306B. (1) IF A PREAPPLICATION MEETING IS REQUESTED IN
- 2 WRITING BY THE LANDOWNER OR ANOTHER PERSON WHO IS AUTHORIZED IN
- 3 WRITING BY THE LANDOWNER, THE DEPARTMENT SHALL MEET WITH THE PERSON
- 4 OR HIS OR HER REPRESENTATIVES TO REVIEW A PROPOSED PROJECT OR A
- 5 PROPOSED PERMIT APPLICATION IN ITS ENTIRETY. THE PREAPPLICATION
- 6 MEETING SHALL TAKE PLACE AT THE DEPARTMENT'S DISTRICT OFFICE FOR
- 7 THE DISTRICT THAT INCLUDES THE PROJECT SITE OR AT THE PROJECT SITE
- 8 ITSELF, AS SPECIFIED IN THE REQUEST.
- 9 (2) EXCEPT AS PROVIDED IN THIS SUBSECTION, THE REQUEST SHALL

- BE ACCOMPANIED BY A FEE. THE FEE FOR A PREAPPLICATION MEETING AT 1
- 2 THE DISTRICT OFFICE IS \$150.00. THE FEE FOR A PREAPPLICATION
- 3 MEETING AT THE PROJECT SITE IS \$250.00 FOR THE FIRST ACRE OR
- 4 PORTION OF AN ACRE OF PROJECT AREA, PLUS \$50.00 FOR EACH ACRE OR
- 5 PORTION OF AN ACRE IN EXCESS OF THE FIRST ACRE, BUT NOT TO EXCEED A
- 6 FEE OF \$1,000.00. HOWEVER, IF THE LOCATION OF THE PROJECT IS A
- 7 SINGLE FAMILY RESIDENTIAL LOT THAT IS LESS THAN 1 ACRE IN SIZE,
- THERE IS NO FEE FOR A PREAPPLICATION MEETING AT THE DISTRICT 8
- 9 OFFICE, AND THE FEE FOR A PREAPPLICATION MEETING AT THE PROJECT
- 10 SITE IS \$100.00.
- 11 (3) IF THE PERSON WITHDRAWS THE REQUEST AT LEAST 24 HOURS
- 12 BEFORE THE PREAPPLICATION MEETING, THE DEPARTMENT MAY AGREE WITH
- 13 THE PERSON TO RESCHEDULE THE MEETING OR SHALL PROMPTLY REFUND THE
- FEE AND NEED NOT MEET AS PROVIDED IN THIS SECTION. OTHERWISE, IF, 14
- 15 AFTER AGREEING TO THE TIME AND PLACE FOR A PREAPPLICATION MEETING,
- 16 THE PERSON IS NOT REPRESENTED AT THE MEETING, THE PERSON SHALL
- 17 FORFEIT THE FEE FOR THE MEETING. IF, AFTER AGREEING TO THE TIME AND
- 18 PLACE FOR A PREAPPLICATION MEETING, THE DEPARTMENT IS NOT
- 19 REPRESENTED AT THE MEETING, THE DEPARTMENT SHALL REFUND THE FEE AND
- 20 SEND A REPRESENTATIVE TO A RESCHEDULED MEETING TO BE HELD WITHIN 10
- 21 DAYS OF THE FIRST SCHEDULED MEETING DATE.
- 22 (4) ANY WRITTEN AGREEMENT PROVIDED BY THE DEPARTMENT AS A
- 23 RESULT OF THE PREAPPLICATION MEETING REGARDING THE NEED TO OBTAIN A
- 24 PERMIT IS BINDING ON THE DEPARTMENT FOR 2 YEARS FROM THE DATE OF
- 25 THE AGREEMENT.
