

HOUSE BILL No. 6225

June 20, 2006, Introduced by Rep. Mortimer and referred to the Committee on Insurance.

A bill to amend 1956 PA 218, entitled
"The insurance code of 1956,"
(MCL 500.100 to 500.8302) by adding section 8124a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 8124A. ANY GUARANTY ASSOCIATION OR FOREIGN GUARANTY
2 ASSOCIATION HAS STANDING TO APPEAR AND MAY INTERVENE AS A PARTY AS
3 A MATTER OF RIGHT OR OTHERWISE APPEAR AND PARTICIPATE IN ANY COURT
4 PROCEEDING CONCERNING THE REHABILITATION OR LIQUIDATION OF AN
5 INSURER IF THE ASSOCIATION IS OR MAY BECOME LIABLE TO ACT AS A
6 RESULT OF THE LIQUIDATION. EXERCISE BY ANY GUARANTY ASSOCIATION OR
7 ITS DESIGNATED REPRESENTATIVE OF THE RIGHT TO INTERVENE CONFERRED
8 UNDER THIS SUBSECTION DOES NOT CONSTITUTE GROUNDS TO ESTABLISH
9 GENERAL PERSONAL JURISDICTION BY THE COURTS OF THIS STATE. THE

1 INTERVENING GUARANTY ASSOCIATION OR FOREIGN GUARANTY ASSOCIATION IS
2 SUBJECT TO THE COURT'S JURISDICTION ONLY FOR THE LIMITED PURPOSE
3 FOR WHICH IT INTERVENES.
