- 1 SEC. 13A. (1) IN A CHARTER TOWNSHIP << IN A COUNTY WITH A POPULATION OF MORE THAN 1,000,000 BUT LESS THAN 2,000,000>> THAT HAS NOT BEEN LOCATED
- 2 WITHIN THE SERVICE AREA OF AN ESTABLISHED FREE PUBLIC LIBRARY FOR
- 3 THE PREVIOUS 5 YEARS, THE TOWNSHIP BOARD MAY ESTABLISH AND MAINTAIN
- 4 A FREE PUBLIC LIBRARY.
