HOUSE SUBSTITUTE FOR SENATE BILL NO. 130

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding sections 411u and 411v.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 411U. (1) AN INDIVIDUAL WHO IS REQUIRED TO BE REGISTERED
- 2 UNDER THE SEX OFFENDERS REGISTRATION ACT, 1994 PA 295, MCL 28.721
- 3 TO 28.732, SHALL NOT ACCEPT OR MAINTAIN EMPLOYMENT WITH OR SERVE AS
- 4 A VOLUNTEER WITH ANY OF THE FOLLOWING:
- 5 (A) A CHILD CARE CENTER.
- 6 (B) A SCHOOL.
- 7 (C) A PLAYGROUND.
- 8 (D) A YOUTH LEAGUE OR YOUTH ORGANIZATION.
- 9 (2) SUBSECTION (1) DOES NOT APPLY IF THE POSITION OF

- 1 EMPLOYMENT OR THE VOLUNTEER POSITION DOES NOT TAKE PLACE AT A
- 2 LOCATION WHERE, OR AT A TIME WHEN, CHILDREN ARE PRESENT.
- 3 (3) AN INDIVIDUAL WHO VIOLATES THIS SECTION IS GUILTY OF A
- 4 CRIME AS FOLLOWS:
- 5 (A) EXCEPT AS PROVIDED IN SUBDIVISION (B), THE INDIVIDUAL IS
- 6 GUILTY OF A FELONY PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 2
- 7 YEARS OR A FINE OF NOT MORE THAN \$2,000.00, OR BOTH.
- 8 (B) IF THE INDIVIDUAL GIVES A FALSE NAME OR OTHERWISE
- 9 MISREPRESENTS HIS OR HER IDENTITY ON AN APPLICATION FOR EMPLOYMENT
- 10 OR FOR A VOLUNTEER POSITION WITH AN ENTITY LISTED IN SUBSECTION
- 11 (1) OR FALSELY STATES ON THE APPLICATION THAT HE OR SHE IS NOT
- 12 REQUIRED TO BE REGISTERED UNDER THE SEX OFFENDERS REGISTRATION ACT,
- 13 1994 PA 295, MCL 28.721 TO 28.732, THE INDIVIDUAL IS GUILTY OF A
- 14 FELONY PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 4 YEARS OR A
- 15 FINE OF NOT MORE THAN \$4,000.00, OR BOTH.
- 16 (4) AS USED IN THIS SECTION:
- 17 (A) "CHILD CARE CENTER" MEANS THAT TERM AS DEFINED IN SECTION
- 18 1 OF 1973 PA 116, MCL 722.111.
- 19 (B) "CHILDREN" MEANS INDIVIDUALS LESS THAN 18 YEARS OF AGE.
- 20 (C) "PLAYGROUND" MEANS AN ENTITY THAT HAS PLAYGROUND EQUIPMENT
- 21 FOR PUBLIC USE BY CHILDREN.
- 22 (D) "PLAYGROUND EQUIPMENT" MEANS A DEVICE OR STRUCTURE THAT IS
- 23 DESIGNED FOR THE RECREATIONAL USE OF CHILDREN. PLAYGROUND EQUIPMENT
- 24 INCLUDES, BUT IS NOT LIMITED TO, A SLIDE, SWING, JUNGLE GYM, MONKEY
- 25 BARS, TEETER-TOTTER, OR MERRY-GO-ROUND.
- 26 (E) "SCHOOL" MEANS A PUBLIC OR PRIVATE INSTITUTION IMPARTING
- 27 INSTRUCTION TO CHILDREN IN ANY GRADE K THROUGH 12. SCHOOL DOES NOT

- 1 INCLUDE A HOME SCHOOL ATTENDED SOLELY BY CHILDREN OF THE INDIVIDUAL
- 2 REQUIRED TO BE REGISTERED UNDER THE SEX OFFENDERS REGISTRATION ACT,
- 3 1994 PA 295, MCL 28.721 TO 28.732.
- 4 (F) "VOLUNTEER" MEANS AN INDIVIDUAL WHO WORKS WITHOUT
- 5 REMUNERATION FOR AN ENTITY DESCRIBED IN SUBSECTION (1) IF ANY OF
- 6 THE FOLLOWING APPLY:
- 7 (i) THE INDIVIDUAL WORKS OR IS TO WORK FOR THAT ENTITY 20 OR
- 8 MORE HOURS WITHIN A CALENDAR YEAR.
- 9 (ii) THE INDIVIDUAL HAS OR IS TO HAVE UNSUPERVISED CONTACT WITH
- 10 CHILDREN.
- 11 (iii) THE INDIVIDUAL SERVES OR IS TO SERVE AS A CHAPERONE FOR
- 12 CHILDREN ON ANY OVERNIGHT ACTIVITY.
- 13 (G) "YOUTH LEAGUE OR YOUTH ORGANIZATION" MEANS A PUBLIC OR
- 14 PRIVATE ENTITY THAT PROVIDES RECREATIONAL, RELIGIOUS, OR
- 15 EDUCATIONAL SERVICES TO CHILDREN.
- 16 SEC. 411V. (1) A YOUTH LEAGUE OR YOUTH ORGANIZATION SHALL NOT
- 17 KNOWINGLY DO EITHER OF THE FOLLOWING:
- 18 (A) EMPLOY AN INDIVIDUAL WHO IS REGISTERED UNDER THE SEX
- 19 OFFENDERS REGISTRATION ACT, 1994 PA 295, MCL 28.721 TO 28.732, IF
- 20 THE POSITION OF EMPLOYMENT TAKES PLACE AT A LOCATION WHERE, AND AT
- 21 A TIME WHEN, CHILDREN ARE PRESENT.
- 22 (B) ALLOW AN INDIVIDUAL WHO IS REGISTERED UNDER THE SEX
- 23 OFFENDERS REGISTRATION ACT, 1994 PA 295, MCL 28.721 TO 28.732, TO
- 24 WORK AS A VOLUNTEER FOR THAT YOUTH LEAGUE OR YOUTH ORGANIZATION IF
- 25 THE VOLUNTEER POSITION TAKES PLACE AT A LOCATION WHERE, AND AT A
- 26 TIME WHEN, CHILDREN ARE PRESENT.
- 27 (2) BEFORE A YOUTH LEAGUE OR YOUTH ORGANIZATION HIRES OR

- ACCEPTS AN INDIVIDUAL AS A VOLUNTEER FOR ANY POSITION IN WHICH THE 1
- INDIVIDUAL WILL BE PRESENT AT A LOCATION WHERE AND A TIME WHEN 2
- 3 CHILDREN ARE PRESENT, AND ANNUALLY THEREAFTER, THE YOUTH LEAGUE OR
- YOUTH ORGANIZATION SHALL CHECK THE SEX OFFENDER REGISTRY OF THIS
- STATE TO DETERMINE WHETHER THE INDIVIDUAL IS REGISTERED AS A SEX 5
- 6 OFFENDER.
- 7 (3) IF A YOUTH LEAGUE OR YOUTH ORGANIZATION VIOLATES
- 8 SUBSECTION (1) OR (2), THE YOUTH LEAGUE OR YOUTH ORGANIZATION IS
- 9 GUILTY OF A MISDEMEANOR PUNISHABLE BY A FINE OF NOT MORE THAN
- 10 \$500.00.
- 11 (4) AS USED IN THIS SECTION:
- 12 (A) "CHILDREN" MEANS INDIVIDUALS LESS THAN 18 YEARS OF AGE.
- 13 (B) "VOLUNTEER" MEANS AN INDIVIDUAL WHO WORKS WITHOUT
- 14 REMUNERATION FOR AN ENTITY DESCRIBED IN SUBSECTION (1) IF EITHER OF
- 15 THE FOLLOWING APPLIES:
- (i) THE INDIVIDUAL WORKS OR IS TO WORK FOR THAT ENTITY 20 OR 16
- 17 MORE HOURS WITHIN A CALENDAR YEAR.
- 18 (ii) THE INDIVIDUAL HAS OR IS TO HAVE UNSUPERVISED CONTACT WITH
- 19 CHILDREN.
- 20 (C) "YOUTH LEAGUE OR YOUTH ORGANIZATION" MEANS A PUBLIC OR
- 21 PRIVATE ENTITY THAT PROVIDES RECREATIONAL, RELIGIOUS, OR
- 22 EDUCATIONAL SERVICES TO CHILDREN.
- Enacting section 1. This amendatory act takes effect October 23
- 15, 2005. 24
