SUBSTITUTE FOR

SENATE BILL NO. 301

A bill to amend 1972 PA 222, entitled

"An act to provide for an official personal identification card; to provide for its form, issuance and use; to regulate the use and disclosure of information obtained from the card; to prescribe the powers and duties of the secretary of state; to prescribe fees; to prescribe certain penalties for violations; and to provide an appropriation for certain purposes,"

by amending sections 1 and 2 (MCL 28.291 and 28.292), section 1 as amended by 1997 PA 99 and section 2 as amended by 2003 PA 143.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. (1) A person who is a resident of this state may apply
- 2 to the department of state for an official state personal
- 3 identification card. Upon application the applicant shall supply a
- 4 birth certificate attesting to his OR HER age or other sufficient
- 5 documents or identification as the secretary of state may require.

- 1 AN APPLICATION FOR A STATE PERSONAL IDENTIFICATION CARD SHALL BE
- 2 MADE IN A MANNER PRESCRIBED BY THE SECRETARY OF STATE AND SHALL
- 3 CONTAIN THE APPLICANT'S FULL NAME, DATE OF BIRTH, RESIDENCE
- 4 ADDRESS, HEIGHT, SEX, EYE COLOR, SIGNATURE, AND, BEGINNING JANUARY
- 5 1, 2007, INTENT TO BE AN ORGAN DONOR, AND OTHER INFORMATION
- 6 REQUIRED OR PERMITTED ON THE OFFICIAL STATE PERSONAL IDENTIFICATION
- 7 CARD. THE APPLICANT MAY PROVIDE A MAILING ADDRESS IF THE APPLICANT
- 8 RECEIVES MAIL AT AN ADDRESS DIFFERENT FROM HIS OR HER RESIDENCE
- 9 ADDRESS.
- 10 (2) The secretary of state shall not issue an official state
- 11 personal identification card to a person who holds an operator's or
- 12 chauffeur's license issued -pursuant to UNDER the Michigan vehicle
- 13 code, 1949 PA 300, MCL 257.1 to 257.923, unless the license has
- 14 been suspended, revoked, or restricted.
- 15 Sec. 2. (1) The official state personal identification card
- 16 shall contain the following:
- 17 (a) An identification number permanently assigned to the
- 18 person.
- 19 (b) The full name, date of birth, sex, residential address,
- 20 height, weight, eye color, image, and signature of the person to
- 21 whom the identification card is issued.
- (c) An indication that the identification card contains 1 or
- 23 more of the following:
- 24 (i) The blood type of the person.
- 25 (ii) Immunization data of the person.
- 26 (iii) Medication data of the person.
- (iv) A statement that the person is deaf.

- 1 (v) \rightarrow UNTIL JANUARY 1, 2007, A statement that the person is
- 2 an organ and tissue donor -pursuant to UNDER part 101 of the
- 3 public health code, 1978 PA 368, MCL 333.10101 to 333.10109. If the
- 4 identification card contains such a statement, the statement shall
- 5 include the signature of the person, along with the signature of at
- 6 least 1 witness.
- 7 (vi) Emergency contact information of the person.
- 8 (vii) A STICKER OR DECAL AS SPECIFIED BY THE SECRETARY OF STATE
- 9 TO INDICATE THAT THE HOLDER OF THE OFFICIAL STATE PERSONAL
- 10 IDENTIFICATION CARD HAS DESIGNATED 1 OR MORE PATIENT ADVOCATES IN
- 11 ACCORDANCE WITH SECTION 5506 OF THE ESTATES AND PROTECTED
- 12 INDIVIDUALS CODE, 1998 PA 386, MCL 700.5506, OR A STATEMENT THAT HE
- 13 OR SHE CARRIES AN EMERGENCY MEDICAL INFORMATION CARD, AS DESCRIBED
- 14 IN SUBSECTION (5).
- 15 (d) Beginning July 1, 2003, in IN the case of a person who
- 16 is less than 18 years of age at the time of issuance of the
- 17 identification card, the dates on which the person will become 18
- 18 years of age and 21 years of age.
- 19 (e) Beginning July 1, 2003, in IN the case of a person who
- 20 is -at least NOT LESS THAN 18 years of age but less than 21 years
- 21 of age at the time of issuance of the identification card, the date
- 22 on which the person will become 21 years of age.
- 23 (F) BEGINNING JANUARY 1, 2007, IN THE CASE OF A HOLDER OF AN
- 24 OFFICIAL STATE PERSONAL IDENTIFICATION CARD WHO HAS INDICATED HIS
- 25 OR HER WISH TO PARTICIPATE IN THE ORGAN AND TISSUE DONOR REGISTRY
- 26 UNDER PART 101 OF THE PUBLIC HEALTH CODE, 1978 PA 368, MCL
- 27 333.10101 TO 333.10109, A HEART INSIGNIA ON THE FRONT OF THE

- 1 OFFICIAL STATE PERSONAL IDENTIFICATION CARD.
- 2 (2) In conjunction with the APPLICATION FOR OR, UNTIL JANUARY
- 3 1, 2007, THE issuance of an official state personal identification
- 4 card, the secretary of state shall do all of the following:
- 5 (a) Provide the applicant with all of the following:
- 6 (i) Written information INFORMATION explaining the
- 7 applicant's right to make an anatomical gift in the event of death
- 8 pursuant to UNDER part 101 of the public health code, 1978 PA 368,
- **9** MCL 333.10101 to 333.10109, and in accordance with this section.
- 10 (ii) Written information INFORMATION describing the organ,
- 11 donation TISSUE, AND EYE DONOR registry program maintained by
- 12 Michigan's federally designated organ procurement organization or
- 13 its successor organization. The -written information required
- 14 under this subparagraph shall include, in a type size and format
- 15 that is conspicuous in relation to the surrounding material,
- 16 INCLUDES the address and telephone number of Michigan's federally
- 17 designated organ procurement organization or its successor
- 18 organization. -, along with an advisory to call Michigan's
- 19 federally designated organ procurement organization or its
- 20 successor organization with questions about the organ donor
- 21 registry program.
- 22 (iii) Written information INFORMATION giving the applicant the
- 23 opportunity to have his or her name placed on the -organ donor
- 24 registry described in subparagraph (ii).
- 25 (b) Provide the applicant with the opportunity to specify on
- 26 his or her official state personal identification card that he or
- 27 she is willing to make an anatomical gift in the event of death

- 1 pursuant to part 101 of the public health code, 1978 PA 368, MCL
- 2 333.10101 to 333.10109, and in accordance with this section.
- 3 (c) Inform the applicant -in writing- that, if he or she
- 4 indicates to the secretary of state under this section a
- 5 willingness to have his or her name placed on the -organ donor
- **6** registry described in subdivision (a)(ii), the secretary of state
- 7 will -forward MARK the applicant's -name and address to the organ
- 8 donation RECORD FOR THE registry. maintained by Michigan's
- 9 federally designated organ procurement organization or its
- 10 successor organization, pursuant to subsection (4).
- 11 (3) The secretary of state may fulfill the requirements of
- 12 subsection (2) by 1 or more of the following methods:
- 13 (a) Providing printed material enclosed with a mailed notice
- 14 for the issuance or renewal of an official state personal
- 15 identification card.
- 16 (b) Providing printed material to an applicant who personally
- 17 appears at a secretary of state branch office.
- 18 (c) Through electronic information transmittals for
- 19 applications processed by electronic means.
- 20 (4) —If— UNTIL JANUARY 1, 2007, IF an applicant indicates a
- 21 willingness under this section to have his or her name placed on
- 22 the $\frac{-\text{organ donor}}{\text{organ donor}}$ registry described in subsection (2)(a)(ii), the
- 23 secretary of state shall within 10 days forward the applicant's
- 24 name, -and address, AND DATE OF BIRTH to the organ donor registry
- 25 maintained by Michigan's federally designated organ procurement
- 26 organization or its successor organization. The secretary of state
- 27 may forward information under this subsection by mail or by

- 1 electronic means. The secretary of state shall not maintain a
- 2 record of the name or address of an individual who indicates a
- 3 willingness to have his or her name placed on the organ donor
- 4 registry after forwarding that information to the organ donor
- 5 registry under this subsection. Information about an applicant's
- 6 indication of a willingness to have his or her name placed on the
- 7 organ donor registry obtained by the secretary of state under
- 8 subsection (2) and forwarded under this subsection is exempt from
- 9 disclosure under -the freedom of information act, 1976 PA 442, MCL
- 10 15.231 to 15.246, pursuant to section 13(1)(d) of the freedom of
- 11 information act, 1976 PA 442, MCL 15.243.
- 12 (5) The secretary of state shall prescribe the form of the
- 13 identification card. The secretary of state shall designate on the
- 14 identification card a space where the applicant may place a sticker
- 15 or decal of the uniform size as the secretary may specify to
- 16 indicate that the cardholder carries a separate emergency medical
- 17 information card. The sticker or decal may be provided by any
- 18 person, hospital, school, medical group, or association interested
- 19 in assisting in implementing the emergency medical information
- 20 card, but shall meet the specifications of the secretary of state.
- 21 The sticker or decal also may be used to indicate that the
- 22 cardholder has designated 1 or more patient advocates in accordance
- 23 with section 5506 of the estates and protected individuals code,
- 24 1998 PA 386, MCL 700.5506. The emergency medical information card,
- 25 carried separately by the cardholder, may contain the information
- 26 described in subsection (2)(c), information concerning the
- 27 cardholder's patient advocate designation, other emergency medical

- 1 information, or an indication as to where the cardholder has stored
- 2 or registered emergency medical information. Beginning on and
- 3 after July 1, 2003, an AN original identification card or the
- 4 renewal of an existing identification card issued to a person less
- 5 than 21 years of age shall be portrait or vertical in form and an
- 6 identification card issued to a person 21 years of age or over
- 7 shall be landscape or horizontal in form. Except as otherwise
- 8 required in this act, other information required on the
- 9 identification card pursuant to **UNDER** this act may appear on the
- 10 identification card in a form prescribed by the secretary of state.
- 11 (6) The identification card shall not contain a fingerprint or
- 12 finger image of the applicant.
- 13 (7) Except as provided in this subsection, the secretary of
- 14 state may retain and use a person's image and signature described
- 15 in subsection (1)(b) only for programs administered by the
- 16 secretary of state. Except as provided in this subsection, the
- 17 secretary of state shall not use a person's image unless written
- 18 permission for that purpose is granted by the person to the
- 19 secretary of state or specific enabling legislation permitting the
- 20 use is enacted into law. A law enforcement agency of this state
- 21 shall have access to any information retained by the secretary of
- 22 state under this subsection. The information may be utilized for
- 23 any law enforcement purpose unless otherwise prohibited by law. The
- 24 department of state police shall provide to the secretary of state
- 25 updated lists of persons required under section 5a of the sex
- 26 offenders registration act, 1994 PA 295, MCL 28.725a, to maintain a
- 27 valid operator's or chauffeur's license or an official state

- 1 personal identification card and the secretary of state shall make
- 2 images of those persons available to the department of state police
- 3 as provided in the sex offenders registration act, 1994 PA 295, MCL
- 4 28.721 to 28.732.
- 5 (8) If a person presents evidence of statutory blindness as
- 6 provided in 1978 PA 260, MCL 393.351 to 393.368, and is issued or
- 7 is the holder of an official state personal identification card,
- 8 the secretary of state shall mark the person's identification card
- 9 in a manner that clearly indicates that the cardholder is legally
- 10 blind.
- 11 (9) Until July 1, 2003, if the secretary of state issues an
- 12 official state personal identification card to a person who at the
- 13 time of application is 20-1/2 years of age or less, the secretary
- 14 of state shall mark the person's identification card in a manner
- 15 that clearly indicates that the cardholder is less than 21 years of
- 16 age. BEGINNING JANUARY 1, 2007, THE SECRETARY OF STATE SHALL
- 17 MAINTAIN A RECORD OF AN INDIVIDUAL WHO INDICATES A WILLINGNESS TO
- 18 HAVE HIS OR HER NAME PLACED ON THE REGISTRY DESCRIBED IN SUBSECTION
- 19 (2)(A)(ii). INFORMATION ABOUT A PERSON'S INDICATION OF A WILLINGNESS
- 20 TO HAVE HIS OR HER NAME PLACED ON THE REGISTRY THAT IS OBTAINED BY
- 21 THE SECRETARY OF STATE AND FORWARDED UNDER THIS SECTION IS EXEMPT
- 22 FROM DISCLOSURE UNDER SECTION 13(1)(D) OF THE FREEDOM OF
- 23 INFORMATION ACT, 1976 PA 442, MCL 15.243. THE SECRETARY OF STATE
- 24 SHALL ESTABLISH AND MAINTAIN THE ORGAN, TISSUE, AND EYE DONOR
- 25 REGISTRY IN A MANNER THAT PROVIDES ELECTRONIC ACCESS, INCLUDING,
- 26 BUT NOT LIMITED TO, THE TRANSFER OF DATA TO THIS STATE'S FEDERALLY
- 27 DESIGNATED ORGAN PROCUREMENT ORGANIZATIONS, THEIR SUCCESSOR

- 1 ORGANIZATIONS, AND TISSUE AND EYE BANKS WITH LIMITATIONS ON THE USE
- 2 OF AND ACCESS TO THE DONOR REGISTRY AS DETERMINED BY THE SECRETARY
- 3 OF STATE.
- 4 (10) An official state personal identification card may
- 5 contain an identifier for voter registration purposes. An official
- 6 state personal identification card may contain information
- 7 appearing in electronic or machine readable codes needed to conduct
- 8 a transaction with the secretary of state. The information shall be
- 9 limited to the person's identification card number, birth date,
- 10 expiration date, and other information necessary for use with
- 11 electronic devices, machine readers, or automatic teller machines
- 12 and shall not contain the person's name, address, driving record,
- 13 or other personal identifier. The identification card shall
- 14 identify the encoded information.
- 15 (11) An official state personal identification card shall be
- 16 issued only upon authorization of the secretary of state, and shall
- 17 be manufactured in a manner to prohibit as nearly as possible the
- 18 ability to reproduce, alter, counterfeit, forge, or duplicate the
- 19 identification card without ready detection.
- 20 (12) Except as otherwise provided in this act, an applicant
- 21 shall pay a fee of \$10.00 to the secretary of state for each
- 22 original or renewal identification card issued.
- 23 The department of treasury shall deposit the fees received and
- 24 collected under this section in the state treasury to the credit of
- 25 the general fund. The legislature shall appropriate the fees
- 26 credited to the general fund under this act to the secretary of
- 27 state for the administration of this act. Appropriations from the

- 1 Michigan transportation fund CREATED UNDER SECTION 10 OF 1951 PA
- 2 51, MCL 247.660, shall not be used to compensate the secretary of
- 3 state for costs incurred and services performed under this section.
- 4 (13) An original or renewal official state personal
- 5 identification card -shall expire EXPIRES on the birthday of the
- 6 person to whom it is issued in the fourth year following the date
- 7 of issuance. The secretary of state shall not issue an official
- 8 state personal identification card under this act for a period
- 9 greater than 4 years. Except as provided in this subsection, a
- 10 person may apply for a renewal of an official state personal
- 11 identification card by mail or by other methods prescribed by the
- 12 secretary of state. The secretary of state shall require renewal in
- 13 person by a person required under section 5a of the sex offenders
- 14 registration act, 1994 PA 295, MCL 28.725a, to maintain a valid
- 15 operator's or chauffeur's license or official state personal
- 16 identification card.
- 17 (14) The secretary of state shall waive the fee under this
- 18 section if the applicant is $\frac{}{}$ ANY OF THE FOLLOWING:
- 19 (A) A person 65 years of age or older. —, is a
- 20 (B) A person who has had his or her operator's or chauffeur's
- 21 license suspended, revoked, or denied under the Michigan vehicle
- 22 code, 1949 PA 300, MCL 257.1 to 257.923, because of a mental or
- 23 physical infirmity or disability. —, is a
- 24 (C) A person who presents evidence of statutory blindness as
- 25 provided in 1978 PA 260, MCL 393.351 to 393.368. —, or is a
- **26 (D)** A person who presents other good cause for a fee waiver.
- 27 (E) BEGINNING JANUARY 1, 2007, A PERSON WHO WISHES TO ADD OR

- 1 REMOVE A HEART INSIGNIA DESCRIBED IN SUBSECTION (1)(F).
- 2 (15) A person who has been issued an official state personal
- 3 identification card shall apply for a renewal official state
- 4 personal identification card if the person changes his or her name.
- 5 (16) A person who has been issued an official state personal
- 6 identification card shall apply for a corrected identification card
- 7 if he or she changes his or her residential address. The secretary
- 8 of state may correct the address on an identification card by a
- 9 method prescribed by the secretary of state. A fee shall not be
- 10 charged for a change of residential address.
- 11 (17) Except as otherwise provided in subsections (15) and
- 12 (16), a person who has been issued an official state personal
- 13 identification card may apply for a renewal official state personal
- 14 identification card for 1 or more of the following reasons:
- 15 (a) The person wants to change any information on the
- 16 identification card.
- 17 (b) An identification card issued under this act is lost,
- 18 destroyed, or mutilated, or becomes illegible.
- 19 (18) A person may indicate on an official state personal
- 20 identification card in a place designated by the secretary of state
- 21 his or her blood type, emergency contact information, immunization
- 22 data, medication data, a statement that the person is deaf, or,
- 23 UNTIL JANUARY 1, 2007, a statement that the person has made an
- 24 anatomical gift pursuant to UNDER part 101 of the public health
- 25 code, 1978 PA 368, MCL 333.10101 to 333.10109.
- 26 (19) If an applicant provides proof to the secretary of state
- 27 that he or she is a minor who has been emancipated -pursuant to

- 1 UNDER 1968 PA 293, MCL 722.1 to 722.6, the official state personal
- 2 identification card shall bear the designation of the individual's
- 3 emancipated status in a manner prescribed by the secretary of
- 4 state.
- 5 (20) BEGINNING JANUARY 1, 2007, THE SECRETARY OF STATE SHALL
- 6 INQUIRE OF EACH PERSON WHO APPLIES FOR OR WHO HOLDS AN OFFICIAL
- 7 STATE PERSONAL IDENTIFICATION CARD, IN PERSON OR BY MAIL, WHETHER
- 8 HE OR SHE AGREES TO PARTICIPATE IN THE ORGAN, TISSUE, AND EYE DONOR
- 9 REGISTRY UNDER PART 101 OF THE PUBLIC HEALTH CODE, 1978 PA 368, MCL
- 10 333.10101 TO 333.10109. A PERSON WHO HAS AGREED TO PARTICIPATE IN
- 11 THAT REGISTRY SHALL NOT BE CONSIDERED TO HAVE REVOKED THAT
- 12 AGREEMENT SOLELY BECAUSE THE PERSON'S OFFICIAL STATE PERSONAL
- 13 IDENTIFICATION CARD HAS EXPIRED. ENROLLMENT IN THE ORGAN, TISSUE,
- 14 AND EYE DONOR REGISTRY CONSTITUTES A LEGAL AGREEMENT THAT REMAINS
- 15 BINDING AND IN EFFECT AFTER THE DONOR'S DEATH REGARDLESS OF THE
- 16 EXPRESSED DESIRES OF THE DECEASED DONOR'S NEXT OF KIN WHO MAY
- 17 OPPOSE THE DONOR'S ORGAN, TISSUE, OR EYE DONATION.
- 18 (21) -(20)— A valid official state personal identification
- 19 card presented by the person to whom the card is issued shall be
- 20 considered the same as a valid state of Michigan driver license
- 21 when identification is requested except as otherwise specifically
- 22 provided by law.
- 23 Enacting section 1. This amendatory act does not take effect
