HOUSE SUBSTITUTE FOR SENATE BILL NO. 351

A bill to amend 1978 PA 368, entitled "Public health code,"

by amending sections 16131 and 16263 (MCL 333.16131 and 333.16263), as amended by 2004 PA 97, and by adding section 16322 and part 165.

- 14 MEMBERS WHO MEET THE REQUIREMENTS OF PART 161:
- 15 (A) FOUR ACUPUNCTURISTS. THE MEMBERS INITIALLY APPOINTED
- 16 UNDER THIS SUBDIVISION SHALL MEET THE REQUIREMENTS OF SECTION

- 5 THIRD PARTY REIMBURSEMENT OR MANDATED WORKER'S COMPENSATION
- 6 BENEFITS FOR SERVICES BY AN INDIVIDUAL REGISTERED AS AN
- 7 ACUPUNCTURIST UNDER THIS PART.
