## SUBSTITUTE FOR SENATE BILL NO. 664

A bill to amend 1972 PA 284, entitled "Business corporation act,"

by amending section 131 (MCL 450.1131), as amended by 2001 PA 57.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 131. (1) A document required or permitted to be filed
- 2 under this act shall be <del>filed</del> **SUBMITTED** by delivering the
- 3 document to the administrator together with the fees and
- 4 accompanying documents required by law. The administrator may
- 5 establish a procedure for accepting delivery OF A DOCUMENT
- 6 SUBMITTED UNDER THIS SUBSECTION by facsimile or other electronic
- 7 transmission. HOWEVER, BY DECEMBER 31, 2006, THE ADMINISTRATOR
- 8 SHALL ESTABLISH A PROCEDURE FOR ACCEPTING DELIVERY OF A DOCUMENT
- 9 SUBMITTED UNDER THIS SUBSECTION BY ELECTRONIC MAIL OR OVER THE

- 1 INTERNET. BEGINNING JANUARY 1, 2007, THE ADMINISTRATOR SHALL ACCEPT
- 2 DELIVERY OF DOCUMENTS SUBMITTED BY ELECTRONIC MAIL OR OVER THE
- 3 INTERNET.
- 4 (2) If -the- A document SUBMITTED UNDER SUBSECTION (1)
- 5 substantially conforms to the requirements of this act, the
- 6 administrator shall endorse upon it the word "filed" with his or
- 7 her official title and the date of receipt and of filing and shall
- 8 file and index the document or a photostatic, micrographic,
- 9 photographic, optical disc media, or other reproduced copy in his
- 10 or her office. If -so- requested at the time of the delivery of the
- 11 document to his or her office, the administrator shall include the
- 12 hour of filing in his or her THE endorsement ON THE DOCUMENT.
- 13 (3) The administrator shall <del>prepare and</del> return a <del>true</del> copy
- 14 of the A document FILED UNDER SUBSECTION (2), other than an

- 19 MAIL OR OVER THE INTERNET, MAY PROVIDE PROOF OF THE FILING DATE TO
- 20 THE PERSON WHO SUBMITTED THE DOCUMENT FOR FILING IN ANOTHER MANNER
- 21 DETERMINED BY THE ADMINISTRATOR.
- 22 (4) The records and files of the administrator relating to
- 23 domestic and foreign corporations shall be open to reasonable
- 24 inspection by the public. The records or files, at the discretion
- 25 of the administrator -, may be maintained MAY MAINTAIN RECORDS OR
- 26 FILES either in their original form or in photostatic,
- 27 micrographic, photographic, optical disc media, or other reproduced

- 17 NONREFUNDABLE FEES IF EXPEDITED FILING OF A DOCUMENT BY THE
- 18 ADMINISTRATOR IS REQUESTED AND THE ADMINISTRATOR SHALL RETAIN THE
- 19 REVENUE COLLECTED UNDER THIS SUBSECTION AND THE DEPARTMENT SHALL
- 20 USE IT TO CARRY OUT ITS DUTIES REQUIRED BY LAW:
- 21 (A) FOR ANY FILING THAT A PERSON REQUESTS THE ADMINISTRATOR TO
- 22 COMPLETE WITHIN 1 HOUR ON THE SAME DAY AS THE DAY OF THE REQUEST,
- 23 \$1,000.00. THE DEPARTMENT MAY ESTABLISH A DEADLINE BY WHICH A
- 24 PERSON MUST SUBMIT A REQUEST FOR FILING UNDER THIS SUBDIVISION.
- 25 (B) FOR ANY FILING THAT A PERSON REQUESTS THE ADMINISTRATOR TO
- 26 COMPLETE WITHIN 2 HOURS ON THE SAME DAY AS THE DAY OF THE REQUEST,
- 27 \$500.00. THE DEPARTMENT MAY ESTABLISH A DEADLINE BY WHICH A PERSON

- MUST SUBMIT A REQUEST FOR FILING UNDER THIS SUBDIVISION. 1
- 2 (C) EXCEPT FOR A FILING REQUEST UNDER SUBDIVISION (A) OR (B),
- 3 FOR THE FILING OF ANY FORMATION OR QUALIFICATION DOCUMENT THAT A
- 4 PERSON REQUESTS THE ADMINISTRATOR TO COMPLETE ON THE SAME DAY AS
- 5 THE DAY OF THE REQUEST, \$100.00. THE DEPARTMENT MAY ESTABLISH A
- 6 DEADLINE BY WHICH A PERSON MUST SUBMIT A REQUEST FOR FILING UNDER
- 7 THIS SUBDIVISION.
- (D) EXCEPT FOR A FILING REQUEST UNDER SUBDIVISION (A) OR (B), 8
- FOR THE FILING OF ANY OTHER DOCUMENT CONCERNING AN EXISTING 9
- 10 DOMESTIC CORPORATION OR A QUALIFIED FOREIGN CORPORATION THAT A
- 11 PERSON REQUESTS THE ADMINISTRATOR TO COMPLETE ON THE SAME DAY AS
- 12 THE DAY OF THE REQUEST, \$200.00. THE DEPARTMENT MAY ESTABLISH A
- 13 DEADLINE BY WHICH A PERSON MUST SUBMIT A REQUEST FOR FILING UNDER
- 14 THIS SUBDIVISION.
- 15 (E) FOR THE FILING OF ANY FORMATION OR QUALIFICATION DOCUMENT
- 16 THAT A PERSON REQUESTS THE ADMINISTRATOR TO COMPLETE WITHIN 24
- 17 HOURS OF THE TIME THE ADMINISTRATOR RECEIVES THE REQUEST, \$50.00.
- 18 (F) FOR THE FILING OF ANY OTHER DOCUMENT CONCERNING AN
- 19 EXISTING DOMESTIC CORPORATION OR A QUALIFIED FOREIGN CORPORATION
- 20 THAT A PERSON REQUESTS THE ADMINISTRATOR TO COMPLETE WITHIN 24
- 21 HOURS OF THE TIME THE ADMINISTRATOR RECEIVES THE REQUEST, \$100.00.
- 22 Enacting section 1. This amendatory act takes effect January
- 23 1, 2006.
- 24 Enacting section 2. This amendatory act does not take effect
- 25 unless Senate Bill No. 298 of the 93rd Legislature is enacted into
- 26 law.
