HOUSE SUBSTITUTE FOR SENATE BILL NO. 686

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 552c.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 552C. (1) A PERSON SHALL NOT INTENTIONALLY AND WITHOUT
- 2 AUTHORITY OR PERMISSION ENTER OR REMAIN IN OR UPON PREMISES OR A
- 3 STRUCTURE BELONGING TO ANOTHER PERSON THAT IS A KEY FACILITY IF THE
- 4 KEY FACILITY IS COMPLETELY ENCLOSED BY A PHYSICAL BARRIER OF ANY
- 5 KIND, INCLUDING, BUT NOT LIMITED TO, A SIGNIFICANT WATER BARRIER
- 6 THAT PREVENTS PEDESTRIAN ACCESS, AND IS POSTED WITH SIGNAGE AS
- 7 PRESCRIBED UNDER SUBSECTION (2). AS USED IN THIS SUBSECTION, "KEY
- 8 FACILITY" MEANS 1 OR MORE OF THE FOLLOWING:
- 9 (A) A CHEMICAL MANUFACTURING FACILITY.
- 10 (B) A REFINERY.

- 1 (C) AN ELECTRIC UTILITY FACILITY, INCLUDING, BUT NOT LIMITED
- 2 TO, A POWER PLANT, A POWER GENERATION FACILITY PEAKER, AN ELECTRIC
- 3 TRANSMISSION FACILITY, AN ELECTRIC STATION OR SUBSTATION, OR ANY
- 4 OTHER FACILITY USED TO SUPPORT THE GENERATION, TRANSMISSION, OR
- 5 DISTRIBUTION OF ELECTRICITY. ELECTRIC UTILITY FACILITY DOES NOT
- 6 INCLUDE ELECTRIC TRANSMISSION LAND OR RIGHT-OF-WAY THAT IS NOT
- 7 COMPLETELY ENCLOSED, POSTED, AND MAINTAINED BY THE ELECTRIC
- 8 UTILITY.
- 9 (D) A WATER INTAKE STRUCTURE OR WATER TREATMENT FACILITY.
- 10 (E) A NATURAL GAS UTILITY FACILITY, INCLUDING, BUT NOT LIMITED
- 11 TO, AN AGE STATION, COMPRESSOR STATION, ORDERIZATION FACILITY, MAIN
- 12 LINE VALVE, NATURAL GAS STORAGE FACILITY, OR ANY OTHER FACILITY
- 13 USED TO SUPPORT THE ACQUISITION, TRANSMISSION, DISTRIBUTION, OR
- 14 STORAGE OF NATURAL GAS. NATURAL GAS UTILITY FACILITY DOES NOT
- 15 INCLUDE GAS TRANSMISSION PIPELINE PROPERTY THAT IS NOT COMPLETELY
- 16 ENCLOSED, POSTED, AND MAINTAINED BY THE NATURAL GAS UTILITY.
- 17 (F) GASOLINE, PROPANE, LIQUID NATURAL GAS (LNG), OR OTHER FUEL
- 18 TERMINAL OR STORAGE FACILITY.
- 19 (G) A TRANSPORTATION FACILITY, INCLUDING, BUT NOT LIMITED TO,
- 20 A PORT, RAILROAD SWITCHING YARD, OR TRUCKING TERMINAL.
- 21 (H) A PULP OR PAPER MANUFACTURING FACILITY.
- 22 (I) A PHARMACEUTICAL MANUFACTURING FACILITY.
- 23 (J) A HAZARDOUS WASTE STORAGE, TREATMENT, OR DISPOSAL
- 24 FACILITY.
- 25 (K) A TELECOMMUNICATION FACILITY, INCLUDING, BUT NOT LIMITED
- 26 TO, A CENTRAL OFFICE OR CELLULAR TELEPHONE TOWER SITE.
- 27 (1) A FACILITY SUBSTANTIALLY SIMILAR TO A FACILITY, STRUCTURE,

- OR STATION LISTED IN SUBDIVISIONS (A) TO (K) OR A RESOURCE REQUIRED 1
- 2 TO SUBMIT A RISK MANAGEMENT PLAN UNDER 42 USC 7412(R).
- 3 (2) A KEY FACILITY SHALL BE POSTED IN A CONSPICUOUS MANNER
- 4 AGAINST ENTRY. THE MINIMUM LETTER HEIGHT ON THE POSTING SIGNS SHALL
- 5 BE 1 INCH. EACH POSTING SIGN SHALL BE NOT LESS THAN 50 SQUARE
- INCHES, AND THE SIGNS SHALL BE SPACED TO ENABLE A PERSON TO OBSERVE 6
- NOT LESS THAN 1 SIGN AT ANY POINT OF ENTRY UPON THE PROPERTY. 7
- (3) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A FELONY 8
- 9 PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 4 YEARS OR A FINE OF
- 10 NOT MORE THAN \$2,500.00, OR BOTH.
- (4) THIS SECTION DOES NOT PROHIBIT AND SHALL BE NOT CONSTRUED 11
- 12 TO PREVENT LAWFUL ASSEMBLY OR A PEACEFUL AND ORDERLY PETITION FOR
- THE REDRESS OF GRIEVANCES, INCLUDING, BUT NOT LIMITED TO, A LABOR 13
- DISPUTE BETWEEN AN EMPLOYER AND ITS EMPLOYEES. 14
- 15 Enacting section 1. This amendatory act takes effect April 15,
- 16 2006.
