## HOUSE SUBSTITUTE FOR SENATE BILL NO. 727

A bill to create certain centers in the Michigan strategic fund; to impose certain duties and responsibilities on those centers and on certain state employees and public employees; and to repeal acts and parts of acts.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. As used in this act:
- 2 (a) "Center" or "defense contract coordination center" means
- 3 the defense contract coordination center created in section 2.
- 4 (b) "Michigan strategic fund" means the Michigan strategic
- 5 fund created under the Michigan strategic fund act, 1984 PA 270,
- 6 MCL 125.2001 to 125.2094.
- 7 (c) "Municipality" means a township, village, city, or county.

1 (d) "Small business" means a business with less than 400

- 2 employees.
- 3 Sec. 2. (1) The defense contract coordination center is
- 4 created in the Michigan strategic fund. The board of the Michigan
- 5 strategic fund may delegate those functions and authority that the
- 6 board considers necessary or appropriate as provided in section 5
- 7 of the Michigan strategic fund act, 1984 PA 270, MCL 125.2005.
- 8 (2) The center shall do all of the following:
- 9 (a) Focus solely on job creation and job retention from
- 10 business opportunities associated with the procurement technical
- 11 assistance center for homeland security and defense contracts and
- 12 contracts related to homeland security and defense.
- 13 (b) Coordinate with procurement technical assistance centers
- 14 in this state to maximize homeland security and defense business
- 15 opportunities for small businesses and small business innovation
- 16 research programs located in this state.
- 17 (c) Give priority to bring homeland security and defense
- 18 business opportunities to municipalities hardest hit by
- 19 manufacturing layoffs.
- 20 (d) Set a performance objective of increasing defense and
- 21 homeland security contracts awarded to businesses located in this
- 22 state by 25% by the time this act is repealed.
- 23 (e) Provide resources needed to meet the performance objective
- 24 described in subdivision (d) within 1 year of the date this act is
- 25 enacted.
- 26 (f) Coordinate center efforts with programs funded with
- 27 proceeds from the 21st century jobs trust fund under the Michigan

- 1 trust fund act, 2000 PA 489, MCL 12.251 to 12.260, and other
- 2 initiatives that are targeted toward commercialization activities
- 3 related to homeland security and defense research and development
- 4 in higher education institutions, research centers, and other
- 5 businesses working in the homeland security and defense arena.
- **6** (g) Coordinate with businesses and nonprofit organizations
- 7 located in this state for the purposes of maximizing homeland
- 8 security and defense business opportunities.
- 9 (3) The center shall hire an executive director and a support
- 10 person to operate the center. Additional staff may be hired once a
- 11 business plan has been developed and approved by the board of the
- 12 Michigan strategic fund. The development plan shall include the
- 13 percentage of funds used for grants, loans, and operating expenses.
- 14 (4) The defense contract coordination center may exercise
- 15 those powers, privileges, and authorities that the Michigan
- 16 strategic fund and local public agencies share in common and that
- 17 each might exercise separately. The shared power, privilege, or
- 18 authority shall be exercised by a public body corporate created
- 19 under section 28 of article VII of the state constitution of 1963
- 20 and the urban cooperation act of 1967, 1967 (Ex Sess) Pa 7, MCL
- 21 124.501 to 124.512, by a contractual interlocal agreement effective
- 22 April 5, 1999 between local participating economic development
- 23 corporations formed under the economic development corporations
- 24 act, 1974 PA 338, MCL 125.1601 to 125.1636, and the Michigan
- 25 strategic fund.
- 26 (5) The center shall not use any state funds to construct or
- 27 renovate a building for its own use.

- 1 Enacting section 1. This act is repealed effective 5 years
- 2 after the date it is enacted into law.
