HOUSE SUBSTITUTE FOR SENATE BILL NO. 892

(As amended December 8, 2005)

[A bill to amend 1939 PA 280, entitled "The social welfare act," by amending section 57f (MCL 400.57f), as amended by 2001 PA 280, and by adding sections 57s, 57t, 57u, and 57v.]

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 57f. (1) The <u>family independence agency</u> **DEPARTMENT**
- 2 shall enter into an agreement with the department of -career
- 3 development LABOR AND ECONOMIC GROWTH in order to facilitate the
- 4 administration of work first. The family independence agency shall
- 5 make information on the program available to the legislature. THE
- 6 DEPARTMENT SHALL TRACK ALL FAMILY INDEPENDENCE PROGRAM RECIPIENTS
- 7 BY SOCIAL SECURITY NUMBER SO THAT TRACKING INFORMATION IS TRACEABLE
- 8 FOR A RECIPIENT'S LIFETIME. THE DEPARTMENT OF LABOR AND ECONOMIC
- 9 GROWTH SHALL TRACK WORK FIRST PARTICIPANTS BY SOCIAL SECURITY

- 1 NUMBER AND THE RECIPIENT'S JOB STATUS FOR A PERIOD OF NOT LESS THAN
- 2 1 YEAR AFTER JOB PLACEMENT. THIS INFORMATION SHALL BE SHARED
- 3 BETWEEN THE DEPARTMENT AND THE DEPARTMENT OF LABOR AND ECONOMIC
- 4 GROWTH. INFORMATION TRACKED UNDER THIS SUBSECTION SHALL BE PROVIDED
- 5 TO THE LEGISLATURE, STANDING COMMITTEES, AND APPROPRIATIONS
- 6 COMMITTEES DURING THE ANNUAL BUDGET REVIEW. AT THE TIME THE
- 7 DEPARTMENT OR THE DEPARTMENT OF LABOR AND ECONOMIC GROWTH OPENS A
- 8 CASE ON A RECIPIENT, THE DEPARTMENT AND THE DEPARTMENT OF LABOR AND
- 9 ECONOMIC GROWTH SHALL USE THE SAME CASE NUMBER PREVIOUSLY USED FOR
- 10 THE RECIPIENT AND SHALL NOT ASSIGN A NEW CASE NUMBER IF THE
- 11 RECIPIENT HAS PREVIOUSLY RECEIVED ASSISTANCE OR PARTICIPATED IN
- 12 WORK FIRST. THE DEPARTMENT AND THE DEPARTMENT OF LABOR AND ECONOMIC
- 13 GROWTH SHALL DEVELOP INDIVIDUAL PROGRAM GOALS AND MEASURABLE
- 14 PERFORMANCE INDICATORS TO BE REVIEWED FOR SUCCESS OR FAILURE
- 15 ANNUALLY. THE ANNUAL SUCCESS OR FAILURE RATES SHALL BE REPORTED TO
- 16 THE LEGISLATURE. ONE INDIVIDUAL PROGRAM GOAL DEVELOPED UNDER THIS
- 17 SUBSECTION SHALL BE A STATE GOAL FOR THE PERCENTAGE OF THE FAMILY
- 18 INDEPENDENCE PROGRAM CASELOAD INVOLVED IN EMPLOYMENT ACTIVITIES TO
- 19 BE DEVELOPED JOINTLY BY THE DEPARTMENT AND THE DEPARTMENT OF LABOR
- 20 AND ECONOMIC GROWTH. THE STATE GOAL FOR THE PERCENTAGE OF THE
- 21 FAMILY INDEPENDENCE PROGRAM CASELOAD INVOLVED IN EMPLOYMENT
- 22 ACTIVITIES DEVELOPED UNDER THIS SUBSECTION SHALL NOT BE LESS THAN
- 23 50% OF THE FAMILY INDEPENDENCE PROGRAM CASELOAD. ON A QUARTERLY
- 24 BASIS, THE DEPARTMENT SHALL REPORT TO THE APPROPRIATIONS
- 25 SUBCOMMITTEES ON THE DEPARTMENT OF HUMAN SERVICES IN THE SENATE AND
- 26 HOUSE, THE SENATE AND HOUSE FISCAL AGENCIES, AND THE SENATE AND
- 27 HOUSE POLICY STAFFS THE CURRENT PERCENTAGE OF THE FAMILY

- 1 INDEPENDENCE PROGRAM CASELOAD INVOLVED IN EMPLOYMENT ACTIVITIES. IF
- 2 THE FAMILY INDEPENDENCE PROGRAM CASELOAD PERCENTAGE IS BELOW THE
- 3 GOAL FOR MORE THAN 2 CONSECUTIVE QUARTERS, THE DEPARTMENT SHALL
- 4 DEVELOP A PLAN FOR INCREASING THE FAMILY INDEPENDENCE PROGRAM

- 17 contract FAMILY SELF-SUFFICIENCY PLAN. If a recipient has
- 18 cooperated with work first, the recipient may enroll in a program
- 19 approved by the local workforce development board. Any and all
- 20 training or education with the exception of high school completion
- 21 AN ENGLISH AS A SECOND LANGUAGE PROGRAM, A FAST TRACK LITERACY
- 22 PROGRAM, HIGH SCHOOL COMPLETION, and GED preparation must be
- 23 occupationally relevant and in demand in the labor market as
- 24 determined by the local workforce development board. and may be no
- 25 more than 2 years in duration. Participants must make satisfactory
- 26 progress while in training or education. IF A RECIPIENT DOES NOT
- 27 HAVE A HIGH SCHOOL DIPLOMA OR GED OR HAS READING PROFICIENCY AT THE

 - (C) THE NUMBER OF SANCTIONS IMPOSED FOR THIRD INSTANCES OF NONCOMPLIANCE.
 - (D) THE NUMBER OF FAMILY INDEPENDENCE PROGRAM CASES REOPENED.
