

HOUSE SUBSTITUTE FOR

SENATE BILL NO. 893

(As amended December 8, 2005)

A bill to amend 1939 PA 280, entitled
"The social welfare act,"
(MCL 400.1 to 400.119b) by adding sections 57q and 57r.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 57Q. ~~[(1)]~~ AFTER TERMINATION OF FAMILY INDEPENDENCE ASSISTANCE
2 BENEFITS FOR NONCOMPLIANCE, FAILURE TO MEET AN EXPECTATION LISTED
3 IN THE FAMILY INDEPENDENCE PLAN DESCRIBED IN SECTION 57G, OR
4 REACHING THE 48-MONTH LIFETIME CUMULATIVE TOTAL ALLOWABLE UNDER
5 SECTION 57G, THE DEPARTMENT SHALL PROVIDE INFORMATION TO THE
6 RECIPIENT ON OBTAINING FOOD ASSISTANCE, ASSISTANCE UNDER THE WOMEN,
7 INFANTS, AND CHILDREN PROGRAM, FREE AND REDUCED LUNCHES, EARNED
8 INCOME TAX CREDIT, AND ANY OTHER RELEVANT PROGRAM OR SERVICE THE
9 DEPARTMENT DETERMINES MAY ASSIST THE FAMILY.

~~[(2) IF A RECIPIENT IS TERMINATED FROM RECEIVING FAMILY
INDEPENDENCE ASSISTANCE BENEFITS DUE TO SANCTIONS RECEIVED UNDER SECTION
57G OR REACHING THE 48-MONTH CUMULATIVE LIFETIME LIMIT, THE DEPARTMENT
WORKER SHALL NOTIFY ANY LOCAL AGENCIES OR SERVICE ORGANIZATIONS OF FAMILY
NEED THAT CAN OFFER SERVICES OR OTHER ASSISTANCE IN RELATION TO THE
RECIPIENT'S CHILDREN.]~~

Senate Bill No. 893 (H-1) as amended December 8, 2005

- 1 SEC. 57R. IF A RECIPIENT RECEIVES A PENALTY UNDER THIS SECTION
2 RESULTING IN TERMINATION FROM THE FAMILY INDEPENDENCE PROGRAM FOR 3
3 CALENDAR MONTHS OR MORE, THE RECIPIENT SHALL ATTEND A JOINT MEETING
4 WITH A DEPARTMENT CASEWORKER AND A WORK FIRST PROGRAM CASEWORKER.
5 AT A MEETING UNDER THIS SECTION, THE FAMILY SELF-SUFFICIENCY PLAN
6 SHALL BE REVIEWED AND MODIFIED AS DETERMINED NECESSARY.
