SUBSTITUTE FOR SENATE BILL NO. 506

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 3101 (MCL 324.3101), as amended by 2004 PA 142, and by adding section 3109c.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 3101. As used in this part:
- 2 (a) "Aquatic nuisance species" means a nonindigenous species
- 3 that threatens the diversity or abundance of native species or the
- 4 ecological stability of infested waters, or commercial,
- 5 agricultural, aquacultural, or recreational activities dependent on
- 6 such waters.
- 7 (b) "Ballast water" means water and associated solids taken on
- 8 board a vessel to control or maintain trim, draft, stability, or
- 9 stresses on the vessel, without regard to the manner in which it is

- 2 (c) "Ballast water treatment method" means a method of
- 3 treating ballast water and sediments to remove or destroy living
- 4 biological organisms through 1 or more of the following:
- 5 (i) Filtration.
- 6 (ii) The application of biocides or ultraviolet light.
- 7 (iii) Thermal methods.
- (iv) Other treatment techniques approved by the department.
- 9 (d) "Department" means the department of environmental
- 10 quality.
- (e) "Detroit consumer price index" means the most
- 12 comprehensive index of consumer prices available for the Detroit
- 13 area from the United States department of labor, bureau of labor
- 14 statistics.
- 15 (f) "Emergency management coordinator" means that term as
- 16 defined in section 2 of the emergency management act, 1976 PA 390,
- **17** MCL 30.402.
- 18 (g) "Great Lakes" means the Great Lakes and their connecting
- 19 waters, including Lake St. Clair.
- 20 (h) "Group 1 facility" means a facility whose discharge is
- 21 described by R 323.2218 of the Michigan administrative code.
- 22 (i) "Group 2 facility" means a facility whose discharge is
- 23 described by R 323.2210(y), R 323.2215, or R 323.2216 of the
- 24 Michigan administrative code.
- 25 (j) "Group 3 facility" means a facility whose discharge is
- 26 described by R 323.2211 or R 323.2213 of the Michigan
- 27 administrative code.

- 1 (k) "Local health department" means that term as defined in
- 2 section 1105 of the public health code, 1978 PA 368, MCL 333.1105.
- 3 (l) "Local unit" means a county, city, village, or township or
- 4 an agency or instrumentality of any of these entities.
- 5 (m) "Municipality" means this state, a county, city, village,
- 6 or township, or an agency or instrumentality of any of these
- 7 entities.
- 8 (n) "National response center" means the national
- 9 communications center established under the clean water act, 33 USC
- 10 1251 to 1387, located in Washington, DC, that receives and relays
- 11 notice of oil discharge or releases of hazardous substances to
- 12 appropriate federal officials.
- 13 (o) "Nonoceangoing vessel" means a vessel that is not an
- 14 oceangoing vessel.
- 15 (p) "Oceangoing vessel" means a vessel that operates on the
- 16 Great Lakes or the St. Lawrence waterway after operating in waters
- 17 outside of the Great Lakes or the St. Lawrence waterway.
- 18 (Q) "OPEN WATER DISPOSAL OF CONTAMINATED DREDGE MATERIALS"
- 19 MEANS THE PLACEMENT OF DREDGE MATERIALS CONTAMINATED WITH TOXIC
- 20 SUBSTANCES AS DEFINED IN R 323.1205 OF THE MICHIGAN ADMINISTRATIVE
- 21 CODE INTO THE OPEN WATERS OF THE WATERS OF THE STATE BUT DOES NOT
- 22 INCLUDE THE SITING OR USE OF A CONFINED DISPOSAL FACILITY
- 23 DESIGNATED BY THE UNITED STATES ARMY CORPS OF ENGINEERS OR BEACH
- 24 NOURISHMENT ACTIVITIES UTILIZING UNCONTAMINATED MATERIALS.
- 25 (R) -(g) "Primary public safety answering point" means that
- 26 term as defined in section 102 of the emergency telephone service
- 27 enabling act, 1986 PA 32, MCL 484.1102.

- 1 (S) $\frac{(r)}{(r)}$ "Sediments" means any matter settled out of ballast
- 2 water within a vessel.
- 3 (T) -(s) "Sewage sludge" means sewage sludge generated in
- 4 the treatment of domestic sewage, other than only septage or
- 5 industrial waste.
- 6 (U) -(t) "Sewage sludge derivative" means a product for land
- 7 application derived from sewage sludge that does not include solid
- 8 waste or other waste regulated under this act.
- 9 (V) $\frac{(u)}{(u)}$ "Sewage sludge generator" means a person who
- 10 generates sewage sludge that is applied to land.
- 11 (W) -(v) "Sewage sludge distributor" means a person who
- 12 applies, markets, or distributes, except at retail, a sewage sludge
- 13 derivative.
- 14 (X) $\frac{(w)}{(w)}$ "St. Lawrence waterway" means the St. Lawrence
- 15 river, the St. Lawrence seaway, and the gulf of St. Lawrence.
- 16 (Y) $\frac{(x)}{(x)}$ "Threshold reporting quantity" means that term as
- 17 defined in R 324.2002 of the Michigan administrative code.
- 18 (Z) -(y) "Waters of the state" means groundwaters, lakes,
- 19 rivers, and streams and all other watercourses and waters,
- 20 including the Great Lakes, within the jurisdiction of this state.
- 21 SEC. 3109C. NOTWITHSTANDING ANY OTHER PROVISION OF THIS PART
- 22 OR THE RULES PROMULGATED UNDER THIS PART, THE OPEN WATER DISPOSAL
- 23 OF CONTAMINATED DREDGE MATERIALS IS PROHIBITED.
