A bill to amend 1982 PA 162, entitled "Nonprofit corporation act,"

by amending section 131 (MCL 450.2131), as amended by 1992 PA 198.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 131. (1) A document required or permitted to be filed
- 2 under this act shall be filed **SUBMITTED** by delivering the
- 3 document to the administrator together with the fees and
- 4 accompanying documents required by law. THE ADMINISTRATOR MAY
- 5 ESTABLISH A PROCEDURE FOR ACCEPTING DELIVERY OF A DOCUMENT
- 6 SUBMITTED UNDER THIS SUBSECTION BY FACSIMILE OR OTHER ELECTRONIC
- 7 TRANSMISSION. HOWEVER, BY DECEMBER 31, 2006, THE ADMINISTRATOR
- 8 SHALL ESTABLISH A PROCEDURE FOR ACCEPTING DELIVERY OF A DOCUMENT
- 9 SUBMITTED UNDER THIS SUBSECTION BY ELECTRONIC MAIL OR OVER THE

- 1 INTERNET. BEGINNING JANUARY 1, 2007, THE ADMINISTRATOR SHALL ACCEPT
- 2 DELIVERY OF DOCUMENTS SUBMITTED BY ELECTRONIC MAIL OR OVER THE

- 4 (2) If -the- A document SUBMITTED UNDER SUBSECTION (1)
- 5 substantially conforms to the requirements of this act, the
- 6 administrator shall endorse upon it the word "filed" with the

- 9 the document pursuant to the records media act REPRODUCTION ACT,

- 23 (B) FOR ANY FILING THAT A PERSON REQUESTS THE ADMINISTRATOR TO
- 24 COMPLETE WITHIN 2 HOURS ON THE SAME DAY AS THE DAY OF THE REQUEST,
- 25 \$500.00. THE DEPARTMENT MAY ESTABLISH A DEADLINE BY WHICH A PERSON
- 26 MUST SUBMIT A REQUEST FOR FILING UNDER THIS SUBDIVISION.
- 27 (C) EXCEPT FOR A FILING REQUEST UNDER SUBDIVISION (A) OR (B),

- 1 FOR THE FILING OF ANY FORMATION OR QUALIFICATION DOCUMENT THAT A
- 2 PERSON REQUESTS THE ADMINISTRATOR TO COMPLETE ON THE SAME DAY AS
- 3 THE DAY OF THE REQUEST, \$100.00. THE DEPARTMENT MAY ESTABLISH A
- 4 DEADLINE BY WHICH A PERSON MUST SUBMIT A REQUEST FOR FILING UNDER
- 5 THIS SUBDIVISION.
- 6 (D) EXCEPT FOR A FILING REQUEST UNDER SUBDIVISION (A) OR (B),
- 7 FOR THE FILING OF ANY OTHER DOCUMENT CONCERNING AN EXISTING
- 8 DOMESTIC CORPORATION OR A QUALIFIED FOREIGN CORPORATION THAT A
- 9 PERSON REQUESTS THE ADMINISTRATOR TO COMPLETE ON THE SAME DAY AS
- 10 THE DAY OF THE REQUEST, \$200.00. THE DEPARTMENT MAY ESTABLISH A
- 11 DEADLINE BY WHICH A PERSON MUST SUBMIT A REQUEST FOR FILING UNDER
- 12 THIS SUBDIVISION.
- 13 (E) FOR THE FILING OF ANY FORMATION OR QUALIFICATION DOCUMENT
- 14 THAT A PERSON REQUESTS THE ADMINISTRATOR TO COMPLETE WITHIN 24
- 15 HOURS OF THE TIME THE ADMINISTRATOR RECEIVES THE REQUEST, \$50.00.
- 16 (F) FOR THE FILING OF ANY OTHER DOCUMENT CONCERNING AN
- 17 EXISTING DOMESTIC CORPORATION OR A QUALIFIED FOREIGN CORPORATION
- 18 THAT A PERSON REQUESTS THE ADMINISTRATOR TO COMPLETE WITHIN 24
- 19 HOURS OF THE TIME THE ADMINISTRATOR RECEIVES THE REQUEST, \$100.00.
- 20 Enacting section 1. This amendatory act takes effect January
- **21** 1, 2006.
- 22 Enacting section 2. This amendatory act does not take effect
- 23 unless Senate Bill No. 298 of the 93rd Legislature is enacted into
