SUBSTITUTE FOR SENATE BILL NO. 673

A bill to amend 1976 PA 451, entitled "The revised school code,"

(MCL 380.1 to 380.1852) by adding section 1536.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1536. (1) THE STATE BOARD SHALL DEVELOP A SCHOOL
- 2 ADMINISTRATOR'S CERTIFICATE THAT MAY BE ISSUED TO SCHOOL DISTRICT
- 3 AND INTERMEDIATE SCHOOL DISTRICT SUPERINTENDENTS, SCHOOL
- 4 PRINCIPALS, ASSISTANT PRINCIPALS, AND OTHER ADMINISTRATORS WHOSE
- 5 PRIMARY RESPONSIBILITY IS ADMINISTERING INSTRUCTIONAL PROGRAMS. AN
- 6 INDIVIDUAL IS NOT REQUIRED BY THIS SECTION TO HAVE A SCHOOL
- 7 ADMINISTRATOR'S CERTIFICATE UNDER THIS SECTION OR AN ENDORSEMENT
- 8 UNDER SUBSECTION (2) TO BE EMPLOYED AS A SCHOOL ADMINISTRATOR BY A
- 9 SCHOOL DISTRICT, PUBLIC SCHOOL ACADEMY, INTERMEDIATE SCHOOL

- 1 DISTRICT, OR NONPUBLIC SCHOOL.
- 2 (2) THE STATE BOARD ALSO MAY DEVELOP APPROPRIATE CERTIFICATE
- 3 ENDORSEMENTS FOR SCHOOL ADMINISTRATORS, BY ELEMENTARY, SECONDARY,
- 4 AND CENTRAL OFFICE LEVEL.
- 5 (3) THE STATE BOARD SHALL DEVELOP STANDARDS AND PROCEDURES TO
- 6 IMPLEMENT THIS SECTION. THE STANDARDS AND PROCEDURES SHALL ADDRESS
- 7 AT LEAST ALL OF THE FOLLOWING:
- 8 (A) THE EDUCATIONAL AND PROFESSIONAL EXPERIENCE REQUIREMENTS
- 9 FOR A CERTIFICATE OR ENDORSEMENT UNDER THIS SECTION.
- 10 (B) CONTINUING EDUCATION REQUIREMENTS FOR PERIODIC
- 11 RECERTIFICATION. THESE REQUIREMENTS SHALL BE CONSISTENT WITH THE
- 12 CONTINUING EDUCATION REQUIREMENTS UNDER SECTION 1246.
- 13 (C) PROCEDURES FOR APPLICATION FOR AND ISSUANCE OF
- 14 CERTIFICATES AND ENDORSEMENTS UNDER THIS SECTION.
- 15 (D) STANDARDS AND PROCEDURES FOR SUSPENSION AND REVOCATION OF
- 16 A CERTIFICATE. THESE STANDARDS AND PROCEDURES SHALL BE BASED ON THE
- 17 STANDARDS AND PROCEDURES FOR TAKING ACTION AGAINST A PERSON'S
- 18 TEACHING CERTIFICATE UNDER SECTION 1535A.
- 19 (4) THE DEPARTMENT SHALL CONSULT AND WORK WITH APPROPRIATE
- 20 PROFESSIONAL ORGANIZATIONS, PRIMARILY ORGANIZATIONS REPRESENTING
- 21 SUPERINTENDENTS AND BUILDING-LEVEL ADMINISTRATORS, IN DEVELOPING
- 22 THE STANDARDS REQUIRED UNDER THIS SECTION.
- 23 (5) THE DEPARTMENT MAY RECOGNIZE PERFORMANCE-BASED
- 24 PROFESSIONAL LEARNING PROGRAMS OFFERED BY APPROPRIATE STATE
- 25 PROFESSIONAL ASSOCIATIONS FOR THE PURPOSES OF ADDING 1 OR MORE
- 26 ENHANCEMENT OR SPECIALTY ENDORSEMENTS FOR A SCHOOL ADMINISTRATOR'S
- 27 CERTIFICATE. THESE PROGRAMS MUST BE APPROVED BY THE DEPARTMENT

- 1 BASED ON ALIGNMENT WITH STATE BOARD-APPROVED SCHOOL ADMINISTRATOR
- 2 PROGRAM PREPARATION STANDARDS.
- Enacting section 1. This amendatory act does not take effect 3
- unless Senate Bill No. 674 of the 93rd Legislature is enacted into 4
- 5 law.
