SUBSTITUTE FOR SENATE BILL NO. 686

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 552c.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 552C. (1) A PERSON SHALL NOT INTENTIONALLY AND WITHOUT
- 2 AUTHORITY OR PERMISSION ENTER OR REMAIN IN OR UPON PREMISES OR A
- 3 STRUCTURE BELONGING TO ANOTHER PERSON THAT IS A KEY FACILITY IF THE
- 4 KEY FACILITY IS COMPLETELY ENCLOSED BY A PHYSICAL BARRIER OF ANY
- 5 KIND, INCLUDING, BUT NOT LIMITED TO, A SIGNIFICANT WATER BARRIER
- 6 THAT PREVENTS PEDESTRIAN ACCESS, AND IS POSTED WITH SIGNAGE AS
- 7 PRESCRIBED UNDER SUBSECTION (2). AS USED IN THIS SUBSECTION, "KEY
- 8 FACILITY" MEANS 1 OR MORE OF THE FOLLOWING:
- 9 (A) A CHEMICAL MANUFACTURING FACILITY.

- 1 (B) A REFINERY.
- 2 (C) AN ELECTRICAL POWER GENERATION OR ELECTRICAL TRANSMISSION
- 3 OR DISTRIBUTION FACILITY.
- 4 (D) A WATER INTAKE STRUCTURE OR WATER TREATMENT FACILITY.
- 5 (E) A PIPELINE TRANSMISSION COMPRESSOR STATION.
- 6 (F) GASOLINE, PROPANE, LIQUID NATURAL GAS (LNG), OR OTHER FUEL
- 7 TERMINAL OR STORAGE FACILITY.
- 8 (G) A TRANSPORTATION FACILITY, INCLUDING, BUT NOT LIMITED TO,
- 9 A PORT, RAILROAD SWITCHING YARD, OR TRUCKING TERMINAL.
- 10 (H) A PULP OR PAPER MANUFACTURING FACILITY.
- 11 (I) A PHARMACEUTICAL MANUFACTURING FACILITY.
- 12 (J) A HAZARDOUS WASTE STORAGE, TREATMENT, OR DISPOSAL
- 13 FACILITY.
- 14 (K) A TELECOMMUNICATION FACILITY, INCLUDING, BUT NOT LIMITED
- 15 TO, A CENTRAL OFFICE OR CELLULAR TELEPHONE TOWER SITE.
- 16 (l) A FACILITY SUBSTANTIALLY SIMILAR TO A FACILITY, STRUCTURE,
- 17 OR STATION LISTED IN SUBDIVISIONS (A) TO (K) OR A RESOURCE REQUIRED
- 18 TO SUBMIT A RISK MANAGEMENT PLAN UNDER 42 USC 7412(R).
- 19 (2) A KEY FACILITY SHALL BE POSTED IN A CONSPICUOUS MANNER
- 20 AGAINST ENTRY. THE MINIMUM LETTER HEIGHT ON THE POSTING SIGNS SHALL
- 21 BE 1 INCH. EACH POSTING SIGN SHALL BE NOT LESS THAN 50 SQUARE
- 22 INCHES, AND THE SIGNS SHALL BE SPACED TO ENABLE A PERSON TO OBSERVE
- 23 NOT LESS THAN 1 SIGN AT ANY POINT OF ENTRY UPON THE PROPERTY.
- 24 (3) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A FELONY
- 25 PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 4 YEARS OR A FINE OF
- 26 NOT MORE THAN \$2,500.00, OR BOTH.
- 27 (4) THIS SECTION DOES NOT PROHIBIT AND SHALL BE NOT CONSTRUED

- TO PREVENT LAWFUL ASSEMBLY OR A PEACEFUL AND ORDERLY PETITION FOR 1
- 2 THE REDRESS OF GRIEVANCES, INCLUDING, BUT NOT LIMITED TO, A LABOR
- 3 DISPUTE BETWEEN AN EMPLOYER AND ITS EMPLOYEES.
