SENATE BILL NO. 861

A bill to amend 1999 PA 94, entitled "Michigan merit award scholarship act," by amending section 7 (MCL 390.1457), as amended by 2004 PA 595.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 7. (1) The Michigan merit award scholarship program is
- 2 established. The board shall administer the Michigan merit award
- 3 scholarship program.
- 4 (2) Subject to subsection (6) and section 7b(2) and (5), and
- 5 to adjustment under subsection (4), each student enrolled in grade
- 6 11 in or after the 1998-1999 school year and before the 2006-2007
- 7 school year who meets the **ELIGIBILITY** requirements of **THIS**
- 8 SUBSECTION AND section 7b(1) is eligible for the award of a
- 9 \$2,500.00 Michigan merit award scholarship if the student is
- 10 enrolled in an approved postsecondary educational institution in

- 1 this state or in a service academy. —, or SUBJECT TO SUBSECTION
- 2 (6) AND SECTION 7B(2) AND (5), AND TO ADJUSTMENT UNDER SUBSECTION
- 3 (4), EACH STUDENT ENROLLED IN GRADE 11 IN OR AFTER THE 1998-1999
- 4 SCHOOL YEAR WHO GRADUATED FROM HIGH SCHOOL BEFORE THE 2006-2007
- 5 SCHOOL YEAR AND WHO MEETS THE ELIGIBILITY REQUIREMENTS OF THIS
- 6 SUBSECTION AND SECTION 7B(1) IS ELIGIBLE FOR the award of a
- 7 \$1,000.00 Michigan merit award scholarship if the student is
- 8 enrolled in an approved postsecondary educational institution
- 9 outside this state other than a service academy. -, if the board
- 10 finds A STUDENT IS ELIGIBLE UNDER THIS SUBSECTION IF THE BOARD
- 11 FINDS that the student while in high school -has HAD taken the
- 12 high school assessment test in the subject areas of reading,
- 13 writing, mathematics, and science and -meets MET 1 of the
- 14 following:
- 15 (a) Has received RECEIVED qualifying results in each of the
- 16 subject areas of reading, writing, mathematics, and science.
- 17 (b) Did not receive qualifying results in 1 or 2 of the
- 18 subject areas of reading, writing, mathematics, and science, but
- 19 received an overall score in the top 25% of a nationally recognized
- 20 college admission examination.
- 21 (c) Did not receive qualifying results in 1 or 2 of the
- 22 subject areas of reading, writing, mathematics, and science, but
- 23 received a qualifying score or scores as determined by the board on
- 24 a nationally recognized job skills assessment test designated by
- 25 the board.
- 26 (3) Subject to subsection (6) and section 7b(5) and to
- 27 adjustment under subsection (4), each student enrolled in grade 11

- 1 in or after the 2006-2007 school year who meets the requirements of
- 2 section 7b(1) is eligible for the award of a \$2,500.00 Michigan
- 3 merit award scholarship if the student is enrolled in an approved
- 4 postsecondary educational institution in this state or in a service
- 5 academy, or the award of a \$1,000.00 Michigan merit award
- 6 scholarship if the student is enrolled in an approved postsecondary
- 7 educational institution outside this state other than a service
- 8 academy, if the board finds that the student while in high school
- 9 has HAD taken the Michigan merit examination and meets MET 1 of
- 10 the following:
- 11 (a) Has received RECEIVED qualifying results in each of the
- 12 subject area components of the Michigan merit examination.
- 13 (b) Did not receive qualifying results in each of the subject
- 14 area components of the Michigan merit examination, but received an
- 15 overall score in the top 25% of a nationally recognized college
- 16 admission examination.
- 17 (c) Did not receive qualifying results in each of the subject
- 18 area components of the Michigan merit examination, but received a
- 19 qualifying score or scores as determined by the board on a
- 20 nationally recognized job skills assessment test designated by the
- 21 board.
- 22 (4) In any fiscal year, the board may adjust the amount of a
- 23 Michigan merit award scholarship available to students eligible
- 24 under 1 or more of subsections (2), (3), and (5), based upon its
- 25 determination of available resources and amounts appropriated, but
- 26 the board shall not increase an amount by more than 5% in any
- 27 fiscal year. The board shall notify the governor, the speaker of

- 1 the house of representatives, and the majority leader of the senate
- 2 in writing at least 30 days before an adjustment under this
- 3 subsection.
- 4 (5) If a student who has previously received a \$1,000.00
- 5 Michigan merit award scholarship under this section as a student
- 6 enrolled in an approved postsecondary educational institution
- 7 outside of this state other than a service academy enrolls in an
- 8 approved postsecondary educational institution in this state and
- 9 meets the requirements of section 7b(1), and subject to adjustment
- 10 under subsection (4), the student is eligible for the award of an
- 11 additional \$1,500.00 Michigan merit award scholarship.
- 12 (6) If the United States department of education has not
- 13 approved the use of the Michigan merit examination for the purposes
- 14 of the federal no child left behind act of 2001, Public Law 107-
- 15 110, by December 31, 2006, all of the following apply:
- (a) Eligibility for a Michigan merit award scholarship under
- 17 this section shall be determined under subsection (2) until the
- 18 next calendar year that begins after that approval occurs.
- 19 (b) Eligibility for a Michigan merit award scholarship under
- 20 this section shall be determined under subsection (3) beginning in
- 21 the next calendar year that begins after that approval occurs.
