## SENATE BILL NO. 1371

A bill to amend 2002 PA 591, entitled "Michigan nursing scholarship act," by amending section 2 (MCL 390.1182).

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2. As used in this act:
- 2 (a) "Authority" means the Michigan higher education assistance
- 3 authority created by 1960 PA 77, MCL 390.951 to 390.961.
- 4 (b) "Eligible costs" means tuition and fees charged by an
- 5 eligible institution; related costs for room, board, books,
- 6 supplies, transportation, or day care; and other costs determined
- 7 by the authority.
- 8 (c) "Eligible employment" means -a EITHER OF THE FOLLOWING:
- 9 (i) TEACHING IN A NURSING PROGRAM.
- 10 ( $\ddot{u}$ ) A registered nurse or licensed practical nurse providing

- 1 full-time nursing care, or part-time nursing care if section 7
- 2 applies, in a ward, emergency department, emergency room, operating
- 3 room, or trauma center of a hospital licensed under article 17 of
- 4 the public health code, 1978 PA 368, MCL 333.20101 to 333.22260, in
- 5 a nursing home or hospice licensed under article 17 of the public
- 6 health code, 1978 PA 368, MCL 333.20101 to 333.22260, in a health
- 7 facility or agency licensed under article 17 of the public health
- 8 code, 1978 PA 368, MCL 333.20101 to 333.22260, that provides
- 9 nonemergency health care to patients without receiving compensation
- 10 for providing that nonemergency health care, or in a clinic or
- 11 other health care program operated by a local health department
- 12 that provides 1 or more required services under part 24 of the
- 13 public health code, 1978 PA 368, MCL 333.2401 to 333.2498, or as an
- 14 employee of a home health care agency providing home patient care.
- 15 (d) "Eligible institution" means a degree or certificate
- 16 granting public or independent nonprofit college or university,
- 17 junior college, or community college in this state.
- 18 (e) "Licensed practical nurse" means an individual licensed to
- 19 engage in the practice of nursing as a licensed practical nurse as
- 20 defined in section 17201 of the public health code, 1978 PA 368,
- **21** MCL 333.17201.
- 22 (f) "Nursing program" means -a EITHER OF THE FOLLOWING:
- 23 (i) A program for the training of individuals to become
- 24 registered nurses or licensed practical nurses operated in this
- 25 state by an eligible institution and approved by the Michigan board
- 26 of nursing.
- 27 (ii) A MASTER'S DEGREE IN NURSING PROGRAM OPERATED IN THIS

- 1 STATE BY AN ELIGIBLE INSTITUTION AND APPROVED BY THE MICHIGAN BOARD
- 2 OF NURSING.
- 3 (g) "Registered professional nurse" means that term as defined
- in section 17201 of the public health code, 1978 PA 368, MCL 4
- 333.17201. 5
