by amending section 226a (MCL 257.226a), as amended by 2002 PA 642.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 226a. (1) Temporary registration plates or markers may be
- 2 issued to licensed dealers in vehicles and to persons engaged in
- 3 the sale of vessels required to be numbered by part 801 of the
- 4 natural resources and environmental protection act, 1994 PA 451,
- 5 MCL 324.80101 to 324.80199, upon application accompanied by the
- 6 proper fee, for use by purchasers or lessees of vehicles, for not
- 7 to exceed 15 days pending receipt of regular registration plates
- 8 from the dealer or person. Only 1 temporary plate or marker may be
- issued to a purchaser or lessee of a vehicle. If a dealer or person

- 1 requires a purchaser or lessee of a vehicle or purchaser or lessee
- 2 of a vessel to pay for a temporary plate or marker, the dealer or
- 3 person shall not charge the purchaser or lessee more than the
- 4 dealer or person was charged by the secretary of state for the
- 5 individual plate or marker. The secretary of state shall determine
- 6 the composition and design of the temporary registration plates or
- 7 markers.
- 8 (2) A temporary registration plate or marker shall show in ink
- 9 the date of issue, a description of the vehicle for which issued,
- 10 and any other information required by the secretary of state. A
- 11 dealer or person shall immediately notify the secretary of state of
- 12 each temporary registration plate or marker issued by the dealer or
- 13 person, on a form prescribed by the secretary of state. Upon the
- 14 attachment of the regular plate to a vehicle for which a temporary
- 15 registration plate or marker has been issued, the temporary plate
- 16 shall be destroyed.
- 17 (3) All temporary registration plates or markers shall be
- 18 serially numbered and upon issuance the number shall be noted on
- 19 the statement of vehicle sale form or in the case of a boat trailer
- 20 on a form prescribed by the secretary of state.
- 21 (4) A dealer or person, upon demand, shall immediately
- 22 surrender any temporary registration plates or markers in his or
- 23 her possession if the secretary of state finds, after
- 24 investigation, that the dealer or person has violated this section,
- 25 and the dealer or person shall immediately forfeit any right to the
- 26 temporary registration plates or markers.
- 27 (5) The secretary of state may issue a registration plate upon

- 1 application and payment of the proper fee to an individual,
- 2 partnership, corporation, or association who in the ordinary course
- 3 of business has occasion to legally repossess a vehicle in which a
- 4 security interest is held. A registration plate issued pursuant to
- 5 this subsection shall be used to move and dispose of a vehicle.
- **6** (6) The secretary of state may issue a registration plate upon
- 7 application and payment of the proper fee to an individual,
- 8 partnership, corporation, or association who in the ordinary course
- 9 of business has occasion to legally pick up or deliver a vehicle
- 10 not required to be titled under this act, TO LEGALLY PICK UP OR
- 11 DELIVER A COMMERCIAL MOTOR VEHICLE BEING DRIVEN TO A FACILITY TO
- 12 UNDERGO AFTERMARKET MODIFICATION, or to repair or service a
- 13 vehicle, or to persons defined as dealers under part 801 of the
- 14 natural resources and environmental protection act, 1994 PA 451,
- 15 MCL 324.80101 to 324.80199, for the purpose of delivering a vessel
- 16 or trailer to a customer or to and from a boat show or exposition.
- 17 A registration plate issued under this subsection shall be used to
- 18 move the vehicle.
- 19 (7) The secretary of state may issue a registration plate upon
- 20 application and payment of the proper fee to an individual,
- 21 partnership, corporation, or association who in the ordinary course
- 22 of business operates an auto auction, and who in the ordinary
- 23 course of business has occasion to legally pick up a vehicle which
- 24 will be offered for sale at the auction, or deliver a vehicle which
- 25 has been offered for sale at the auction. The registration plate
- 26 shall be used only to move vehicles as provided in this subsection.
- 27 Auto auctions that make application for a registration plate under
