HOUSE BILL No. 4389

EXECUTIVE BUDGET BILL

February 23, 2005, Introduced by Rep. Whitmer and referred to the Committee on Appropriations.

A bill to make appropriations for the department of military and veterans affairs for the fiscal year ending September 30, 2006; to provide for the expenditure of the appropriations; to provide for certain powers and duties of the department of military and veterans affairs, other state agencies, and local units of government related to the appropriations; and to provide for the preparation of certain reports related to the appropriations.

PART 1

25	Sec. 203. As used in this bill:	

- 1 (a) "Department" means the department of military and veterans
- 2 affairs.
- 3 (b) "Director" means the director of the department of military
- 4 and veterans affairs.
- 5 (c) "DOD" means the United States department of defense.
- 6 (d) "DOD-DOA-NGB" means the DOD department of the army,
- 7 national guard bureau.
- 8 (e) "DVA" means the United States department of veterans'
- 9 affairs.
- 10 (f) "DVA-VHA" means the DVA veterans' health administration.
- 11 (g) "FTE" means full-time equated.
- 12 (h) "HHS" means the United States department of health and
- 13 human services.
- 14 (i) "IDG" means interdepartmental grant.
- 15 Sec. 204. The department of civil service shall bill
- 16 departments and agencies at the end of the first fiscal quarter for
- 17 the 1% charge authorized by section 5 of article XI of the state
- 18 constitution of 1963. Payments shall be made for the total amount
- 19 of the billing by the end of the second fiscal quarter.
- 20 Sec. 205. (1) A hiring freeze is imposed on the state
- 21 classified civil service. State departments and agencies are
- 22 prohibited from hiring any new full-time state classified civil
- 23 service employees and prohibited from filling any vacant state
- 24 classified civil service positions. This hiring freeze does not
- 25 apply to internal transfers of classified employees from 1 position
- 26 to another within a department.
- 27 (2) The state budget director may grant exceptions to this

- 1 hiring freeze when the state budget director believes that the
- 2 hiring freeze will result in rendering a state department or agency
- 3 unable to deliver basic services, cause loss of revenue to the
- 4 state, result in the inability of the state to receive federal
- 5 funds, or necessitate additional expenditures that exceed any
- 6 savings from maintaining a vacancy. The state budget director
- 7 shall report quarterly to the chairpersons of the senate and house
- 8 of representatives standing committees on appropriations the number

- 11 Sec. 206. Unless otherwise specified, the department shall use
- 12 the Internet to fulfill the reporting requirements of this bill.
- 13 This requirement may include transmission of reports via electronic
- 14 mail to the recipients identified for each reporting requirement,
- 15 or it may include placement of reports on an Internet or Intranet
- **16** site.
- 17 Sec. 207. Funds appropriated in part 1 shall not be used for
- 18 the purchase of foreign goods or services, or both, if
- 19 competitively priced and of comparable quality American goods or
- 20 services, or both, are available. Preference should be given to
- 21 goods or services, or both, manufactured or provided by Michigan
- 22 businesses if they are competitively priced and of comparable
- 23 quality.
- Sec. 208. The director shall take all reasonable steps to
- 25 ensure businesses in deprived and depressed communities compete for
- 26 and perform contracts to provide services or supplies, or both.
- 27 The director shall strongly encourage firms with which the

- 1 department contracts to subcontract with certified businesses in
- 2 depressed and deprived communities for services, supplies, or both.
- 3 Sec. 209. From the funds appropriated in part 1 for information
- 4 technology, departments and agencies shall pay user fees to the
- 5 department of information technology for technology-related
- 6 services and projects. Such user fees shall be subject to
- 7 provisions of an interagency agreement between the departments and
- 8 agencies and the department of information technology.
- 9 Sec. 210. Amounts appropriated in part 1 for information
- 10 technology may be designated as work projects and carried forward
- 11 to support technology projects under the direction of the
- 12 department of information technology. Funds designated in this
- 13 manner are not available for expenditure until approved as work
- 14 projects under section 451a of the management and budget act, 1984
- **15** PA 431, MCL 18.1451a.
- 16 Sec. 211. (1) Due to the current budgetary problems in this
- 17 state, out-of-state travel for the fiscal year ending September 30,
- 18 2006 shall be limited to situations in which 1 or more of the
- 19 following conditions apply:
- 20 (a) The travel is required by legal mandate or court order or
- 21 for law enforcement purposes.
- 22 (b) The travel is necessary to protect the health or safety of
- 23 Michigan citizens or visitors or to assist other states in similar
- 24 circumstances.
- 25 (c) The travel is necessary to produce budgetary savings or to
- 26 increase state revenues, including protecting existing federal
- 27 funds or securing additional federal funds.

- 1 (d) The travel is necessary to comply with federal
- 2 requirements.
- 3 (e) The travel is necessary to secure specialized training for
- 4 staff that is not available within this state.
- 5 (f) The travel is financed entirely by federal or nonstate
- 6 funds.
- 7 (2) If out-of-state travel is necessary but does not meet 1 or
- 8 more of the conditions in subsection (1), the state budget director
- 9 may grant an exception to allow the travel. Any exceptions granted
- 10 by the state budget director shall be reported on a monthly basis
- 11 to the senate and house of representatives standing committees on
- 12 appropriations.
- 13 (3) Not later than January 1 of each year, each department shall
- 14 prepare a travel report listing all travel by classified and
- 15 unclassified employees outside this state in the immediately
- 16 preceding fiscal year that was funded in whole or in part with
- 17 funds appropriated in the department's budget. The report shall be
- 18 submitted to the chairs and members of the senate and house of
- 19 representatives standing committees on appropriations, the fiscal
- 20 agencies, and the state budget director. The report shall include
- 21 the following information:
- 22 (a) The name of each person receiving reimbursement for travel
- 23 outside this state or whose travel costs were paid by this state.
- 24 (b) The destination of each travel occurrence.
- 25 (c) The dates of each travel occurrence.
- 26 (d) A brief statement of the reason for each travel occurrence.
- 27 (e) The transportation and related costs of each travel

- 1 occurrence, including the proportion funded with state general
- 2 fund/general purpose revenues, the proportion funded with state
- 3 restricted revenues, the proportion funded with federal revenues,
- 4 and the proportion funded with other revenues.
- 5 (f) A total of all out-of-state travel funded for the
- 6 immediately preceding fiscal year.
- 7 Sec. 212. (1) In addition to the funds appropriated in part 1,
- 8 there is appropriated an amount not to exceed \$5,000,000.00 for
- 9 federal contingency funds. These funds are not available for
- 10 expenditure until they have been transferred to another line item
- 11 in this bill under section 393(2) of the department of management
- 12 and budget act, 1984 PA 431, MCL 18.1393.
- 13 (2) In addition to the funds appropriated in part 1, there is
- 14 appropriated an amount not to exceed \$2,000,000.00 for state
- 15 restricted contingency funds. These funds are not available for
- 16 expenditure until they have been transferred to another line item
- 17 in this bill under section 393(2) of the department of management
- 18 and budget act, 1984 PA 431, MCL 18.1393.
- 19 (3) In addition to the funds appropriated in part 1, there is
- 20 appropriated an amount not to exceed \$100,000.00 for local
- 21 contingency funds. These funds are not available for expenditure
- 22 until they have been transferred to another line item in this bill
- 23 under section 393(2) of the department of management and budget
- 24 act, 1984 PA 431, MCL 18.1393.
- 25 (4) In addition to the funds appropriated in part 1, there is
- 26 appropriated an amount not to exceed \$100,000.00 for private
- 27 contingency funds. These funds are not available for expenditure

- 1 until they have been transferred to another line item in this bill
- 2 under section 393(2) of the department of management and budget
- 3 act, 1984 PA 431, MCL 18.1393.
- 4 Sec. 213. (1) Of the funds appropriated in section 103 for
- 5 military training sites and support facilities, there shall be
- 6 established a Michigan national guard education assistance program.
- 7 Disbursements to the educational assistance program shall not
- 8 exceed \$1,100,000.00 without legislative approval. Under the
- 9 program, a member of the national guard who is in active service
- 10 and who enrolls as a full- or part-time student at a public or
- 11 private state college or university may be eligible to receive up
- 12 to an equivalent of 50% of the total cost of tuition not to exceed
- 13 \$2,000.00, as education assistance, in any academic year.
- 14 (2) As used in this section, an eligible person means a member
- 15 of the Michigan national guard who is in active service, as defined
- 16 in section 105 of the Michigan military act, 1967 PA 150, MCL
- 17 32.505. An eligible person does not include a member of the
- 18 Michigan national guard or air national guard who is absent without
- 19 leave or who is under charges as described in the Michigan code of
- 20 military justice of 1980, 1980 PA 523, MCL 32.1001 to 32.1148.
- 21 (3) The department of military and veterans affairs, office of
- 22 the adjutant general shall administer the education assistance
- 23 program and prescribe forms and procedures to effectively carry out
- 24 the education assistance program.
- 25 (4) An eligible person shall apply to the department of military
- 26 and veterans affairs, office of the adjutant general for education
- 27 assistance and shall provide evidence of attendance and completion

- 1 of the course of study with a grade of at least 2.0 on a 4.0 scale,
- 2 or its equivalent. The adjutant general shall approve the
- 3 application for reimbursement if the applicant meets the definition
- 4 of an eligible person under subsection (2) and other criteria as
- 5 established by the adjutant general.
- **6** (5) The education assistance program applies to any course of
- 7 instruction that is included in an associate, undergraduate, or
- 8 postgraduate degree program offered by a college or university of
- 9 this state.
- 10 (6) The education assistance program applies to an eligible
- 11 person notwithstanding any other educational incentive or benefit
- 12 received by the eligible person under any other educational
- 13 assistance program provided by any other state.
- 14 (7) An eligible person who successfully completes the course of
- 15 study with a grade of at least 2.0 on a 4.0 scale, or its
- 16 equivalent, shall be eligible for reimbursement.
- 17 (8) The department of military and veterans affairs may use
- 18 funds from the appropriated funds to administer the education
- 19 assistance program.
- 20 (9) Reimbursed members who do not complete their national guard
- 21 obligation shall pay the state for money received from the state
- 22 for tuition. Members who fail to repay the state within the time
- 23 limits established by the adjutant general shall be indebted to the
- 24 state. The department shall work in conjunction with the
- 25 department of treasury for inclusion in the tax intercept program
- 26 for amounts due the state.
- 27 (10) A portion of the funds for the Michigan national guard

- 1 education assistance program may be used by the department for the
- 2 purpose of promoting the program and for encouraging those persons
- 3 the department wishes to have enlist or reenlist in the Michigan
- 4 national guard.

5 HEADQUARTERS AND ARMORIES

- 6 Sec. 302. (1) The funds appropriated in this bill for private
- 7 donations to the challenge program shall be considered state
- 8 restricted revenue, and unexpended funds remaining at the close of
- 9 the fiscal year shall not lapse to the general fund but shall be
- 10 carried forward to the subsequent fiscal year.
- 11 (2) The department shall make every effort to identify
- 12 alternative sources of revenue to replace the general fund/general
- 13 purpose funding provided in this bill for the challenge program.
- 14 (3) The department may charge a parent or guardian of a
- 15 participant in the challenge program a fee for participating in the
- 16 program if the participant is a member of a family with an income
- 17 that exceeds 200% of the federal poverty guidelines as published by
- 18 the United States department of health and human services. The
- 19 amount charged the parent or guardian shall not exceed the per
- 20 student state share cost of administering the program. The parent
- 21 or guardian shall be notified of any charge to be assessed under
- 22 this subsection prior to enrollment of the child in the program.
- 23 (4) The department shall take steps to insure that at least 75%
- 24 of the participants in the challenge program are members of
- 25 families with incomes at or below 200% of the federal poverty
- 26 level.
- 27 Sec. 304. The department shall partner with the family

- 1 independence agency to identify youth who may be eligible for the
- 2 challenge program from those youth served by family independence
- 3 agency programs. These eligible youth shall be given priority for
- 4 enrollment in the program.

5 VETERANS SERVICE ORGANIZATIONS

- 6 Sec. 501. (1) Money appropriated in section 105 for grants to
- 7 veterans service organizations shall be used only for salaries,
- 8 wages, related personnel costs, training, and equipment for
- 9 accredited veteran service advocacy officers and necessary support
- 10 and managerial staff. Training shall be provided for service
- 11 advocacy officers and shall be conducted by accredited advocacy
- 12 officers.
- 13 (2) To receive a grant from the money appropriated in section
- 14 105, a veterans service organization shall meet the following
- 15 eligibility requirements:
- 16 (a) Be congressionally chartered by the United States Congress.
- 17 (b) Be an active participating member of the Michigan veterans
- 18 organizations' rehabilitation and veterans service committee and
- 19 abide by its rules, guidelines, and programs.
- 20 (c) Demonstrate the receipt of monetary or service support from
- 21 its own organization.
- 22 (d) Comply with the department's and the legislature's
- 23 requirements of accounting audits, service work activity,
- 24 accounting of recoveries, listing of volunteer hours, budget
- 25 requests, and other requirements specified in subsection (3).
- 26 (e) For a veterans service organization founded after September
- 27 30, 1989, be in operation and providing service to Michigan

- 1 veterans for not less than 2 years before receiving an initial
- 2 state grant. During this 2-year period of time, the organization
- 3 shall file a listing of service work activity and an accounting of
- 4 recoveries with the department, the senate and house fiscal
- 5 agencies, the senate and house of representatives appropriations
- 6 subcommittees on military affairs, and the state budget office on
- 7 forms as prescribed by the department.
- 8 (3) A veterans service organization receiving a grant from the
- 9 money appropriated in section 105 shall file with the department an
- 10 accounting of its expenditures, audited and certified by a
- 11 certified public accountant, within 120 days after the
- 12 organization's fiscal year end. Each organization shall provide a
- 13 detailed budget request for the fiscal year ending September 30,
- 14 2007, to the department by November 15, 2005, within the format as
- 15 prescribed by the department to be used in the development of the
- 16 budget for the fiscal year ending September 30, 2007. Each
- 17 veterans service organization shall provide 5 copies of a listing
- 18 of all service activity, an accounting of recoveries, and a listing
- 19 of volunteer hours for the fiscal year ending September 30, 2005,
- 20 to the department by January 31, 2006. The listing of volunteer
- 21 hours shall include the hours, services, and donations provided to
- 22 residents of the Grand Rapids veterans' home and the D.J. Jacobetti
- 23 veterans' home. Each veterans service organization shall provide a
- 24 copy of the most recent and completed internal revenue service form
- 25 990 to the department at the end of the fiscal year ending
- 26 September 30, 2005. A veterans service organization receiving a
- 27 grant from the money appropriated in section 105 shall use the

- 1 forms recommended by the Michigan veterans organizations'
- 2 rehabilitation and veterans service committee for filing reports
- 3 required by this bill. The department shall forward information
- 4 required under this section to the senate and house fiscal
- 5 agencies, the senate and house of representatives appropriations
- 6 subcommittees on military affairs, and the state budget office.

7 VETERANS' HOMES

- 8 Sec. 603. The money appropriated in this bill for the boards of
- 9 managers may be expended for facility improvements, the purchase
- 10 and repair of equipment and furnishings, member services, and other
- 11 purposes that benefit the Grand Rapids veterans' home and the D.J.
- 12 Jacobetti veterans' home.

13 VETERANS' TRUST FUND

- Sec. 703. (1) By April 1, 2006, the department shall submit to
- 15 the senate and house of representatives appropriations
- 16 subcommittees on military affairs and the state budget office a
- 17 detailed annual report of the Michigan veterans' trust fund for
- 18 fiscal year 2004-2005. The report shall include information on
- 19 grants provided from the emergency grant program and the veterans
- 20 survivor tuition program, including details concerning the
- 21 methodology of allocations, the selection of emergency grant
- 22 program authorized agents, and a detailed breakdown of trust fund
- 23 expenditures for that year. The report shall also provide an
- 24 update on the department's efforts to reduce program administrative
- 25 costs.
- 26 (2) The annual report required under subsection (1) shall
- 27 contain information on the veterans survivors tuition program,

- 1 including the number of participants, where the participants
- 2 attended school, payments made to each school, the average grade
- 3 point and number of college credits earned by each participant, the
- 4 number of participants suspended by the program, and the number of
- 5 participants who earned a degree during fiscal year 2004-2005.
