## **HOUSE BILL No. 4426**

March 1, 2005, Introduced by Reps. Kolb, Leland, Alma Smith, Lipsey, Bieda, Donigan and Tobocman and referred to the Committee on Health Policy.

A bill to amend 1978 PA 368, entitled "Public health code,"

by amending sections 5717 and 5721 (MCL 333.5717 and 333.5721), section 5717 as added by 1987 PA 48 and section 5721 as amended by 1988 PA 236.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 5717. The department shall establish a birth defectsregistry for all of the following purposes:
  - (a) To provide information on the incidence, **PREVALENCE**, and trends of birth defects, **FETAL DEATHS**, **AND MISCARRIAGES** among Vietnam-era veterans, —and—their families, and —among—the general population.
    - (b) To provide information to determine whether environmental

- 17 of birth defects, shall be reported to the department WITHIN 30
- 18 DAYS OF THE DIAGNOSIS. The reporting shall begin not later than
- 19 the next calendar year after June 11, 1987.
- 20 (2) EACH FETAL DEATH AND MISCARRIAGE AND ANY OTHER INFORMATION
- 21 RELEVANT TO THE FETAL DEATH OR MISCARRIAGE, INCLUDING, BUT NOT
- 22 LIMITED TO, THE MEDICAL RECORDS OF THE MOTHER, SHALL BE REPORTED TO

- 9 published not later than 180 days after the end of each calendar
