

HOUSE BILL No. 4455

March 3, 2005, Introduced by Reps. Murphy, Gonzales, Zelenko, Williams, Whitmer, McConico, Leland, Clemente, Condino, Tobocman, Farrah, Lipsey, Alma Smith, Clack, Cushingberry, Plakas and Hopgood and referred to the Committee on Health Policy.

A bill to amend 1978 PA 368, entitled
"Public health code,"
(MCL 333.1101 to 333.25211) by adding section 2227.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 2227. THE DEPARTMENT SHALL DO ALL OF THE FOLLOWING:

2 (A) DEVELOP AND IMPLEMENT A STATE STRUCTURE MORE CONDUCTIVE TO
3 ADDRESSING THE HEALTH DISPARITIES OF THE MINORITY POPULATION IN
4 THIS STATE.

5 (B) MONITOR MINORITY HEALTH PROGRESS.

6 (C) ESTABLISH MINORITY HEALTH POLICY.

7 (D) FUND MINORITY HEALTH PROGRAMS, RESEARCH, AND OTHER
8 INITIATIVES.

9 (E) PROVIDE THE FOLLOWING THROUGH INTERDEPARTMENTAL

1 COORDINATION:

2 (i) THE DATA AND TECHNICAL ASSISTANCE NEEDS OF LOCAL MINORITY
3 HEALTH COALITIONS.

4 (ii) MEASURABLE MINORITY HEALTH OBJECTIVES TO LOCAL MINORITY
5 HEALTH COALITIONS FOR THE DEVELOPMENT OF HEALTH INTERVENTION
6 PROGRAMS.

7 (F) ESTABLISH A STATE HEALTH DATA CENTER FOR MINORITY HEALTH
8 RESEARCH AND RESOURCE INFORMATION ADDRESSING ALL OF THE FOLLOWING:

9 (i) RESEARCH WITHIN MINORITY POPULATIONS.

10 (ii) A RESOURCE DATABASE THAT CAN BE DISTRIBUTED TO LOCAL
11 ORGANIZATIONS INTERESTED IN MINORITY HEALTH.

12 (iii) RACIAL AND ETHNIC SPECIFIC DATABASES INCLUDING, BUT NOT
13 LIMITED TO, MORBIDITY, DIAGNOSTIC GROUPS, SOCIAL AND ECONOMIC
14 GROUPS, EDUCATION, AND POPULATION.

15 (iv) ATTITUDE, KNOWLEDGE, AND BELIEF INFORMATION.

16 (G) STAFF A MINORITY HEALTH HOTLINE THAT ESTABLISHES LINKAGES
17 WITH OTHER HEALTH AND SOCIAL SERVICE HOTLINES AND LOCAL COALITIONS.

18 (H) DEVELOP AND IMPLEMENT AN AGGRESSIVE RECRUITMENT AND
19 RETENTION PROGRAM TO INCREASE THE NUMBER OF MINORITIES IN THE
20 HEALTH AND SOCIAL SERVICES PROFESSIONS.

21 (I) DEVELOP AND IMPLEMENT AN AWARENESS PROGRAM THAT WILL
22 INCREASE THE KNOWLEDGE OF HEALTH AND SOCIAL SERVICE PROVIDERS TO
23 THE SPECIAL NEEDS OF MINORITIES.

24 (J) DEVELOP AND IMPLEMENT CULTURALLY AND LINGUISTICALLY
25 APPROPRIATE HEALTH PROMOTION AND DISEASE PREVENTION PROGRAMS THAT
26 WOULD EMPHASIZE AVOIDING THE HEALTH RISK FACTORS FOR CONDITIONS
27 AFFECTING MINORITIES AND INCORPORATE AN ACCESSIBLE, AFFORDABLE, AND

1 ACCEPTABLE EARLY DETECTION AND INTERVENTION COMPONENT.

2 (K) PROVIDE THE STATE SUPPORT NECESSARY TO ENSURE THE
3 CONTINUED DEVELOPMENT OF THE EXISTING MINORITY HEALTH COALITIONS
4 AND TO DEVELOP COALITIONS IN OTHER AREAS TARGETED FOR MINORITY
5 HEALTH INTERVENTION.

6 (L) APPOINT A STATE FUNDED COORDINATOR FOR EACH OF THE COUNTIES
7 WITH EXISTING MINORITY HEALTH COALITIONS TO PROVIDE COMMUNITY
8 PLANNING AND NEEDS ASSESSMENT ASSISTANCE TO THE COALITION AND TO
9 ASSIST THE COALITION IN THE DEVELOPMENT OF THE LOCAL MINORITY
10 HEALTH INTERVENTION PLAN THROUGH THE YEAR 2008.

11 (M) APPOINT AND ASSIGN REGIONAL CONSULTANTS TO SERVE AS A
12 LIAISON BETWEEN THE DEPARTMENT AND THE LOCAL MINORITY HEALTH
13 COALITION TO DO ALL OF THE FOLLOWING:

14 (i) COORDINATE THE DEPARTMENT RESOURCES NEEDED FOR THE
15 DEVELOPMENT OF LOCAL MINORITY HEALTH COALITIONS.

16 (ii) PROVIDE ASSISTANCE TO AND MONITOR THE REGIONAL CONSULTANTS
17 IN THE DEVELOPMENT OF LOCAL INTERVENTION PLANS.

18 (iii) SERVE AS THE BAROMETER TO THE DEPARTMENT ON THE MINORITY
19 HEALTH CONCERNS OF LOCAL MINORITY HEALTH COALITIONS.

20 (iv) ASSIST IN COORDINATING MINORITY INPUT ON STATE HEALTH
21 POLICIES AND PROGRAMS.

22 (v) SERVE AS THE LINKAGE BETWEEN THE DEPARTMENT AND LOCAL
23 MINORITY HEALTH COORDINATORS.

24 (vi) MONITOR THE PROGRESS OF THEIR COMPLIANCE WITH THIS
25 SUBDIVISION.

26 (N) PROVIDE FUNDING, WITHIN THE LIMITS OF APPROPRIATIONS, TO
27 SUPPORT PREVENTATIVE HEALTH, EDUCATION, AND TREATMENT PROGRAMS IN

1 MINORITY COMMUNITIES THAT ARE DEVELOPED, PLANNED, AND EVALUATED BY
2 APPROVED ORGANIZATIONS.

3 (O) PROVIDE ASSISTANCE TO LOCAL COMMUNITIES TO OBTAIN FUNDING
4 FOR THE DEVELOPMENT OF A HEALTH CARE DELIVERY SYSTEM TO MEET THE
5 NEEDS, GAPS, AND BARRIERS IDENTIFIED IN LOCAL MINORITY HEALTH
6 INTERVENTION PLANS DEVELOPED UNDER SUBDIVISION (I).
