## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 21555. (1) TO EXAMINE MEANS TO IMPROVE PATIENT SAFETY AND
- 2 REDUCE HOSPITAL-ACQUIRED INFECTIONS IN THIS STATE, THE GOVERNOR
- 3 SHALL CREATE AND APPOINT A COMMISSION ON HOSPITAL-ACQUIRED
