HOUSE BILL No. 4595

A bill to amend 1978 PA 368, entitled "Public health code,"

by amending section 7410a (MCL 333.7410a), as amended by 2000 PA 314.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 7410a. (1) An individual 18 years of age or over who
 does any of the following IS GUILTY OF A FELONY AND may be punished
 by a term of imprisonment of not more than 2 years:
 - (a) Violates section 7401(2)(a)(iv) or (2)(b)(i) or section 7401b by delivering a controlled substance or gamma-butyrolactone to a minor who is in a public park or private park or within 1,000 feet of a public park or private park.
 - (b) Violates section 7401(2)(a)(iv) or (2)(b)(i) or section

- 1 7401b by possessing with intent to deliver a controlled substance
