## **HOUSE BILL No. 4642**

April 20, 2005, Introduced by Reps. Jones, LaJoy, Baxter, Stewart, Elsenheimer, Rocca, Robertson, Sheltrown, Steil, Garfield, Acciavatti, Pearce, Wenke, Palsrok, Hummel, Hansen, Gosselin, Booher, Polidori, Stahl, Cushingberry, Anderson, Hune, Nofs, Farhat, Vander Veen, Ball and Moolenaar and referred to the Committee on Conservation, Forestry, and Outdoor Recreation.

A bill to amend 1927 PA 372, entitled

"An act to regulate and license the selling, purchasing, possessing, and carrying of certain firearms and gas ejecting devices; to prohibit the buying, selling, or carrying of certain firearms and gas ejecting devices without a license or other authorization; to provide for the forfeiture of firearms under certain circumstances; to provide for penalties and remedies; to provide immunity from civil liability under certain circumstances; to prescribe the powers and duties of certain state and local agencies; to prohibit certain conduct against individuals who apply for or receive a license to carry a concealed pistol; to make appropriations; to prescribe certain conditions for the appropriations; and to repeal all acts and parts of acts inconsistent with this act,"

by amending section 12 (MCL 28.432), as amended by 2004 PA 99.

- Sec. 12. (1) Sections 2 and 9 do not apply to any of the following:
  - (a) A police or correctional agency of the United States or of this state or any subdivision of this state.
    - (b) The United States army, air force, navy, or marine corps.

- 18 (I) AN INDIVIDUAL CARRYING, POSSESSING, USING, OR TRANSPORTING
- 19 A PISTOL BELONGING TO HIS OR HER SPOUSE, IF THE SPOUSE'S PISTOL IS
- 20 PROPERLY LICENSED AND INSPECTED UNDER THIS ACT AND THE INDIVIDUAL
- 21 CARRYING, POSSESSING, USING, OR TRANSPORTING THE PISTOL HAS ALSO
- 22 OBTAINED A LICENSE UNDER THIS ACT TO CARRY, POSSESS, USE, OR
- 23 TRANSPORT A PISTOL.

- 25 known and may be cited as the "Janet Kukuk act".
