THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 801. (1) Compensation shall be paid promptly and directly
- 2 to the person entitled -thereto- and shall become due and payable
- 3 on the fourteenth day after the employer has notice or knowledge of
- 4 the disability or death, on which date all compensation then
- 5 accrued shall be paid. Thereafter compensation shall be paid in
- 6 weekly installments. COMPENSATION OR A LUMP SUM REQUIRED TO BE PAID
- 7 UNDER A SETTLEMENT OR REDEMPTION AGREEMENT IS DUE AND OWING ON THE
- 8 DATE OF THE SETTLEMENT OR REDEMPTION AGREEMENT AND IS PAYABLE IN
- 9 ACCORDANCE WITH THE TERMS OF THE SETTLEMENT OR REDEMPTION

- 1 AGREEMENT. Every carrier shall keep a record of all payments made
