A bill to amend 1978 PA 368, entitled "Public health code,"

(MCL 333.1101 to 333.25211) by adding section 16184.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 16184. (1) AN INDIVIDUAL WHO IS RETIRED FROM THE ACTIVE
- 2 PRACTICE OF MEDICINE OR OSTEOPATHIC MEDICINE AND SURGERY AND WHO
- 3 WISHES TO DONATE HIS OR HER EXPERTISE FOR THE MEDICAL CARE AND
- 4 TREATMENT OF INDIGENT AND NEEDY INDIVIDUALS IN THIS STATE OR FOR
- 5 THE MEDICAL CARE AND TREATMENT OF INDIVIDUALS IN MEDICALLY
- 6 UNDERSERVED AREAS OF THIS STATE MAY OBTAIN A SPECIAL VOLUNTEER
- 7 LICENSE BY SUBMITTING AN APPLICATION TO THE BOARD PURSUANT TO THIS
- B SECTION. AN APPLICATION FOR A SPECIAL VOLUNTEER LICENSE SHALL BE
- 9 ON A FORM PROVIDED BY THE DEPARTMENT AND SHALL INCLUDE EACH OF THE
- 10 FOLLOWING:
 - (A) DOCUMENTATION OF THE APPLICANT'S MEDICAL DEGREE AND

- 1 PRACTICE HISTORY, INCLUDING THE NAME OF EACH HOSPITAL WITH WHICH HE
- 2 OR SHE WAS EMPLOYED OR UNDER CONTRACT AND EACH HOSPITAL IN WHICH HE
- 3 OR SHE WAS ALLOWED TO PRACTICE.
- 4 (B) DOCUMENTATION THAT THE INDIVIDUAL HAS BEEN PREVIOUSLY
- 5 LICENSED TO ENGAGE IN THE PRACTICE OF MEDICINE OR OSTEOPATHIC
- 6 MEDICINE AND SURGERY IN THIS STATE OR IN ANOTHER STATE AND THAT HIS
- 7 OR HER LICENSE WAS IN GOOD STANDING PRIOR TO THE EXPIRATION OF HIS
- 8 OR HER LICENSE.
- 9 (C) ACKNOWLEDGMENT AND DOCUMENTATION THAT THE APPLICANT WILL
- 10 NOT RECEIVE ANY PAYMENT OR COMPENSATION, EITHER DIRECT OR INDIRECT,
- 11 OR HAVE THE EXPECTATION OF ANY PAYMENT OR COMPENSATION, FOR ANY
- 12 MEDICAL CARE SERVICES PROVIDED UNDER THE SPECIAL VOLUNTEER LICENSE.
- 13 (2) IF THE BOARD DETERMINES THAT THE APPLICATION OF THE
- 14 INDIVIDUAL SATISFIES THE REQUIREMENTS OF SUBSECTION (1) AND THAT
- 15 THE INDIVIDUAL MEETS THE REQUIREMENTS FOR A LICENSE AS PRESCRIBED
- 16 BY THIS ARTICLE AND RULES PROMULGATED UNDER THIS ARTICLE, THE BOARD
- 17 SHALL GRANT A SPECIAL VOLUNTEER LICENSE TO THE APPLICANT. THE BOARD
- 18 SHALL NOT CHARGE A FEE FOR THE ISSUANCE OR RENEWAL OF A SPECIAL
- 19 VOLUNTEER LICENSE UNDER THIS SECTION.
- 20 (3) A PHYSICIAN WHO IS GRANTED A SPECIAL VOLUNTEER LICENSE
- 21 PURSUANT TO THIS SECTION AND WHO ACCEPTS THE PRIVILEGE OF
- 22 PRACTICING MEDICINE IN THIS STATE IS SUBJECT TO ALL OF THE
- 23 PROVISIONS OF THIS ARTICLE, INCLUDING THOSE PROVISIONS GOVERNING
- 24 DISCIPLINARY ACTION SET FORTH IN THIS ARTICLE.
- 25 (4) FOR PURPOSES OF THIS SECTION, AN INDIVIDUAL IS CONSIDERED
- 26 RETIRED FROM PRACTICE IF THE INDIVIDUAL'S LICENSE HAS EXPIRED WITH
- 27 THE INDIVIDUAL'S INTENTION OF CEASING TO ENGAGE IN THE PRACTICE OF
