## **HOUSE BILL No. 4714**

May 3, 2005, Introduced by Reps. Pavlov, Schuitmaker, Jones, Wenke, Walker, Ball, Huizenga, Elsenheimer, Kooiman, Vander Veen, Ward, Farhat, Gillard and Emmons and referred to the Committee on Natural Resources, Great Lakes, Land Use, and Environment.

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding section 41321.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 41321. (1) THE NONNATIVE SPECIES ADVISORY COUNCIL IS 2 CREATED.
- 3 (2) THE COUNCIL SHALL CONSIST OF THE FOLLOWING MEMBERS:
- 4 (A) FOUR MEMBERS APPOINTED BY THE SENATE MAJORITY LEADER.
  - (B) THREE MEMBERS APPOINTED BY THE SPEAKER OF THE HOUSE OF REPRESENTATIVES.
  - (3) THE MEMBERS FIRST APPOINTED TO THE COUNCIL SHALL BE APPOINTED WITHIN 60 DAYS AFTER THE EFFECTIVE DATE OF THIS SECTION.
    - (4) MEMBERS OF THE COUNCIL SHALL SERVE FOR TERMS OF 2 YEARS OR

- 1 UNTIL A SUCCESSOR IS APPOINTED, WHICHEVER IS LATER, EXCEPT THAT 2
- 2 OF THE MEMBERS FIRST APPOINTED BY THE SENATE MAJORITY LEADER AND 1

- 14 SENATE MAJORITY LEADER. AT THE FIRST MEETING, THE COUNCIL SHALL
- 15 ELECT FROM AMONG ITS MEMBERS A CHAIRPERSON AND OTHER OFFICERS AS IT
- 16 CONSIDERS NECESSARY OR APPROPRIATE. AFTER THE FIRST MEETING, THE
- 17 COUNCIL SHALL MEET AT LEAST QUARTERLY, OR MORE FREQUENTLY AT THE

- 19 (8) A MAJORITY OF THE MEMBERS OF THE COUNCIL CONSTITUTE A
- 20 QUORUM FOR THE TRANSACTION OF BUSINESS AT A MEETING OF THE COUNCIL.
- 21 A MAJORITY OF THE MEMBERS PRESENT AND SERVING ARE REQUIRED FOR
- 22 OFFICIAL ACTION OF THE COUNCIL.
- 23 (9) THE BUSINESS THAT THE COUNCIL MAY PERFORM SHALL BE
- 24 CONDUCTED AT A PUBLIC MEETING OF THE COUNCIL HELD IN COMPLIANCE
- 25 WITH THE OPEN MEETINGS ACT, 1976 PA 267, MCL 15.261 TO 15.275.
- 26 (10) A WRITING PREPARED, OWNED, USED, IN THE POSSESSION OF, OR
- 27 RETAINED BY THE COUNCIL IN THE PERFORMANCE OF AN OFFICIAL FUNCTION
