A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 479c.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 479C. (1) A PEACE OFFICER SHALL NOT USE THE RACIAL
- 2 CHARACTERISTICS OR SKIN COLOR OF ANY INDIVIDUAL AS THE SOLE BASIS
- 3 FOR CONDUCTING AN INVESTIGATIVE STOP.
- 4 (2) A PEACE OFFICER WHO VIOLATES THIS SECTION IS GUILTY OF A
- 5 CRIME AS FOLLOWS:
 - (A) EXCEPT AS PROVIDED IN SUBDIVISION (B), THE PEACE OFFICER IS GUILTY OF A MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 90 DAYS OR A FINE OF NOT MORE THAN \$100.00, OR BOTH.
 - (B) A PEACE OFFICER WHO COMMITS A SECOND OR SUBSEQUENT VIOLATION OF THIS SECTION IS GUILTY OF A FELONY PUNISHABLE BY
