A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

- 3 ANOTHER INDIVIDUAL OR REPRESENT TO ANOTHER INDIVIDUAL BY
- 4 IDENTIFICATION OR ANY OTHER MEANS THAT HE OR SHE IS EMPLOYED IN 1
- 5 OF THOSE CAPACITIES WITH INTENT TO DO 1 OR MORE OF THE FOLLOWING:
 - (A) PERFORM THE DUTIES OF A FIREFIGHTER OR EMERGENCY MEDICAL SERVICE PROVIDER.
 - (B) REPRESENT TO ANOTHER PERSON THAT HE OR SHE IS A
