HOUSE BILL No. 4938

June 14, 2005, Introduced by Reps. Hune, Gleason, Gaffney, Wojno, Hildenbrand and Mortimer and referred to the Committee on Health Policy.

A bill to amend 1953 PA 181, entitled

"An act relative to investigations in certain instances of the causes of death within this state due to violence, negligence or other act or omission of a criminal nature or to protect public health; to provide for the taking of statements from injured persons under certain circumstances; to abolish the office of coroner and to create the office of county medical examiner in certain counties; to prescribe the powers and duties of county medical examiners; to prescribe penalties for violations of the provisions of this act; and to prescribe a referendum thereon,"

(MCL 52.201 to 52.216) by adding section 9.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 9. (1) IF A COUNTY MEDICAL EXAMINER OR A DEPUTY RECEIVES
- 2 NOTIFICATION FROM A PERSON OTHER THAN A REPRESENTATIVE OF A
- 3 HOSPITAL OF A DEATH THAT REQUIRES AN INVESTIGATION BY THE COUNTY
- MEDICAL EXAMINER'S OFFICE PURSUANT TO THIS ACT, THE COUNTY MEDICAL
 - EXAMINER OR DEPUTY SHALL TAKE CHARGE OF THE BODY. UPON VIEWING THE

- 1 BODY AND PERSONALLY INQUIRING INTO THE CAUSE AND MANNER OF THE
