- 1 PART 96A. CLINICAL TRIALS HUMAN SUBJECT RESEARCH
  2 SEC. 9651. AS USED IN THIS PART:
  - (A) "CLINICAL TRIAL" MEANS RESEARCH INVOLVING HUMAN SUBJECTS
    THAT IS CONDUCTED FOR THE PRIMARY PURPOSE OF DETERMINING WHETHER OR
    NOT A PARTICULAR DRUG OR MEDICAL TREATMENT IS SAFE AND EFFECTIVE.
  - (B) "HUMAN SUBJECT" MEANS A LIVING INDIVIDUAL ABOUT WHOM AN INVESTIGATOR CONDUCTING RESEARCH OBTAINS DATA THROUGH INTERVENTION OR INTERACTION WITH THE INDIVIDUAL OR OBTAINS IDENTIFIABLE PRIVATE
