- 2 (A) "MOTION PICTURE" MEANS A FEATURE-LENGTH FILM DISTRIBUTED
- 3 IN 2 OR MORE STATES THAT IS A PRODUCTION FOR WHICH RECORDS ARE NOT
- 4 REQUIRED TO BE MAINTAINED WITH RESPECT TO ANY PERFORMER IN THE
- 5 PRODUCTION UNDER 18 USC 2257, OR TELEVISION SERIES MADE IN THIS
- 6 STATE IN WHOLE OR IN PART FOR THEATRICAL OR TELEVISION VIEWING OR
- 7 AS A TELEVISION PILOT. MOTION PICTURE DOES NOT INCLUDE PRODUCTION
 - OF TELEVISION COVERAGE OF NEWS AND SPORTING EVENTS.
- 9 (B) "MOTION PICTURE PRODUCTION COMPANY" MEANS A COMPANY IN THE
