HOUSE BILL No. 5268

October 6, 2005, Introduced by Reps. Meyer, Nofs and Taub and referred to the Committee on Judiciary.

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 85.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 85. (1) A PERSON WHO TORTURES ANOTHER PERSON IS GUILTY OF
- 2 A FELONY PUNISHABLE BY IMPRISONMENT FOR LIFE OR ANY TERM OF YEARS.
- 3 (2) AS USED IN THIS SECTION:
- 4 (A) "GREAT BODILY INJURY" MEANS A SIGNIFICANT OR SUBSTANTIAL
- 5 PHYSICAL INJURY.
 - (B) "SEVERE MENTAL PAIN OR SUFFERING" MEANS THE PROLONGED
 - MENTAL HARM CAUSED BY OR RESULTING FROM ANY OF THE FOLLOWING:
 - (i) THE INTENTIONAL INFLICTION OR THREATENED INFLICTION OF
 - SEVERE PHYSICAL PAIN OR SUFFERING.
 - (ii) THE ADMINISTRATION OR APPLICATION, OR THREATENED

- 1 ADMINISTRATION OR APPLICATION, OF MIND-ALTERING SUBSTANCES OR OTHER
- 2 PROCEDURES CALCULATED TO PROFOUNDLY DISRUPT THE SENSES OR THE

- 4 (iii) THE THREAT OF IMMINENT DEATH.
- 5 (iv) THE THREAT THAT ANOTHER PERSON WILL IMMINENTLY BE
- 6 SUBJECTED TO DEATH, SEVERE PHYSICAL PAIN OR SUFFERING, OR THE
- 7 ADMINISTRATION OR APPLICATION OF MIND-ALTERING SUBSTANCES OR OTHER
- 8 PROCEDURES CALCULATED TO PROFOUNDLY DISRUPT THE SENSES OR
- 9 PERSONALITY.
- 10 (C) "TORTURE" MEANS AN ACT SPECIFICALLY INTENDED TO INFLICT
- 11 GREAT BODILY INJURY OR SEVERE MENTAL PAIN OR SUFFERING UPON ANOTHER
- 12 PERSON WITHIN HIS OR HER CUSTODY OR PHYSICAL CONTROL.
- 13 (3) PROOF THAT A VICTIM SUFFERED PAIN IS NOT AN ELEMENT OF THE
- 14 CRIME UNDER THIS SECTION.
- 15 (4) A CONVICTION OR SENTENCE UNDER THIS SECTION DOES NOT
- 16 PRECLUDE A CONVICTION OR SENTENCE FOR A VIOLATION OF ANY OTHER LAW
- 17 OF THIS STATE ARISING FROM THE SAME TRANSACTION.
