A bill to amend 1976 PA 451, entitled "The revised school code," (MCL 380.1 to 380.1852) by adding section 1281a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1281A. (1) THE DEPARTMENT SHALL TAKE REASONABLE STEPS, AS
- 2 DETERMINED BY THE DEPARTMENT, TO ASSIST SCHOOL DISTRICTS,
- 3 INTERMEDIATE SCHOOL DISTRICTS, AND PUBLIC SCHOOL ACADEMIES TO
- 4 OPERATE IN A MORE EFFICIENT AND COST-EFFECTIVE MANNER. THESE STEPS
- 5 SHALL INCLUDE ASSISTING SCHOOL DISTRICTS, INTERMEDIATE SCHOOL
- 6 DISTRICTS, AND PUBLIC SCHOOL ACADEMIES IN THE CONSOLIDATION OF
- SERVICES AND FACILITATING OTHER ARRANGEMENTS AMONG THEM THAT REDUCE
- INSTRUCTIONAL, ADMINISTRATIVE, OR PUPIL TRANSPORTATION COSTS.

- 1 (2) IF THE DEPARTMENT DETERMINES THAT ANY STATE OR FEDERAL
