HOUSE BILL No. 5416

November 9, 2005, Introduced by Reps. Farhat, Garfield, Moore, Stahl, Espinoza and McDowell and referred to the Committee on Veterans Affairs and Homeland Security.

A bill to authorize a service bonus for certain veterans; and to make appropriations.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. When used in this act:
- 2 (a) "Period of service" means that period of time between
- 3 12:01 a.m., January 1, 1991 and the time when the United States
- 4 Congress declares an end to hostilities in Iraq.
- 5 (b) "Veteran" means a person who completed at least 30 days of
- 6 honorable service between January 1, 1991 and June 30, 1992 or 180
- 7 days of honorable service between June 30, 1992 and January 1, 2016
- 8 or died during the period of service from service-connected causes
- 9 in the military, naval, marine, or coast guard forces of the United
 - States including any auxiliary branches, was a resident of the

- 1 state for at least 6 months before entering military service, and
- 2 has not applied for and received similar benefits from another
- 3 state. The required active duty does not include any of the
- 4 following:
- 5 (i) A period when assigned full-time by the armed forces to a
- 6 civilian institution for a course substantially the same as a
- 7 course offered to civilians.
- 8 (ii) A period served as a cadet or midshipman at a service
- 9 academy.
- 10 (iii) A period of active duty for training in an enlistment in
- 11 the army or air national guard or as a reserve for service in the
- 12 army, navy, air force, marine corps, or coast guard reserve.
- 13 (c) "Beneficiary" means, in relation to a deceased veteran,
- 14 the surviving husband or wife, child or children, or the dependent
- 15 surviving mother or father, in the order named which determination
- 16 may be made by the probate court of the county of residence of the
- 17 veteran at the time of death.
- (d) "Honorable service" means that service as evidenced by 1
- 19 or more of the following:
- 20 (i) Honorable or general discharge, or separation under
- 21 honorable conditions.
- 22 (ii) In the case of a serviceman who has not been discharged, a
- 23 certificate from the appropriate service authority that a
- 24 serviceman did qualify under subparagraph (i) as if the veteran were
- 25 being discharged or separated.
- (e) "Combat veteran" means a veteran who served in combat in
- 27 an armed conflict during the period of service.

- 1 Sec. 2. (1) A combat veteran shall be paid a service bonus in
- 2 the amount of \$1,000.00.
- 3 (2) A veteran shall be paid a service bonus of \$500.00.
- 4 (3) A person shall not be entitled to a bonus as both a
- 5 veteran and a combat veteran.
- 6 (4) If the veteran or combat veteran is deceased, payment
- 7 shall be made to his or her beneficiary.
- 8 Sec. 3. The benefits provided in this act are not pay for
- 9 services rendered or subject to state or city income tax.
- Sec. 4. The benefits provided herein expire when the United
- 11 States Congress declares an end to hostilities in Iraq.
- Sec. 5. The legislature shall make appropriations fully
- 13 sufficient to pay the bonuses conferred in this act.
