November 22, 2005, Introduced by Reps. Shaffer, Hummel, Brandenburg, Vander Veen, Pearce, Sheen, Stahl, Hune, Booher, Hansen, Palmer, Gosselin, Green, Taub, Hoogendyk, Marleau, Huizenga, Amos, Nofs, Moore, Pastor, Pavlov, Drolet, Farhat and Kooiman and referred to the Committee on Family and Children Services.

A bill to amend 1939 PA 280, entitled "The social welfare act,"

by amending section 57b (MCL 400.57b), as amended by 1999 PA 9.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 57b. (1) Subject to section 57l, an individual who meets
- 2 all of the following requirements is eligible for family
- 3 independence assistance:
- 4 (a) Is a member of a family or a family independence
- 5 assistance group.
 - (b) Is a member of a program group whose income and assets are
- 7 less than the income and asset limits set by the -family
- 8 independence agency DEPARTMENT.
 - (c) In the case of a minor parent, meets the requirements of

- 2 (d) Is a United States citizen, a permanent resident alien, or
- **3** a refugee.
- 4 (e) Is a resident of this state as described in section 32.
- 5 (f) Meets any other eligibility criterion required for the
- 6 receipt of federal or state funds or determined by the -family
- 7 independence agency DEPARTMENT to be necessary for the
- 8 accomplishment of the goals of the family independence program.
- 9 (2) A minor parent and the minor parent's child shall not
- 10 receive family independence assistance unless they live in an
- 11 adult-supervised household. The family independence assistance
- 12 shall be paid on behalf of the minor parent and child to an adult
- in the adult-supervised household. Child care in conjunction with
- 14 participation in education, employment readiness, training, or
- 15 employment programs, -which- THAT have been approved by the -family
- 16 independence agency DEPARTMENT, shall be provided for the minor
- 17 parent's child. The minor parent and child shall live with the
- 18 minor parent's parent, stepparent, or legal guardian unless the
- 19 family independence agency DEPARTMENT determines that there is
- 20 good cause for not requiring the minor parent and child to live
- 21 with a parent, stepparent, or legal guardian. The -family
- 22 independence agency DEPARTMENT shall determine the circumstances
- 23 that constitute good cause, based on a parent's, stepparent's, or
- 24 guardian's unavailability or unwillingness or based on a reasonable
- 25 belief that there is physical, sexual, or substance abuse, or
- 26 domestic violence, occurring in the household, or that there is
- 27 other risk to the physical or emotional health or safety of the

- 1 minor parent or child. If the <u>family independence agency</u>
- 2 DEPARTMENT determines that there is good cause for not requiring a
- 3 minor parent to live with a parent, stepparent, or legal guardian,
- 4 the minor parent and child shall live in another adult-supervised
- 5 household. A local office director may waive the requirement set
- 6 forth in this subsection with respect to a minor parent who is at
- 7 least 17 years of age, attending secondary school full-time, and
- 8 participating in a **DEPARTMENT** service plan -of the family
- 9 independence agency or a teen parenting program, if moving would
- 10 require the minor parent to change schools.
- 11 (3) IN DETERMINING A MEMBER'S INCOME FOR ELIGIBILITY FOR
- 12 FAMILY INDEPENDENCE ASSISTANCE, THE DEPARTMENT SHALL INCLUDE THE
- 13 AMOUNT ANY MEMBER OF A PROGRAM GROUP RECEIVES IN SUPPLEMENTAL
- 14 SECURITY INCOME UNDER TITLE XVI AS PART OF THAT PROGRAM GROUP'S
- 15 INCOME.
