- 1 SEC. 1319. IF A HIGH SCHOOL OPERATED BY A SCHOOL DISTRICT
- 2 CONDUCTS OR PARTICIPATES IN A CAREER OR COLLEGE DAY OR SIMILAR
- 3 PROGRAM FOR PUPILS CONCERNING CAREER OR POSTSECONDARY EDUCATIONAL
- 4 OPPORTUNITIES, AND IF THE SCHOOL DISTRICT ALSO OPERATES AN
- 5 ALTERNATIVE EDUCATION PROGRAM FOR HIGH SCHOOL PUPILS, THE BOARD OF
- 6 THE SCHOOL DISTRICT SHALL ENSURE THAT PUPILS IN THE ALTERNATIVE
- 7 EDUCATION PROGRAM ARE ALLOWED TO ATTEND AND PARTICIPATE IN THE
- 8 CAREER OR COLLEGE DAY OR SIMILAR PROGRAM. IN ADDITION, SCHOOL
- 9 OFFICIALS SHALL PROVIDE TO HIGH SCHOOL PUPILS IN THE ALTERNATIVE
- 10 EDUCATION PROGRAM AND THEIR PARENTS THE SAME ADVANCE INFORMATION
