- 3 OR DENTAL SERVICES WITHOUT COST TO PATIENTS MAY CLAIM A CREDIT
- 4 AGAINST THE TAX IMPOSED BY THIS ACT EQUAL TO 50% OF THE COST OF
- 5 DONATED SERVICES NOT TO EXCEED \$5,000.00 PER TAX YEAR.
