THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 35E. (1) FOR TAX YEARS THAT BEGIN AFTER DECEMBER 31,
- 2 2005, A TAXPAYER MAY CLAIM A CREDIT AGAINST THE TAX IMPOSED UNDER
- 3 THIS ACT EQUAL TO THE SALARY, WAGES, OR OTHER COMPENSATION THAT
- 4 WHEN ADDED TO ALL MILITARY PAY AND THE VALUE OF MILITARY ALLOWANCES
- 5 RECEIVED BY THE ELIGIBLE EMPLOYEES WOULD BE EQUAL TO OR LESS THAN
- 6 THE AMOUNT THE TAXPAYER WOULD HAVE PAID ELIGIBLE EMPLOYEES HAD THE

- 20 MILITARY FORCE DESIGNATED BY CONGRESS AS PART OF THE ARMED FORCES

- 22 (C) "ELIGIBLE EMPLOYEE" MEANS AN INDIVIDUAL WHO IS IN THE
- 23 ARMED FORCES OF THE UNITED STATES OR A MEMBER OF THE MICHIGAN
- 24 NATIONAL GUARD ON ACTIVE DUTY STATUS.
